
Sub: Increase in seats of B.A.1<sup>st</sup> year in S.D. Mahila Mahavidyala, Hansi.

With reference to the Memo No. 4/83-2017 C-IV (5) dated Panchkula, 07.09.2017 on the subject cited above.

I am desired to inform that the Vice-Chancellor has been pleased to allow admissions on Ten (10) additional seats only in B.A 1<sup>st</sup> year for the session 2017-18. The college will make the admissions of the fresh students only with the late fee of Rs. 2500/- up to 16.09.2017. Any kind of shifting of the students from the other colleges is not allowed for these admissions.

Further, the admissions may be made strictly on merit subject to the fulfilment of minimum eligibility conditions as laid down in the admission policy of the Director of Higher Education. The college should ensure that the infrastructure facilities and faculties are available to cater the need of increased student's strength. The University will, however, not be responsible for the shortage of lectures due to late admissions. You are therefore, requested to take necessary action in this regard at your end.
