3. The examination fee once paid is neither refundable nor adjustable for any course or the subsequent examination under any circumstances. The examination form alongwith the examination fee once submitted shall not be permitted to withdraw.
4. The examination fee for special chance to the students of B.Ed./B.Ed(Shiksha Shastri)/B.Ed./M.Ed(Integrated)/B.El.Ed. 1<sup>st</sup> Year re-appear batch 2017 will be @Rs.1000/-as additional fee in addition to the usual fees/late fees. However, 1<sup>st</sup> Year Re-appear (Batch 2018) students of these courses will have to pay normal usual fee/late fee.
5. The University portal will be opened on 15.01.2020 for examination of March- 2020 and for June 2020 will be opened on 15.04.2020.
