**It is hereby informed that the following pattern will be adopted for the examination of the session May/June/July/August/September, 2022:-**

**Relaxation in question paper:-**

**(A) Where the syllabus is divided into units and Question No. 1 is compulsory:-**

Question no. 1 will remain compulsory. Out of remaining eight questions (divided in 4 Units), the candidate will have to attempt four questions by selecting either one question from each unit OR by selecting two questions from any one unit and remaining two questions from two different units out of remaining three units.

**(B) Where the syllabus is not divided into units:-**

The question paper will remain same as per instructions given by the examiner on the question paper.

The above relaxation in question paper pattern will be applicable only for the examinations for session May/June/July/August/September, 2022 of UTD, Engineering Colleges, Distance Education and all the Affiliated Colleges of Hisar District (Law Colleges /Degree Colleges /Education Colleges).


This type of relaxation should not be made as precedent.
