**NEP-2020:** Learning is a complex process and it should be outcome based so as to make it relevant to one and all. We have seen that education, traditionally, has not required thinking deeply beyond the facts. Teachers generally have not been trained on the differences between factual and conceptual questions. In fact, we will have to accept that meaningful learning is dependent on learners' active cognitive processing while they learn. Hence, we would prefer to apply science of learning because it has been proved that science of learning, if applied properly, it can contribute to improving instruction in subject matter areas: learning to read, learning to comprehend text, learning to write, learning to think mathematically, and learning to think scientifically. Giving global exposure to teachers and students may enrich the staff for better professional performance at workplace.

#### **4. The Parents-Teachers Interaction Focus for Producing**

**Enlightened Human Being:** Parents and teachers are very important to the overall improvement of the school. When the relationship between the university and parents is based on trust and collaboration, the student is benefited the most. Keeping the above in mind, the university should attempt to develop a very constructive communication with the parents. They need to be invited from time to time to convey their feedback, student's results would be communicated to home and the doors of university leadership would always be open for the parents. The universities should maintain an open academic climate, which is characterized by teacher relations that are professional, collegial, friendly, and committed to the education of students. Concurrently, a healthy academic climate should be established that would ensure institutional integrity. For this reason, the effective teachers should be protected from disruptive outside forces, which would create an over-all firmness for academic achievement by teachers, parents, and students. Close association with society in general, through various public welfare activities, may benefit the institution.

Contemporary teaching and learning strategies, classroom management, research methodologies, and technology integration into instruction would be the primary content of professional training. - 6.2 Faculty and Staff Recruitment:** Attract top-notch faculty and staff members from around the world with globally competitive salaries, research opportunities, and a supportive academic environment that are essential for academic excellence.
- 6.3 World-class Infrastructure and Resources:** Invest in state-of-the-art facilities, libraries, laboratories, and technology. Ensure a conducive teaching, learning and research environment in such world-class facilities.
- 6.4 Research and Innovation:** Promote research culture and allocate funds for cutting-edge research projects. Encourage collaboration with industries and other universities.

- 6.5 Curriculum and Pedagogy:** Develop modern, relevant curricula and teaching methods. Encourage interdisciplinary programs and experiential learning.
- 6.6 International Collaboration:** Foster partnerships with leading international universities for exchange programs, joint research, and faculty/student mobility.
- 6.7 Student Quality:** Admit students based on merit, ensuring a competitive and diverse student body. Offer scholarships and financial aid to attract talent.
- 6.8 Quality Assurance:** Implement robust quality assurance mechanisms and accreditation processes to ensure high standards.
