Following decisions were taken unanimously.

- The committee discussed the cases of extension of research scholars who got registered before 2016 and who were already on any kind of extensions (Ist, IInd or any other extensions granted as per the rules) during Covid-19 period. The scholars whose initial period of submission of thesis fell in the Covid-19 period, have been given granted several extensions by UGC. The research of scholars, who were already on some kind of extension permissible under the rules, has also suffered because of successive lockdowns due to Covid-19 at par with the other scholars. In this context, the committee recommends that the following scholars may kindly be granted the extension either up to 30.06.2022 as per the UGC notification or as per the following table.

"The candidate shall submit his/her thesis in e-version on DVD-ROM as well as in printed version within six months from the date on which the BOS&R has approved the appointment of examiners provided that the Board of Studies and Research may, for satisfactory reasons, extend the period by maximum of another six months only subject to the condition that the extension period should remain within stipulated period of PhD Programme."

Keeping in view of the harsh conditions of COVID-19 period the committee recommends that she may kindly be granted extension for PhD submission up to 30-06-2022.
