**Sub: Extension in the period of submission of Migration Certificate for the students  
admitted in UTDs/HSB/Affiliated Colleges for the session 2025-26.**

Sir/Madam,

It is to inform you that the Vice-Chancellor after considering the request of Chairpersons, UTDs and Principals, Affiliated colleges is pleased to extend the date for submission of Migration Certificate with late fees of the students admitted in UTDs/HSB/Affiliated colleges on the basis of lower examination passed from other Universities/Boards (other than HBSE) for the session 2025-26 as under:

**Schedule of submission of Migration Certificate after expiry of the date  
with fine of Rs. 500/-**

Upto 31<sup>st</sup> March, 2026 with a late fee of Rs. 3000/-  
Upto 31<sup>st</sup> August, 2026 with a late fee of Rs. 5000/-  
Upto 31<sup>st</sup> December, 2026 with a late fee of Rs. 7000/-

**The candidature of the student who fails to submit the Migration  
Certificate upto 31<sup>st</sup> December, 2026 shall be suspended automatically.**

Further, the concerned student has to furnish an Affidavit duly attested by the Notary Public to the effect that he/she did not take/appear in regular examination of any other course from any University/Board during the admission in his/her course of study in this University simultaneously. It is explicitly mentioned that no request of relaxation/waive off fine/late fee on account of late submission of Migration Certificate shall be entertained under any circumstances.

The Chairpersons/Directors/Principals concerned shall issue the orders of suspension of candidature for the examinations concerned of the students under intimation to the Controller of Examinations after 31<sup>st</sup> December, 2026 who fail to submit the Migration Certificates within the stipulated time.

You are therefore, requested to take further necessary action to bring the extended date to the notice of the students admitted in your Department/College for the session 2025-26.
