from Third Semester as per National Education Policy-2020**

**Under Learning Outcome Based Curriculum Framework-Choice Based Credit System

(w.e.f. Session 2024-25)**

1. Scope

This Ordinance is based on National Education Policy-2020 (NEP-2020), Learning Outcome Based Curriculum Framework-Choice Based Credit System (LOCF-CBCS) and is according to the Curriculum and Credit Framework for UG Programmes (CCFUGP) of University Grants Commission and as per Memo No. DHE-170005/5/2023-Deputy Director-NPE dated June 8, 2023 regarding implementation of the key components of NEP-2020 in Colleges and Universities.

- (i) The duration of the programme for the award of Undergraduate Certificate in Discipline will be one academic year and of Undergraduate Diploma in Discipline with major in a subject will be two academic years. The duration of Bachelor Degree in discipline with major in a subject will be three academic years and Bachelor Degree in discipline (Hons./Hons. with Research) in a subject will be four academic years. Each academic year will be divided into two semesters i.e., July to December and January to June. There shall be teaching of 15 weeks/90 days in each semester excluding admission and examination days.
- (ii) The nomenclature of the Certificate/Diploma/Degree will be as under:
 - (a) UG Certificate in Arts or UG Certificate in Physical Sciences or UG Certificate in Life Sciences
 - (b) UG Diploma in Arts with major in <Major Subject> or UG Diploma in Physical Sciences with major in <Major Subject> or UG Diploma in Life Sciences with major in <Major Subject>
 - (c) Bachelor of Arts with Major in <Major Subject>
OR
Bachelor of Science in Physical Sciences with Major in <Major Subject>
OR
Bachelor of Science in Life Sciences with Major in <Major Subject>
 - (d) Bachelor of Arts (Hons.) in <Major Subject>
OR
Bachelor of Arts (Hons. with Research) in <Major Subject>
OR
Bachelor of Science (Hons.) in <Major Subject>
OR
Bachelor of Science (Hons. with Research) in <Major Subject>

2. Key Terms

- (i) **Learning Outcome based Curriculum Framework (LOCF):** The learning outcomes of the programme (POs) are mapped against well-defined Course Outcomes (COs).
- (ii) **Choice Based Credit System (CBCS):** The CBCS provides choices to students to select disciplinary and interdisciplinary courses to fit into their own requirements and to learn at their own pace within the framework.
- (iii) **Programme:** A programme is made up of courses/subjects and leads to the award of a Certificate or Diploma or Degree after completing requisite courses successfully.
- (iv) **Course/Subject:** A course/subject refers to components of a programme. A course/subject may comprise of lectures/tutorials/practicum or laboratory work/field practice/project work/seminar/community engagement and service/internship/dissertation, etc. or any combination of these.
- (v) **Credit:** A unit by which the course work is measured. It determines the number of hours of instructions required per week over the duration of one semester. For calculation of the teaching hours, one credit means one hour of lecture or one hour of tutorial or one hour of seminar or two hours of practicum/laboratory work per week over the duration of a semester.
- (vi) **Lecture:** Component of a course/subject which is taught by a teacher through lectures covering the contents of a course/subject.
- (vii) **Tutorial:** Component of a course/subject which involves problem-solving, learning through discussions and remedial teaching related to the contents and periphery of a course/subject with the direct involvement of a teacher.
- (viii) **Practicum:** A course/subject or a component of a course/subject which enables students to learn or to attain skills or to get procedural knowledge for the contents of a course/subject through practical/laboratory activity/project and to apply the studied principles/theory/ concepts related to the chosen field of learning, work/vocation, or professional practice in the field of learning, under the supervision of a teacher.
- (ix) **Seminar:** A course/subject or a component of a course/subject which makes students to learn a specific topic through in-depth exploration and analysis of facts about the topic in a set-up that involves presentation, interactive discussions and collaborative learning under the supervision of a teacher.
- (x) **Internship:** A course/subject requiring students to participate in professional employment-related activity or work experience or co-operative education activity with an entity external to the educational institution normally under the supervision of an employee of an organization or an individual professional. A key aspect of the internship is induction into actual, formal and organized work situations. Internship involves working with local industry (Government or Private organizations), business establishments, artists, craft persons, etc. to provide opportunities for students to actively engage in on-site experiential learning.
- (xi) **Studio Activity:** A studio activity involves engagement of students in creative, artistic or experimental activities involving visual, digital, audio, video and other professional experiential work.
- (xii) **Field Work/Practice/Survey/Project:** A course/subject or a component of course/subject which enables students to participate in field-based learning/project, involving application of knowledge in solving/analyzing/exploring a real-life situation/problem under the supervision of a teacher/mentor.
- (xiii) **Project Work:** A course/subject or a component of a course/subject which facilitates students to apply their knowledge, skills and critical thinking ability to complete a specific task in a given time frame through conceptualization,

exploration and analysis of research-based activities to suggest tangible solutions for a given problem related to the chosen field of learning.

- (xiv) **Dissertation:** Dissertation is a comprehensive report of the work done in a research project/field work/survey, based on a systematic and rigorous investigation of the chosen topic utilizing research methods.
- (xv) **Community Engagement and Service:** A course/subject or a component of a course/subject which exposes the students to the socio-economic issues prevailing in society so that the theoretical learning can be supplemented by actual life experiences to understand and generate solutions to real-life problems.

3. Courses

- (i) **Discipline Specific Courses (DSC):** A major course/subject as discipline specific course is the field in which a student focuses for understanding and skills majorly in the chosen field of learning contributing to the core of the programme. This may include Core, Elective and Skill-enhancement courses.
- (ii) **Minor Courses (MIC):** Minor course/subject aims to expand student's knowledge beyond the major field of study. This will also include **Vocational Course (VOC)** that will assist student in developing work-force relevant skills through practical work and enhances the employability of student.
- (iii) **Multidisciplinary Courses (MDC):** These courses are based on introductory knowledge in a subject. A student will study MDC in a subject other than the discipline of Discipline Specific and Minor subjects/courses to gain knowledge across the disciplines.
- (iv) **Ability Enhancement Courses (AEC):** These courses aim at enabling the students to achieve competency in the English language or Modern Indian Languages (MIL) with special emphasis on language and communication skills.
- (v) **Skill Enhancement Courses (SEC):** These courses aim at imparting practical skills, hands-on training, soft skills, etc. to enhance the employability of students.
- (vi) **Value-Added Courses (VAC):** These courses aim at enabling the students to acquire and demonstrate the acquisition of knowledge and understanding of human values, Indian Knowledge System (IKS), contemporary India, environmental science and education, digital and technical solutions, health and wellness, yoga education, sports and fitness, etc.

4 Evaluation terms

- (i) **Letter Grade:** It is an index of the performance of a student in a course. Grades are denoted by letters O, A+, A, B+, B, C, P, F and Ab depending on the score earned in that course.
- (ii) **Grade Point:** It is a numerical value allotted to each letter grade on a 10-point scale.
- (iii) **Credit Point:** It is the product of grade point and number of credits for a course.
- (iv) **Semester Grade Point Average (SGPA):** It is a measure of performance of a student in a semester. It is the ratio of total credit points secured by a student in all the courses registered in a semester to the total of the credits of the courses taken during that semester. It shall be expressed up to two digits after decimal place.
- (v) **Cumulative Grade Point Average (CGPA):** It is a measure of overall cumulative performance of a student in a programme over all the semesters. The CGPA is the ratio of total credit points secured by a student in all the courses of the programme to the sum of the total credits of all the courses of the programme. It is expressed up to two digits after decimal place.
- (vi) **Detailed-Grade-Certificate:** Based on the grades earned, a grade certificate shall be issued to all the registered students after every semester. The Detailed-Grade-

Certificate (DGC) will display the course details (code, title, number of credits, grade secured) along with SGPA of that semester.

5 Academic Bank of Credits (ABC): It is a virtual/digital mechanism that contains information of the credits earned by individual students throughout their learning journey in Higher Education Institutions in India recognized by UGC. The Automated Permanent Academic Account Registry (APAAR) ID is also being introduced as a pivotal component. The APAAR ID serves as a lifelong academic passport, consolidating all achievements and credential of a student in one place. This will help enabling student mobility across higher education institution.

6 Programme Duration and Multiple Exit Options

All programmes shall be offered as per UGC list of 'Specification of Degree' prevailing from time to time. The programme duration and options for multiple entry and exit will be as per UG Curriculum Framework- Scheme-B (*Appendix-I; Table-1*).

- (i) A student will be allowed an exit option after passing first academic year of the UG Programme with requisite 52 credits including the 4 credits of internship of 4 weeks duration as per scheme of the programme and will be awarded an Undergraduate Certificate in the discipline (Arts/Physical Sciences/Life Sciences/etc.) (*Appendix-I; Table-2*).
- (ii) A student will be allowed an exit option after passing two academic years of the UG Programme with requisite 100 credits including the 4 credits of internship of duration 4 weeks duration as per scheme of the programme and will be awarded Undergraduate Diploma in the discipline with a major Subject. (*Appendix-I; Table-2*).
- (iii) A student will be awarded with Bachelor degree in a discipline with Major Subject after successfully completing three academic years of UG Programme and earning requisite 136 credits including the 4 credits of internship of 4 weeks duration as per scheme of the programme (*Appendix-I; Table-2*).
- (iv) A student, who has successfully completed three years UG Programme (Single Major from Third Semester) and has earned minimum 60 credits in the Major subject, can opt for Honours Programme in that subject in the fourth year. If a Department/College/Institute allows to continue the student or admits the student for fourth year of Honours Programme, then the student will be awarded with Bachelor degree (Honours) in the Major subject after successfully completing four academic years of UG Programme and earning requisite 184 credits including the 4 credits of internship of duration 4 weeks as per scheme of the programme (*Appendix-I; Table-2*).

Further, provided that a Department/College/Institute will be able to admit students for Honours Programme if the institution has got the approval for the same from the University after obtaining approval from Department of Higher Education (DHE), Government of Haryana, wherever applicable.

- (v) A student, who has successfully completed three years UG Programme (Single Major from Third Semester) and has earned minimum 60 credits in the major subject and obtained CGPA of 7.5 or more, can opt for Honours with Research Degree Programme in that subject in the fourth year. If a student opts to continue or is admitted by a eligible Department/College/Institute to Honours with Research Programme in the fourth year, then the student will be awarded with Bachelor Degree (Honours with Research) in the Major subject after successfully completing four academic years of UG Programme and earning requisite 184 credits including the 4 credits of internship of duration 4 weeks and 12 credit of Project/Dissertation as per scheme of the programme (*Appendix-I; Table-2*).

Further, provided that a Department/College/Institute will be able to admit students for Honours with Research Programme only if the institution has got the approval for the same from the University after obtaining approval from Department of Higher Education (DHE), Government of Haryana, wherever applicable.

7 Admission to a UG Programme under Multiple Entry

- (i) The Department/College/Institute shall declare approved total number of seats available discipline-wise each year for fresh and lateral admissions.
- (ii) The Department/College/Institute can plan the number of seats discipline-wise in consonance with the faculty and infrastructure available.
- (iii) A student can pursue two Undergraduate Programme simultaneously through Open and Distance Learning (ODL)/online mode; or combinations of ODL, online and regular modes, from the same or different Universities/Institutions duly approved by the UGC/AICTE/Regulatory Body/Central Government/State Government, in various combinations, viz.
 - A student can pursue two full-time UG Programme in physical mode provided that in such cases, class timings and examination schedule for one programme do not overlap with the class timings and examination schedule of the other programme, and requirements under clause 7 (iv) are fulfilled.
 - A student can pursue two UG Programme, one in full-time physical mode and another in ODL/online mode; or up to two ODL/online programmes simultaneously.

The Department/College/Institute and the University shall not be responsible for any such overlapping and consequences thereof.

(iv) Minimum Eligibility Conditions for Admission

A candidate who has passed Senior Secondary Certificate Examination (Class XII level) of the Board of School Education, Haryana; or any other examination recognized as equivalent thereto with minimum passing marks in aggregate with English as one of the subjects, shall be eligible to join First Semester of the Undergraduate (UG) Programme. In addition, the following conditions, if applicable should also be satisfied:

- to opt for Mathematics as a DSC, the candidate must have passed Mathematics as a subject in the qualifying examination.
- to opt for Chemistry as a DSC, the candidate must have passed Chemistry as a subject in the qualifying examination.
- to opt for Physics as a DSC, the candidate must have passed Physics as a subject in the qualifying examination
- to opt for subject(s) in the discipline of Life Sciences, which consists of Botany, Zoology as a one or more than one subject(s), then the candidate must have passed Class XII with Biology as a subject.
- to opt for subjects of Physical Sciences discipline as Major subject(s), the candidate must have passed respective subjects in the qualifying examination.

Further, eligibility conditions for admission to a programme shall be applicable as mentioned in the scheme of the concerned programme.

A candidate having 2-Year Diploma from ITI or 3-Year Diploma from Polytechnic of minimum 2 years duration qualified with Hindi Core/English as one subject or as an additional subject at Class XII level is also eligible for seeking admission in First Semester of the UG Programme in Arts discipline or in the disciplines wherever mentioned so.

Note: Eligibility conditions are subject to change according to the implementation of National Curriculum Framework (NCrF) for school education or in accordance with any such guidelines issued by the Central/State Government or issued by University from time to time.

- (v) A student who has been placed under compartment or allowed to re-appear in one subject only in Senior Secondary Certificate Examination (Class XII level) of the Board of School Education, Haryana, or equivalent examination of another University/Board may be allowed to study provisionally for the First Semester of the UG programme. Such student shall pass the compartment/re-appear subject before commencement of the examination of Ist semester of the concerned UG Programme. If a student does not clear the compartment/re-appear subject before the commencement of the Ist semester examination, her/his provisional admission to concerned UG Programme shall be cancelled ab initio by the Chairperson/Principal/Director with intimation to the University. However, the Vice-Chancellor may relax this condition, in exceptional cases at own level or on the recommendations of a committee constituted by the Vice-Chancellor.

For such students, the required percentage of marks for admission shall be determined by considering the minimum pass marks in compartment/re-appear subject.

- (vi) The student opting for exit must inform in writing to the Department/College/Institute by 30th June of every year. The student is allowed multiple entry into a UG Programme. For example, the student can re-enter into second year of a programme if she/he has taken an exit option after first year. Similarly, re-entry into the third year is allowed if exit option was exercised by a student after getting UG Diploma. In any case, the gap between the exit and the re-entry into the UG Programme should not be more than three years subject to completion of the whole UG Programme within seven years. Multiple entry shall be allowed in a Department/College/Institute subject to the availability of seats in the concerned programme in that year in that Department/College/Institute. In case of re-entry, the scheme and syllabus currently running will be applicable.
- (vii) Lateral admissions against sanctioned vacant seats may be made by a Department/College/Institute category wise following the State Govt. norms for reservation in an odd semester. Lateral admission may be provided in the 3rd and 5th semesters if a student has passed all the preceding examinations up to 2nd and 4th semester, respectively of the concerned programme under NEP Curriculum Framework. However, this will be subject to fulfilment of other eligibility conditions for the programme in which the admission is sought.

First preference in the lateral admission will be given to the students of that Department/College/Institute who had taken exit from that programme and are seeking re-entry into the same institution, for this a cut-of-date will be notified by Department/College/Institute.

8 Subjects and Courses of UG Programmes

- (i) A student of UG Programme (Multidisciplinary, Single Major from Third Semester), herein after called Scheme-B, will select three subjects A, B and C in the first year out of the pool of subjects in that discipline offered by the Department/College/Institute as Discipline Specific Subjects/Courses. Minor subject/course is to be offered preferably from the same discipline and will be different from three subjects/courses which are opted as Discipline Specific Subjects/Courses. Any subject/course in a discipline can be a Discipline Specific or Minor subject/course for a UG programme. In case of Physical Sciences and Life Sciences disciplines, if the Minor Subject/course cannot be offered from the same discipline by a Department/College/Institute, then the Discipline Specific Subject/course may be offered from either of the two disciplines. For Example, if a Department/College/Institute is unable to offer a Minor subject/course from the discipline of Life Sciences, other than three subjects Botany, Zoology and Chemistry which have been offered as three Major subjects/courses, then Department/College/Institute can offer any subject/course from the discipline of Physical Sciences as a Minor Subject or vice-versa.
- (ii) A student will study Discipline Specific, Minor, Minor (Vocational), AEC, VAC, SEC and MDC courses as per Curriculum Framework Scheme-B (*Appendix-I; Table 1*).
- (iii) For 1st and 2nd semester of UG Programme (Multidisciplinary, Single Major from Third Semester) (Scheme-B), a student can choose a Minor Course of 2 credit from the pool of Minor subjects/course from that discipline as offered by the Department/College/Institute in that semester. The same minor subject be studied in subsequent semesters.

From 3rd semester onwards, a Minor Course will be of 4 credits and will be taken from the pool of the offered Minor Courses of that subject which was chosen in the first and second semesters.

- (iv) A student will study three Multidisciplinary Courses (MDCs) in first three semesters. The Multidisciplinary Courses (MDCs) will be from the subject which is different from the Discipline Specific and Minor subjects/courses. Students are not allowed to choose or repeat courses already undergone at the Senior Secondary Level (Class XII) or Discipline Specific and Minor subjects/courses under this category. Provided further that if a Multidisciplinary Course (MDC) across the discipline cannot be offered by a Department/College/Institute, due to its constraints and available resources, then

- A subject from the same discipline can be offered as MDC course if that subject also belongs to the list of subjects of some other discipline.
- MDC can be opted out of MOOCs through SWAYAM.
- MDC can be completed out of online courses offered by GJUST.
- MDC can be completed from a cluster college i.e., from a neighbouring College/Institute.

Note: The student himself/herself has to pay the requisite fee and/or re-appear fee as applicable from time to time. Department/College/Institute shall not be responsible for any issue(s) related to MOOCs, online course(s) and from cluster college or else.

- (v) A student will select AEC, SEC, VAC and Minor (Vocational) courses from a pool of respective courses offered in Department/College/Institute.

Depending upon the availability of faculty and infrastructure, a Department/College/Institute may offer AEC, SEC, VAC and Minor (Vocational) courses from the respective pool of courses duly approved by the University. University will revise such pools from time to time by taking proposals of Department/College/Institute into consideration.

- (vi) A student will study VAC- 'Environmental Studies' which is mandatory and at least one SEC to gain computer competency before exit. The number of these courses will be offered by the Department/College/Institute according to the availability of faculty and infrastructure.
- (vii) In the subjects/courses which involve practicum, i.e., Practical/Laboratory/Studio/Project/ Survey/Field work, etc., a course of 4 credits will dedicate 3 credits for lectures and one credit for practicum or 4 credits for lectures. In other subjects/courses not having practicum component, a course of 4 credits will dedicate 3 credits for lectures and 1 credit for tutorial or 4 credits for lectures.

During 4th year, if the practicum course is offered as a separate course in that subject, all the credits will be dedicated to practicum.

In the case, when tutorial of 1 credit is not adopted/implemented in a subject, then all the credits of that course will be dedicated to lectures only.

- (viii) In case of AEC and VAC of 2 credits, the entire 2 credits will be allocated to lectures.
- (ix) In the SEC courses of 3 credit, 2 credit will be allocated to lectures and 1 credit to practicum.
- (x) In case of Minor (Vocational) courses/subjects, where practicum component is dominant, a course of 4 credits may allocate 2 credits to lectures and 2 credits to practicum. Similarly, a course of 4 credits may be divided into 2 credits of lectures and 2 credits of practicum in the subjects where the practicum component of the course is major and teaching-learning process mainly depends upon practicum, e.g. Music and Fine Arts.

9 Contact hours/workload

The weekly contact hours/workload for theory/practical/laboratory/studio/project/survey/field work, etc. components of the courses will be:

- (i) 1 credit theory/tutorial = 1 hour;
- (ii) 1 credit practical/laboratory/studio/project/survey/field work = 2 hours.
- (iii) The tutorial and practical/laboratory/studio/project/survey/field work will be conducted in groups of students and one group will comprise of 20 students.

10 Exit option

When a student decides to continue for the second year and neither opt exit option after the second semester nor opt Scheme-A but decides to shift to UG programme with single major subject (Scheme-B) has to select one major out of the three Discipline Specific/Major undertaken in the first semester. The credits earned by the student in other two Major subjects will contribute towards credits of Minor courses.

11 Online Courses

With the permission of Department/College/Institute, a student can opt for online courses (at own level), up to 40% of the courses of the programme except Discipline Specific Courses and Skill Enhancement courses, through online platform SWAYAM or online courses offered by GJUST, Hisar or through other such online platforms approved by the UGC as per university guidelines prevailing time to time.

12 Internship

Every student for the UG Programme shall be required to undergo 4 credits internship of 4 weeks duration before taking an exit or completing the degree programme.

- (i) A student for the UG Programme shall be required to undergo internship during summer vacation either after the second semester examination or after the fourth semester examination. If she/he opts to exit with Undergraduate Certificate in the discipline, then it shall be obligatory to complete the internship after second semester examination.

However, for those students who have taken lateral entry into the third semester and have completed internship of 4 weeks duration during first year, the internship is not required after the fourth semester examination.

- (ii) A student will inform and get approval from the Chairperson/Principal/Director of the Department/College/Institute before going for an internship. The internship will involve working with local industry (Government or Private organizations/Institutions), business establishments, artists, craft persons, or a professional (individual/organization). Student will submit a copy of the report (a hard copy and a soft copy in PDF) to the Department/College/Institute within 15 days after the completion of internship. A student must submit a certificate of attendance and work done report from the organization/professional where the internship was done. The evaluation of the internship shall be done by a committee comprising of at least two senior teachers appointed by the Principal/Director of the College/Institute. Marks will be awarded by the committee out of 100 marks on the basis of the report and viva-voce examination.

- (iii) The internship will be governed by the prevailing rules of the University from time to time.

13. Project/Dissertation

A student of fourth-year Bachelor Degree (Honours with Research) programme will be required to work on the Research Project or do research during eighth semester. The Project/Dissertation work will be of 12 credits.

- (i) A student, who has been admitted in a Honours with Research programme, shall submit a request for allotment of supervisor mentioning her/his research areas of interest in order of preference to the Chairperson/Director/ Principal during seventh semester. The Department/College/Institute shall allot a qualified supervisor to guide the student for doing research during Project/Dissertation work. A regular full-time teacher of that Department/College/Institute, who has been approved to supervise Ph.D. scholars by the university, will be eligible to guide the students of Honours with Research Programme of that institution.
- (ii) The student will submit the synopsis to the supervisor. In case of University Teaching Department, the synopsis will be approved by the Departmental Research Advisory Committee after recommendation of the supervisor. In other cases, a Principal/Director of a College/Institute shall constitute a committee at the College/Institute level. External experts may be involved wherever sufficient qualified regular teachers are not available.
- (iii) The student shall be required to submit three hard copies of her/his dissertation along with soft copy as PDF file to the Department/Institute/College by 30th June

- of the concerned year. The late submission can be allowed with late fees as decided by the university from time to time.
- (iv) The Anti-plagiarism policy of the university is to be strictly followed by the candidate and the supervisor. Similarity report as per anti-plagiarism policy of the university is to be annexed with the dissertation.
 - (v) Evaluation of the dissertation shall be done by an external examiner. The dissertation work will be of total 12 credits (300 marks) and evaluation will be done in two components; report of dissertation (200 marks) and open viva-voce examination (100 marks).

14 Medium of Instructions and Examination

- (i) For Arts/Home Science subjects etc., the medium of instructions shall be Hindi/English. The question paper shall be set in both English and Hindi, wherever feasible and approved by the university, except in the case of
 - English, in which the questions shall be set in English.
 - Sanskrit, in which the questions shall be set in Sanskrit/Hindi.
 - Other languages, in which the questions shall be set in the language concerned.
- (ii) The students shall write their answers:
 - in English, in case of English language
 - in the language concerned, in the case of Modern Indian Languages
 - English/Hindi in the case of other subjects.
- (iii) For Physical Sciences/Life Sciences Subjects/Courses, the medium of instructions shall be mainly English. Hindi medium may be offered wherever feasible and approved by the university. The question paper shall be set in English. Bilingual question paper (s) will be provided, wherever feasible and approved by the university. The students can write their answers in English/Hindi.

15 Programme and Course Learning Outcomes

Individual programmes of study will have well defined learning **Programme Outcomes (POs)** which should be attained for the award of a specific Certificate/Diploma/Degree.

Each course will have well defined learning **Course Outcomes (COs)** specific to the learning for a given course of study related to a disciplinary or interdisciplinary/multi-disciplinary area. Course Outcomes (COs) will be mapped to Programme Outcomes (POs). The attainment of Course Outcomes will lead to the attainment of the Programme Outcomes

16 Assessment and Evaluation

(i) Student Progression and Mentoring

Each student shall be examined in the course(s) to check their progression through the programme as laid down in the scheme, syllabus and learning outcomes through a system of Continuous Comprehensive Assessment (CCA) using a mix of Internal and End-Term evaluation.

- Internal Assessment will be broadly 30% of the total marks and weightage of 70% shall be given to evaluation of End-Term examination(s).

- Internal Assessment (30%) shall be broadly based on the following defined components: Class Participation; Seminar/Presentation/Assignment/Quiz/Class Test, etc. in case of Theory examination and Seminar/Demonstration/Viva-Voce/Lab record, etc. in case of Practical examination; Mid-Term Exam.
- Internal Assessment Marks will be further distributed as per following tables:

- A student has to obtain minimum 40% marks (Grade 'P') in aggregate (sum of the Internal Assessment and End-Term Examination marks) and in End-Term Examination separately to qualify a course.
- (ii) The pass percentage will be 40% (Grade 'P') both for theory and practicum End-Term Examination. For Project/Dissertation work also, the pass percentage will remain 40%.
- (iii) The Chairperson/Principal/Director shall ensure uploading of the Internal Assessment marks at least one week before the commencement of the End-Term Semester Examinations on the examination portal of the university as notified by the Controller of Examinations.

- (iv) Internal Assessment marks of a course shall be carried forward in case of re-appear examination of that course.
- (v) The Chairperson/Principal/Director shall preserve the record on the basis of which the Internal Assessment awards have been prepared, for inspection, if needed by the university for year from the date of declaration of semester examination results.

17 Eligibility for Examination

End-Term Examination shall be open to a regular student who

- (i) has been on the rolls of the Department/College/Institute during the semester.
- (ii) has passed the requisite qualifying examination as laid down in Clause 7 (iv) above, if she/he is a candidate for the First Semester Examination.
- (iii) has her/his examination form submitted to the Examinations Branch through the Chairperson/Principal/Director of the concerned Department/College/Institute.
- (iv) has attended not less than 75% of the lectures in a course. This requirement shall be fulfilled separately for each course of the programme. A deficiency in the prescribed course (Lectures/Practicum, etc.) may be condoned by the Chairperson/Principal/Director of the Department/College/Institute in deserving cases up to 15% (excluding 2% additional for Girl/Women student).
- (v) These shall also include loss of attendance due to participation in the cultural and sports assignments, etc. Provided that, a student who participates in the Inter-University Tournaments or Inter University Youth festivals or Republic Day Parade may be allowed additional condonation on this ground up to 10% in each paper on a certificate from the Dean/Director, Sports/Youth Welfare/Cultural Affairs, Placement Cell, NSS, ANO, NCC as the case may be, subject to the condition that such a student shall not be allowed to appear in the examination if his/her attendance, after condonation on all counts, falls below 50%.
- (i) Provided that a candidate who has not attended the requisite percentage of lectures/practicum shall not be eligible to take the End-Term Examination in the concerned theory/practicum unless she/he repeats the course and obtains requisite attendance.

18 Duration for Passing the Programme

- (i) A student can complete a Bachelor degree programme within seven years. A student who fails to pass the whole examination(s) of a UG programme within seven years of admission to the programme, shall be awarded Undergraduate Certificate/Diploma on the basis of qualified courses as per credit point, if eligible (*Appendix-I; Table 2*).
- (ii) Each student will have to open an Academic Bank of Credit (ABC) account at the time of admission. At the end of each semester, credits earned by the students will be uploaded in her/his respective ABC account. A student registered in ABC account for a programme will be allowed to complete the respective programme within 7 years or as per the time period stipulated in the ABC for accumulation of credits from time to time or within the period as prescribed by the university for the purpose.

19 Conditions for Promotion to Higher Semester and Rules for Re-appear

- (i) A student who has appeared and failed in one or more courses of the First Semester shall be allowed to study for and appear in the second semester. Such a student may pursue her/his studies for the next higher semester(s) and appear in

the examination(s) for the same along with the examination for the lower semester(s) or as notified by the university.

- (ii) A candidate who has attended the prescribed classes of a course(s) of a programme in the Department/College/Institute in a semester and was eligible but did not appear in the End-Term examination or has appeared but fails, may be allowed on the recommendation of the Chairperson/Principal/Director of the Department/College/Institute to appear/re-appear as an ex-student in the End-Term examinations of that course(s) as the case may be, in the subsequent semesters examination up to two times when such examination(s) are held without attending the course(s) again. While re-appearing in the examination, the student shall be exempted from appearing in the course(s)/practical(s) in which she/he has obtained passing marks.

Provided that after completion of regular studies for the whole duration of a programme, the candidate will be allowed to appear in examination as an ex-student for the re-appear/left out courses under the permissible chances, within the prescribed time period.

- (iii) A candidate who could not complete or has failed in a project/internship, she/he will get only one chance to repeat the project work/intership at the end of the next Semester. Further, if the candidate still fails or remains absent in the project/internship, then she/he will not be eligible for the award of the concerned UG Certificate/Diploma/Degree.

20 Examinations and Result

- (i) End-Term Examinations for the odd semesters shall ordinarily be held in November/December and for the even semesters in May/June, on such dates as may be notified by the Controller of Examinations from time to time.
- (ii) Supplementary examinations will be held for Re-appear candidates as under:

Odd Semester	Along with the First, Third and Fifth Semester
Even Semester	Along with the Second, Fourth and Sixth Semester

- (iii) The last date(s) by which the examination forms shall be uploaded on the examination portal shall be as per the schedule notified by the Controller of Examinations from time to time.
- (iv) The amount of examination fee to be paid by a student for each semester shall be as prescribed by the University from time to time.
- (v) The minimum Semester Grade Point Average (SGPA) to qualify a semester shall be 4.00 and minimum Cumulative Grade Point Average (CGPA) required for the award of the UG Certificate/Diploma/Degree shall be 4.00.
- (vi) The Examination Branch shall prepare the Grade/Result and the Controller of Examinations will notify the same within the stipulated time.
- (vii) If a student is not able to pass any semester examination during her/his regular studies in the programme, her/his pass credits will be accumulated in the Academic Bank of Credits (ABC) and she/he can pass the deficient courses any time within seven years or as stipulated in the Academic Bank of Credits from time to time.
- (viii) A student who discontinues her/his studies at any point of time may be permitted to re-join the programme of study and complete balance credits as per Clause 7 (iv).

(ix) **Award of Grades**

Award of grades and the corresponding grade points will be based on absolute marks as per the following table:

- The multiplication factor for conversion from SGPA/CGPA to equivalent percentage of marks shall be 10.
- A candidate eligible to take the examination obtaining Grade 'F'/'Ab' will be considered to have failed in the examination/course(s). Such a student will be required to re-appear in that examination/course(s) within the permissible chances.

21 Computation of SGPA and CGPA

The following shall be the procedure to compute the Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

- (i) The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a candidate in all the courses taken by the candidate in a semester to the sum of the number of credits of all the courses undertaken by the candidate in that semester, i.e.

$$SGPA (S_j) = \frac{\sum(C_i + G_i)}{\sum C_i}$$

where C_i is the number of credits of the i^{th} course and G_i is the grade point scored by the student in the i^{th} course in the j^{th} semester.

- (ii) The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme, i.e.

$$CGPA (S_j) = \frac{\sum(N_j + S_j)}{\sum N_j}$$

where S_j is the SGPA of the j^{th} semester and N_j is the total number of credits in that semester.

- (iii) The SGPA and CGPA shall be rounded off to 2 digits after decimal place and shall be reported in the Detail-Grade-Certificate (DGC).

A merit list will be prepared for a programme and Gold Medal will be awarded to a candidate securing highest CGPA provided the candidate must have passed all the semester examinations in the first attempt and within minimum duration of the programme. In case,

when more than one student have the same CGPA, then Gold Medal shall be decided on the basis of actual obtained marks in the programme.

22 Improvement

- (i) A candidate who has passed a UG Programme from GJUST, Hisar and is desirous of improving her/his CGPA in the respective programme (Certificate/Diploma/Degree), will be allowed to appear within next four Semester examinations of passing the sixth semester examination to appear as an ex-student in one or more theory course(s) of any one or two parts, out of Part-I (Semester I & II), Part-II (Semester III & IV), Part-III (Semester V & VI) and Part-IV (Semester VII & VIII) separately in four consecutive semester examinations and shall pay examination fee as for the whole semester examination in which she/he opts to appear.
- (ii) The result of improvement examinations shall be declared only if a candidate improves her/his CGPA of the respective programme. Provided further that if a student does not want to avail the remaining chances out of permissible four total chances for improvement, then she/he will submit an undertaking to this effect for declaration of her/his final result. The fact that student has improved the performance/grade shall be mentioned in the Detailed-Grade-Certificate of the candidate.
- (iii) Improvement shall not be allowed in Internal Assessment/Practical/Internship/Field Work/Project/Seminar/Studio etc.

The rules, syllabus and fees for improvement examinations shall be applicable as prevailing at that time or as prescribed by the university from time to time.

23 Award of Grace Marks

Grace marks will be awarded according to the university rules prevailing from time to time.

- 24** The ordinance in force at the time a student joins the programme shall hold good only for the examination held during or at the end of that academic year and nothing in this ordinance shall be deemed to debar the university from amending the ordinance and the amended ordinance, if any, shall apply to all the students whether old or new.

- 25** Notwithstanding anything mentioned above, the Vice-Chancellor can relax any rule in exceptional cases or when situation demands so.

26 Transitory Provision

Students admitted to UG Programmes under semester system in Department/College/Institute prior to the academic session 2024-25 shall be governed by the old rules as applicable for that programme for that session. The present rules shall be applicable to the students who take admission in a programme according to Curriculum and Credit Framework for UG Programme (CCFUGP) as per NEP-2020 w.e.f. the academic session 2024-25.

- Skill Enhancement Courses (SEC); Ability Enhancement Courses (AEC); Value Added Courses (VAC); Multidisciplinary Courses (MDC), Minor Course (MIC), Minor Course (Vocational) [MIC(V)]. Discipline Specific Courses [Core courses, Elective courses, Practicum Courses].
A student of UG Programme (Scheme-B) will select 3 Major subjects in the first year out of the pool of subjects in that discipline offered by the Department/College/Institute. - A student will opt for MDC course from the subject which is different from the discipline of major subjects and should also be different from the courses undergone at senior secondary level (Class XII).
- 4-year UG (Honours) or (Honours with Research) in Major Subject will be offered after completion of 3-Year UG programme (Single Major) to those students who have completed at least 60 credits in the concerned Major Subject. In addition to the above, 4-Year UG (Honours with Research) in Major Subject will be offered only to those students who have obtained CGPA 7.5 or more in the 3-Year UG programme.
- In addition to the defined practicum courses, the practicum courses may include seminar or other activities as recommended by the concerned Board of Studies in case of Non-Practicum subjects. The Practicum course may be replaced by a theory course wherever Board of Studies decides so.

1. Scope

This Ordinance is based on National Education Policy-2020 (NEP-2020), Learning Outcome Based Curriculum Framework-Choice Based Credit System (LOCF-CBCS) and is according to the Curriculum and Credit Framework for UG Programmes (CCFUGP) of University Grants Commission and as per Memo No. DHE-170005/5/2023-Deputy Director-NPE dated June 8, 2023 regarding implementation of the key components of NEP-2020 in Colleges and Universities.

- (i) The duration of the programme for the award of Undergraduate Certificate in Discipline will be one academic year and of Undergraduate Diploma in Discipline will be two academic years. The duration of Bachelor Degree in discipline will be three academic years. Each academic year will be divided into two semesters i.e., July to December and January to June. There shall be teaching of 15 weeks in each semester excluding admission and examination days.
- (ii) The nomenclature of the Certificate/Diploma/Degree will be as under:
 - (a) UG Certificate in < Major Subject >
 - (b) UG Diploma in < Major Subject >
 - (c) Bachelor of Arts with Major in <Major Subject>
OR
Bachelor of Science with Major in <Major Subject>
 - (d) Bachelor of Arts (Hons.) in <Major Subject>
OR
Bachelor of Arts (Hons. with Research) in <Major Subject>
OR
Bachelor of Science (Hons.) in <Major Subject>
OR
Bachelor of Science (Hons. with Research) in <Major Subject>

2. Key Terms

- (i) **Learning Outcome based Curriculum Framework (LOCF):** The learning outcomes of the programme (POs) are mapped against well-defined Course Outcomes (COs).

- (ii) **Choice Based Credit System (CBCS):** The CBCS provides choices to students to select disciplinary and interdisciplinary/multidisciplinary courses to fit into their own requirements and to learn at their own pace within the framework.
- (iii) **Programme:** A programme is made up of courses/subjects and leads to the award of a Certificate or Diploma or Degree after completing requisite courses successfully.
- (iv) **Course/Subject:** A course/subject refers to component of a programme. A course/subject may comprise of lectures/tutorials/practicum or laboratory work/field practice/project work/seminar/community engagement and service/internship/dissertation, etc. or any combination of these.
- (v) **Credit:** A unit by which the course work is measured. It determines the number of hours of instructions required per week over the duration of one semester. For calculation of the teaching hours, one credit means one hour of lecture or one hour of tutorial or one hour of seminar or two hours of practicum/laboratory work per week over the duration of a semester.
- (vi) **Lecture:** Component of a course/subject which is taught by a teacher through lectures covering the contents of a course/subject.
- (vii) **Tutorial:** Component of a course/subject which involves problem-solving, learning through discussions and remedial teaching related to the contents and periphery of a course/subject with the direct involvement of a teacher.
- (viii) **Practicum:** A course/subject or a component of a course/subject which enables students to learn or to attain skills or to get procedural knowledge for the contents of a course/subject through practical/laboratory activity/project and to apply the studied principles/theory/ concepts related to the chosen field of learning, work/vocation, or professional practice in the field of learning, work/vocation under the supervision of a teacher.
- (ix) **Seminar:** A course/subject or a component of a course/subject which makes students to learn a specific topic through in-depth exploration and analysis of facts about the topic in a set-up that involves presentation, interactive discussions and collaborative learning under the supervision of a teacher.
- (x) **Internship:** A course/subject requiring students to participate in professional employment-related activity or work experience or co-operative education activity with an entity external to the educational institution normally under the supervision of an employee of an organization or an individual professional. A key aspect of the internship is induction into actual, formal and organized work situations. Internship involves working with local industry (Government or Private organizations), business establishments, artists, craft persons, etc. to provide opportunities for students to actively engage in on-site experiential learning.
- (xi) **Studio Activity:** A studio activity involves engagement of students in creative, artistic or experimental activities involving visual, digital, audio, video and other professional experiential work.
- (xii) **Field Work/Practice/Survey/Project:** A course/subject or a component of course/subject which enables students to participate in field-based learning/project, involving application of knowledge in solving/analyzing/exploring a real-life situation/difficult problem under the supervision of a teacher/mentor.
- (xiii) **Project Work:** A course/subject or a component of a course/subject which facilitates students to apply their knowledge, skills and critical thinking ability to complete a specific task in a given time frame through conceptualization, exploration and analysis of research-based activities to suggest tangible solutions for a given problem related to the chosen field of learning.
- (xiv) **Community Engagement and Service:** A course/subject or a component of a course/subject which exposes the students to the socio-economic issues prevailing in society so that the theoretical learning can be supplemented by actual life experiences to understand and generate solutions to real-life problems.

3. Discipline Specific Courses (DSC): A major course as discipline specific course is the field of study (subject) in which a student focuses for understanding and skills majorly in the chosen field of learning contributing to the core of the programme. This may include Core, Elective and Skill-enhancement courses.

- (ii) **Minor Courses (MIC):** Minor course aims to expand student's knowledge beyond the major field of study (DSC). This will also include **Vocational Course (VOC)** that will assist student in developing work-force relevant skills through practical work and enhances the employability of student.
- (iii) **Multidisciplinary Courses (MDC):** These courses are based on introductory knowledge in a subject. A student will study MDC in a subject other than the discipline of Discipline Specific and Minor subjects/courses to gain knowledge across the disciplines.
- (iv) **Ability Enhancement Courses (AEC):** These courses aim at enabling the students to achieve competency in the English language or Modern Indian Languages or other foreign languages with special emphasis on language and communication skills.
- (v) **Skill Enhancement Courses (SEC):** These courses aim at imparting practical skills, hands-on training, soft skills, etc. to enhance the employability of students.
- (vi) **Value-Added Courses (VAC):** These courses aim at enabling the students to acquire and demonstrate the acquisition of knowledge and understanding of human values, Indian Knowledge System, contemporary India, environmental science and education, digital and technical solutions, health and wellness, yoga education, sports and fitness, etc.

4 Evaluation terms

- (i) **Letter Grade:** It is an index of the performance of a student in a course. Grades are denoted by letters O, A+, A, B+, B, C, P, F and Ab depending on the score earned in that course.
- (ii) **Grade Point:** It is a numerical value allotted to each letter grade on a 10-point scale.
- (iii) **Credit Point:** It is the product of grade point and number of credits for a course.
- (iv) **Semester Grade Point Average (SGPA):** It is a measure of performance of a student in a semester. It is the ratio of total credit points secured by a student in all the courses registered in a semester to the total of the credits of the courses taken during that semester. It shall be expressed up to two digits after decimal place.
- (v) **Cumulative Grade Point Average (CGPA):** It is a measure of overall cumulative performance of a student in a programme over all the semesters. The CGPA is the ratio of total credit points secured by a student in all the courses of the programme to the sum of the total credits of all the courses of the programme. It shall be expressed up to two digits after decimal place.
- (vi) **Detailed-Grade-Certificate:** Based on the grades earned, a grade certificate shall be issued to all the registered students after every semester. The Detailed-Grade-Certificate (DGC) will display the course details (code, title, number of credits, grade secured) along with SGPA of that semester.

5 Academic Bank of Credits (ABC): It is a virtual/digital mechanism that contains information of the credits earned by individual students throughout their learning journey in Higher Education Institutions in India recognized by UGC. The Automated Permanent Academic Account Registry (APAAR) ID is also being introduced as a pivotal component. The APAAR ID serves as a lifelong academic passport, consolidating all achievements and credential of a student in one place. This will help enabling student mobility across higher education institution.

6 Programme Duration and Multiple Exit Options

All programmes shall be offered as per UGC list of 'Specification of Degree' prevailing from time to time. The programme duration and options for multiple entry and exit will be as per UG Curriculum Framework– Scheme-C (*Appendix-I; Table-1*).

- (i) A student will be allowed an exit option after passing first academic year of the UG Programme with requisite 48 credits including the 4 credits of internship of minimum of 4 weeks duration as per scheme of the programme and will be awarded an Undergraduate Certificate in the Major subject (*Appendix-I; Table-2*).
- (ii) A student will be allowed an exit option after passing two academic years of the UG Programme with requisite 94 credits including the 4 credits of internship of minimum of 4 weeks duration as per scheme of the programme and will be awarded Undergraduate Diploma in the Major subject (*Appendix-I; Table-2*).
- (iii) A student will be awarded with Bachelor degree in Major subject after successfully completing three academic years of UG Programme and earning requisite 136 credits including the 60 credits in the major subject and 4 credits of internship of minimum of 4 weeks duration as per scheme of the programme (*Appendix-I; Table-2*).
- (iv) A student, who has successfully completed three years in single major programme and has earned minimum 60 credits in the major subject can opt for Honours Programme in that subject in the fourth year. If a Department/College/Institute allows to continue the students or admits the student for fourth year of Honours Programme, then the student will be awarded with Bachelor degree (Honours) in the major subject after successfully completing four academic years of UG Programme and earning requisite 184 credits including the 4 credits of internship of duration 4 weeks as per scheme of the programme (*Appendix-I; Table-2*).

Further provided that a Department/College/Institute will be able to admit students for Honours programme only if the institution has got the approval for the same from the University after obtaining approval from Director, Higher Education (DHE), Government of Haryana, where ever applicable

- (v) A student, who has successfully completed three years degree in a single major programme and has earned minimum 60 credits in the major subject and obtained CGPA of 7.5 or more can opt for Honours with Research Degree Programme in that subject in the fourth year. If a student opts to continue or is admitted by an eligible Department/College/Institute to Honours with Research Programme in the fourth year, then the student will be awarded with Bachelor degree (Honours with Research) in the major subject after successfully completing four academic years of UG Programme and earning requisite 184 credits including the 4 credits of internship of duration 4 weeks and 12 credits of Project/Dissertation as per scheme of the programme (*Appendix-I; Table-2*).

Further provided that a Department/College/Institute will be able to admit students for Honours with Research Programme only if the institution has got the approval for the same from the university after obtaining approval from Director, Higher Education (DHE), Government of Haryana, where ever applicable.

7 Admission to a UG Programme under Multiple Entry

- (i) The Department/College/Institute shall declare approved total number of seats available discipline-wise each year for fresh and lateral admissions.
- (ii) The Department/College/Institute can plan the number of seats discipline-wise in consonance with the faculty and infrastructure available.

(iii) A student can pursue two Undergraduate Programme simultaneously through Open and Distance Learning (ODL)/online mode; or combinations of ODL, online and regular modes, from the same or different Universities/Institutions duly approved by the UGC/AICTE/Regulatory Body/Central Government/State Government, in various combinations, viz.

- A student can pursue two full-time UG Programme in physical mode provided that in such cases, class timings and examination schedule for one programme do not overlap with the class timings and examination schedule of the other programme, and requirements under clause 7(iv) are fulfilled.
- A student can pursue two UG Programme, one in full-time physical mode and another in ODL/online mode; or up to two ODL/online programmes simultaneously.

The Department/College/Institute and the University shall not be responsible for any such overlapping and consequences thereof.

(iv) **Minimum Eligibility Conditions for Admission**

A candidate who has passed Senior Secondary Certificate Examination (Class XII level) of the Board of School Education, Haryana; or any other examination recognized as equivalent thereto with minimum passing marks in aggregate with English as one of the subjects, shall be eligible to join First Semester of the Undergraduate (UG) Programme. In addition, the following conditions, if applicable should also be satisfied:

- to opt for Mathematics as a DSC, the candidate must have passed Mathematics as a subject in the qualifying examination.
- to opt for Chemistry as a DSC, the candidate must have passed Chemistry as a subject in the qualifying examination.
- to opt for Physics as a DSC, the candidate must have passed Physics as a subject in the qualifying examination
- to opt for subject(s) in the discipline of Life Sciences, which consists of Botany, Zoology as a one or more than one subject(s), then the candidate must have passed Class XII with Biology as a subject.
- to opt for subjects of Physical Sciences discipline as Major subject(s), the candidate must have passed respective subjects in the qualifying examination.

Further, eligibility conditions for admission to a programme shall be applicable as mentioned in the scheme of the concerned programme.

A candidate having 2-Year Diploma from ITI or 3-Year Diploma from Polytechnic of minimum 2 years duration qualified with Hindi Core/English as one subject or as an additional subject at Class XII level is also eligible for seeking admission in First Semester of the UG Programme in Arts discipline or in the disciplines wherever mentioned so.

Note: Eligibility conditions are subject to change according to the implementation of National Curriculum Framework (NCrF) for school education or in accordance with any such guidelines issued by the Central/State Government or issued by University from time to time.

(v) A student who has been placed under compartment or allowed to re-appear in one subject only in Senior Secondary Certificate Examination (Class XII level) of the Board of School Education, Haryana, or equivalent examination of another

University/Board may be allowed to study provisionally for the First Semester of the UG programme. Such student shall pass the compartment/re-appear subject before commencement of the examination of Ist semester of the concerned UG Programme. If a student does not clear the compartment/re-appear subject before the commencement of the Ist semester examination, her/his provisional admission to concerned UG Programme shall be cancelled ab initio by the Chairperson/Principal/Director with intimation to the University. However, the Vice-Chancellor may relax this condition, in exceptional cases at own level or on the recommendations of a committee constituted by the Vice-Chancellor.

For such students, the required percentage of marks for admission shall be determined by considering the minimum pass marks in compartment/re-appear subject.

- (vi) The student opting for exit must inform in writing to the Department/College/Institute by 30th June of every year. The student is allowed multiple entry into a UG Programme. For example, the student can re-enter into second year of a programme if she/he has taken an exit option after first year. Similarly, re-entry into the third year is allowed if exit option was exercised by a student after getting UG Diploma. In any case, the gap between the exit and the re-entry into the UG Programme should not be more than three years subject to completion of the whole UG Programme within six years. Multiple entry shall be allowed in a Department/College/Institute subject to the availability of seats in the concerned programme in that year in that Department/College/Institute. In case of re-entry, the scheme and syllabus currently running will be applicable.
- (vii) Lateral admissions against sanctioned vacant seats may be filled by a Department/College/Institute category wise following the State Govt. norms for reservation in an odd semester. Lateral admission may be provided in the 3rd and 5th semesters if a student has passed all the preceding examinations up to 2nd and 4th semester, respectively of the concerned programme under NEP Curriculum Framework. However, this will be subject to fulfilment of other eligibility conditions for the programme in which the admission is sought.

First preference in the lateral admission will be given to the students of that Department/College/Institute who had taken exit from that programme and are seeking re-entry into the same institution, for this a cut-of-date will be notified by Department/College/Institute.

8 Subjects/Courses of UG Programmes

- (i) A student of UG Programme (Major), herein after called Scheme C, who is seeking admission in the programme with single Major subject in the first year offered by the Department/College/Institute study DSCs in the Major subject as per scheme of the concerned subject. Minor subject, different from the Major subject, is to be offered from the same discipline. Any subject in a discipline can be a Major or Minor subject for a UG programme. In case of Physical Sciences and Life Sciences disciplines, if the Minor Subject cannot be offered from the same discipline by a Department/College/Institute, then the Minor Subject may be offered from either of the two disciplines. For Example, if a Department/College/Institute is unable to offer a Minor subject from the discipline of Life Sciences, other than three subjects Botany, Zoology and Chemistry which have been offered as three Major subjects, then Department/College/Institute can offer any subject from the discipline of Physical Sciences as a Minor Subject.

- (ii) A student will study Discipline Specific, Minor, Minor (Vocational), AEC, VAC, SEC and MDC courses as per Curriculum Framework Scheme C (*Appendix-I; Table 1*).
- (iii) For UG Programme (Major) (Scheme C), a Minor course will be of 4 credits and will be taken out of the offered DSCs of that subject in that semester.
- (iv) A student will study three Multidisciplinary Courses (MDCs) in first three semesters. The Multidisciplinary Courses (MDCs) will be from the subject/course which is different from the Discipline Specific and Minor subjects/courses. Students are not allowed to choose or repeat courses already undergone at the Senior Secondary Level (Class XII) or Discipline Specific and Minor subjects/courses under this category. Provided further that if a Multidisciplinary Course (MDC) across the discipline cannot be offered by a Department/College/Institute, due to its constraints and available resources, then

- A subject from the same discipline can be offered as MDC course if that subject also belongs to the list of subjects of some other discipline.
- MDC can be opted out of MOOCs through SWAYAM.
- MDC can be completed out of online course(s) offered by GJUST.
- MDC can be completed from a cluster college i.e., from a neighbouring College/Institute or else.

Note: The student himself/herself has to pay the requisite fee and/or re-appear fee as applicable from time to time. Department/College/Institute shall not be responsible for any issue(s) related to MOOCs, online course(s) and from cluster college or else.

- (v) A student will select AEC, SEC, VAC and Minor (Vocational) courses from a pool of respective courses offered in Department/College/Institute.

Depending upon the availability of faculty and infrastructure, a Department/College/Institute may offer AEC, SEC, VAC and Minor (Vocational) courses from the respective pool of courses duly approved by the College/University. University will review and revise such pools from time to time by taking proposals of Department/College/Institute into consideration.

- (vi) A student will study VAC– ‘Environmental Studies’ which is mandatory and at least one SEC to gain computer competency before exit. The number of these courses will be offered by the Department/College/Institute according to the availability of faculty and infrastructure.
- (vii) In the subjects/courses which involve practicum, i.e., Practical/Laboratory/Studio/Project/ Survey/Field work, etc., a course of 4 credits will dedicate 3 credits for lectures and one credit for practicum or 4 credits for lectures. In other subjects/courses not having practicum component, a course of 4 credits will dedicate 3 credits for lectures and 1 credit for tutorial or 4 credits for lectures.

During 4th year, if the practicum course is offered as a separate course in that subject, all the credits will be dedicated to practicum.

In the case, when tutorial of 1 credit is not adopted/implemented in a subject, then all the credits of that course will be dedicated to lectures only.

- (viii) In case of AEC and VAC of 2 credits, the entire 2 credits will be allocated to lectures.
- (ix) In the SEC courses of 3 credit, 2 credit will be allocated to lectures and 1 credit to practicum/Seminar/tutorial.
- (x) In case of Minor (Vocational) courses/subjects, where practicum component is dominant, a course of 4 credits may allocate 2 credits to lectures and 2 credits to

practicum. Similarly, a course of 4 credits may be divided into 2 credits of lectures and 2 credits of practicum in the subjects where the practicum component of the course is major and teaching-learning process mainly depends upon practicum, e.g. Music and Fine Arts.

9 Contact hours/workload

The weekly contact hours/workload for theory/practical/laboratory/studio/project/survey/field work, etc. components of the courses will be:

- (i) 1 credit theory/tutorial = 1 hour;
- (ii) 1 credit practical/laboratory/studio/project/survey/field work = 2 hours.
- (iii) The tutorial and practical/laboratory/studio/project/survey/field work will be conducted in groups of students and one group will comprise of 20 students.

10 Online Courses

With the permission of Department/College/Institute, a student can opt for online courses (at own level), up to 40% of the courses of the programme except Discipline Specific Courses and Skill Enhancement courses, through online platform SWAYAM or online courses offered by GJUST, Hisar or through other such online platforms approved by the UGC as per university guidelines prevailing time to time.

11 Internship

Every student for the UG Programme shall be required to undergo 4 credits internship of minimum of 4 weeks duration before taking an exit or completing the degree programme.

- (i) A student for the UG Programme shall be required to undergo internship during summer vacation either after the second semester examination or after the fourth semester examination. If she/he opts to exit with Undergraduate Certificate in the discipline, then it shall be obligatory to complete the internship after second semester examination.

However, for those students who have taken lateral entry into the third semester and have completed internship of minimum of 4 weeks duration during first year, the internship is not required after the fourth semester examination

- (ii) A student will inform and get approval from the Chairperson/Principal/Director of the Department/College/Institute before going for an internship. The internship will involve working with local industry (Government or Private organizations/ Institutions), business establishments, artists, craft persons, or a professional (individual/organization). Student will submit a copy of the report (a hard copy and a soft copy in PDF) to the Department/College/Institute within 15 days after the completion of internship. A student must submit a certificate of attendance and work done report from the organization/professional where the internship was done. The evaluation of the internship shall be done by a committee comprising of at least two teachers appointed by the Chairperson/Principal/Director of the College/Institute. Marks will be awarded by the committee out of 100 marks on the basis of the report and viva-voce examination.
- (iii) The internship will be governed by the prevailing rules of the University from time to time.

12 Project/Dissertation

A student of fourth-year Bachelor Degree (Honours with Research) Programme will be required to work on the Research Project or do research during eighth semester. The Project/Dissertation work will be of 12 credits.

- (i) A student, who has been admitted in Honours with Research Programme, shall submit a request for allotment of a supervisor mentioning her/his research areas of interest in order of preference to the Chairperson/Principal/Director during seventh semester. The Department/College/Institute will allot a qualified supervisor to guide the student for doing research during Project/Dissertation work. A regular full-time teacher of that Department/College/Institute, who has been approved to supervise Ph.D. scholars by the university, will be eligible to guide the students of Honours with Research programme of that institution.
- (ii) The student will submit the synopsis to the supervisor. In case of University Teaching Department (UTD) the synopsis will be approved by the departmental research advisory committee after recommendation of the supervisor. In other cases, the Principal/Director of College/Institute shall constitute a committee for this purpose at the College/Institute level. External experts may be involved wherever sufficient qualified regular teachers are not available.
- (iii) The student shall be required to submit three hard copies of her/his dissertation along with soft copy as PDF file to the Department/College/Institute by 30th June of the concerned year. The late submission can be allowed with late fees as decided by the university from time to time. The Anti-plagiarism policy of the university is to be strictly followed by the candidate and the supervisor. Similarity report as per Anti-plagiarism policy of the university is to be annexed with the dissertation.
- (iv) Evaluation of the dissertation shall be done by an external examiner. The dissertation work will be of total 12 credits (300 marks) and evaluation will be done in two components; report of dissertation (200 marks) and open viva-voce examination (100 marks).

13 Medium of Instructions and Examination

- (i) For Arts/Home Science/Commerce subjects, the medium of instructions shall be Hindi/English.
The question paper shall be set in both English and Hindi, wherever feasible, except in the case of
 - English, in which the questions shall be set in English.
 - Sanskrit, in which the questions shall be set in Sanskrit/Hindi.
 - Other languages, in which the questions shall be set in the language concerned.
- (ii) The students shall write their answers:
 - in English, in case of English language
 - in the language concerned, in the case of Modern Indian Languages
 - English/Hindi in the case of other subjects.

- (iii) For Physical Sciences/Life Sciences Subjects/Courses, the medium of instructions shall be mainly English. Hindi medium will also be offered wherever feasible and approved by the university. The question paper shall be set in English. Bilingual question paper (s) will be provided, wherever possible and approved by the university. The students can write their answers in English/Hindi depending on the medium of instructions and language of the course content/syllabus.

14 Programme and Course Learning Outcomes

Individual programmes of study will have well defined learning **Programme Outcomes (POs)** which should be attained for the award of a specific Certificate/Diploma/Degree.

Each course will have well defined learning **Course Outcomes (COs)** specific to the learning for a given course of study related to a disciplinary or interdisciplinary/multi-disciplinary area. Course Outcomes (COs) will be mapped to Programme Outcomes (POs). The attainment of Course Outcomes will lead to the attainment of the Programme Outcomes.

15 Assessment and Evaluation

(i) Student Progression and Mentoring

Each student shall be examined in the course(s) to help their progression through the programme as laid down in the scheme, syllabus and learning outcomes through a system of Continuous Comprehensive Assessment (CCA) using a mix of Internal and End-Term evaluation.

- Internal Assessment will be broadly 30% of the total marks and weightage of 70% shall be given to evaluation of End-Term examination(s).
- Internal Assessment (30%) shall be broadly based on the following defined components: Class Participation; Seminar/Presentation/Assignment/Quiz/Class Test, etc. in case of Theory examination and Seminar/Demonstration/Viva-Voce/Lab record, etc. in case of Practical examination; Mid-Term Exam.
- Internal Assessment Marks will be further distributed as per following tables:

- A student has to obtain minimum 40% marks (Grade 'P') in aggregate (sum of the Internal Assessment and End-Term Examination marks) and in End-Term Examination separately to qualify a course.
- (ii) The pass percentage will be 40% (Grade 'P') both for theory and practicum End-Term Examination.
- (iii) The Chairperson/Principal/Director shall ensure uploading of the Internal Assessment marks at least one week before the commencement of the End-Term Semester Examinations on the examination portal of the University or as notified by the Controller of Examinations of the University.
- (iv) Internal Assessment marks of a course shall be carried forward in case of re-appear examination of that course.
- (v) The Chairperson/Principal/Director shall preserve the record on the basis of which the Internal Assessment awards have been prepared, for inspection, if needed by the university, for one year from the date of declaration of semester examination results.

16 Eligibility for Examination

End-Term Examination shall be open to a regular student who

- (i) has been on the rolls of the Department/College/Institute during the semester.
- (ii) has passed the requisite qualifying examination as laid down above, if she/he is a candidate for the First Semester Examination.
- (iii) has her/his examination form submitted to the Examinations Branch through the Chairperson/Principal/Director of the concerned Department/College/Institute.
- (iv) has attended not less than 75% of the lectures in a course. This requirement shall be fulfilled separately for each course of the programme. A deficiency in the prescribed course (Lectures/Practicum, etc.) may be condoned by the Chairperson/Principal/Director of the Department/College/Institute in deserving cases up to 15% (excluding 2% additional for Girl/Women student).
- (v) These shall also include loss of attendance due to participation in the cultural and sports assignments, etc. Provided that, a student who participates in the Inter-University Tournaments or Inter University Youth festivals or Republic Day Parade may be allowed additional condonation on this ground up to 10% in each paper on a certificate from the Dean/Director, Sports/Youth Welfare/Cultural Affairs, Placement Cell, NSS, ANO, NCC, YRC as the case

may be, subject to the condition that such a student shall not be allowed to appear in the examination if his/her attendance, after condonation on all counts, falls below 50%.

- (vi) Provided that a candidate who has not attended the requisite percentage of lectures/practicum shall not be eligible to take the End-Term Examination in the concerned theory/practicum unless she/he repeats the course and obtains requisite attendance.

17 Duration for Passing the Programme

- (i) A student can complete a Bachelor degree programme within seven years. A student who fails to pass the whole examination(s) of a UG programme within seven years of admission to the programme, shall be awarded Undergraduate Certificate/Diploma on the basis of qualified courses as per credit point, if eligible (*Appendix-I; Table 2*).
- (ii) Each student will have to open an Academic Bank of Credit (ABC) account immediately for admission or during admission if admitted. At the end of each semester, credits earned by the students will be uploaded in her/his respective ABC account. A student registered in ABC account for a programme will be allowed to complete the respective programme within seven years or as per the time period stipulated in the ABC for accumulation of credits from time to time or within the period as prescribed by the university for the purpose.

18 Conditions for Promotion to Higher Semester and Rules for Re-appear

- (i) A student who has appeared and failed in one or more courses of the First Semester shall be allowed to study for and appear in the second semester. Such a student may pursue her/his studies for the next higher semester(s) and appear in the examination(s) for the same along with the examination for the lower semester(s).
- (ii) A candidate who has attended the prescribed classes of a course(s) of a programme in the Department/College/Institute in a semester and was eligible but did not appear in the End-Term examination or has appeared but fails, may be allowed on the recommendation of the Chairperson/Principal/Director of the Department/College/Institute to appear/re-appear as an ex-student in the End-Term examinations of that course(s) as the case may be, in the subsequent semesters examination up to two times when such examination(s) are held without attending the course(s) again. While re-appearing in the examination, the student shall be exempted from appearing in the course(s)/practical(s) in which she/he has obtained pass marks.

Provided that after completion of regular studies for the whole duration of a programme, the candidate will be allowed to appear in examination as an ex-student/private for the re-appear/left out courses under the permissible chances, within the prescribed time period to complete the programme.

- (iii) A candidate who could not complete or has failed in a project/internship, she/he will get only one chance to repeat the project work at the end of the next Semester. Further, if the candidate still fails or remains absent in the project/internship, then she/he will not be eligible for the award of the concerned UG Certificate/Diploma/Degree

19 Examinations and Result

- (i) End-Term Examinations for the odd semesters shall ordinarily be held in November/December and for the even semesters in May/June, on such dates as may be notified by the Controller of Examinations from time to time.
- (ii) Supplementary examinations will be held for Re-appear candidates as under:

Semester	When held
Odd Semester	Along with the First, Third and Fifth Semester
Even Semester	Along with the Second, Fourth and Sixth Semester

- (iii) The last date(s) by which the examination forms shall be uploaded on the examination portal shall be as per the schedule notified by the Controller of Examinations from time to time.
- (iv) The amount of examination fee to be paid by a student for each semester shall be as prescribed by the University from time to time.
- (v) The minimum Semester Grade Point Average (SGPA) to qualify a semester shall be 4.00 and minimum Cumulative Grade Point Average (CGPA) required for the award of the UG Certificate/Diploma/Degree shall be 4.00.
- (vi) The Examination Branch shall prepare the Grade/Result and the Controller of Examinations will notify the same.
- (vii) If a student is not able to pass any semester examination during her/his regular studies in the programme, her/his pass credits will be accumulated in the Academic Bank of Credits (ABC) and she/he can pass the deficient courses any time within seven years or as stipulated in the Academic Bank of Credits from time to time.
- (viii) A student who discontinues her/his studies at any point of time may be permitted to re-join the programme of study and complete balance credits.
- (ix) **Award of Grades**
Award of grades and the corresponding grade points will be based on absolute marks as per the following table:

- The multiplication factor for conversion from SGPA/CGPA to equivalent percentage of marks shall be 10.
- A candidate eligible to take the examination obtaining Grade 'F'/'Ab' will be considered to have failed in the examination/course(s). Such a student will be required to re-appear in that examination/course(s) within the permissible chances.

20 Computation of SGPA and CGPA

The following shall be the procedure to compute the Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

- (i) The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a candidate in all the courses taken by the candidate in a semester to the sum of the number of credits of all the courses undertaken by the candidate in that semester, i.e.

$$SGPA(S_j) = \frac{\sum(C_i + G_i)}{\sum C_i}$$

where C_i is the number of credits of the i^{th} course and G_i is the grade point scored by the student in the i^{th} course in the j^{th} semester.

- (ii) The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme, i.e.

$$CGPA(S_j) = \frac{\sum(N_j + S_j)}{\sum N_j}$$

where S_j is the SGPA of the j^{th} semester and N_j is the total number of credits in that semester.

- (iii) The SGPA and CGPA shall be rounded off to 2 digits after decimal place and shall be reported in the Detail-Grade-Certificate (DGC).

A merit list will be prepared for a programme and Gold Medal will be awarded to a candidate securing highest CGPA provided the candidate must have passed all the semester examinations in the first attempt and within minimum duration of the programme. In case, when more than one student has the same CGPA, then Gold Medal shall be decided on the basis of actual obtained marks in the programme.

21 Improvement

- (i) A candidate who has passed a UG Programme from GJUST, Hisar and is desirous of improving her/his CGPA in the respective programme (Certificate/Diploma/Degree/Degree (Hons.)), will be allowed to appear within next four Semester examinations of passing the sixth semester examination to appear as an ex-student in one or more theory course(s) of any one or two parts, out of Part-I (Semester I & II), Part-II (Semester III & IV), Part-III (Semester V & VI) and Part IV (Semester VII & VIII) separately in four consecutive semester examinations and shall pay examination fee as for the whole semester examination in which she/he opts to appear. The rules, syllabus and fees for improvement examinations shall be applicable as prevailing at that time or as prescribed by the university from time to time.
- (ii) The result of improvement examinations shall be declared only if a candidate improves her/his CGPA of the respective programme. Provided further that if a student does not want to avail the remaining chances out of permissible four total chances for improvement, then she/he will submit an undertaking to this effect for declaration of her/his final result. The fact that student has improved the performance/grade shall be mentioned in the Detailed-Grade-Certificate (DGC).
- (iii) Improvement shall not be allowed in Internal Assessment/Practical/Internship/ Field Work/Project/Seminar/Studio etc.

22 Award of Grace Marks

Grace marks will be awarded according to the university rules prevailing from time to time.

- 23** The ordinance in force at the time a student joins the programme shall hold good only for the examination held during or at the end of the academic year and nothing in this ordinance shall be deemed to debar the university from amending the ordinance and the amended ordinance, if any, shall apply to all the students whether old or new.

- 24**
- (i) In the event of any inconsistency in the rules or any clarification thereof, the matter shall be referred to the Vice-Chancellor for interpretation, whose decision shall be final. The Vice-Chancellor is also competent to remove any inconsistency/make amendment in rules at any time and decide which provision shall take precedence over the other.
 - (ii) The Vice-Chancellor is authorized to make changes/amendments in the ordinance of different Schemes for effective implementation of Curriculum and Credit Framework of Undergraduate and Integrated 5 years Programmes under National Education Policy 2020.
 - (iii) Notwithstanding anything mentioned above, the Vice-Chancellor can relax any rule in exceptional cases or when situation demands so.

25 Transitory Provision

Students admitted to UG Programmes under semester system in Department/College/Institute prior to that academic session 2024-25 shall be governed by the old rules as applicable for that programme for that session. The present rules shall be applicable to the students who take admission in a programme according to Curriculum and Credit Framework for UG Programme (CCFUGP) as per NEP-2020 w.c.f. the academic session 2024-25.

- Discipline Specific Courses (DSC), Minor courses (MIC) including vocational (VOC), Ability Enhancement Courses (AEC); Value Added Courses (VAC); Multidisciplinary Courses (MDC), Core courses, Elective courses and Practicum Course of this programme.
- A student of UG Programme (Major) will study single major subject in the first year.
- A student will study Discipline Specific Courses (DSC) including Core, Elective and Practicum courses from the major subject as per scheme of the programme.
- A student will study AEC, VAC, SEC, MDC and Minor (Vocational) Courses from the respective pools of the courses offered by Department/College/Institute duly approved by the University
- Minor subject will be different from the Major subject in the same discipline. Minor Course will be of 4 credits and will be taken out of the offered Core Courses of that subject (Minor subject).
- A student will opt for MDC course from the subject which is different from the discipline of major subjects and should also be different from the courses undergone at senior secondary level (Class XII).
- 4-year UG (Honours) or (Honours with Research) in Major Subject will be offered after completion of 3-Year UG programme (Single Major) to those students who have completed at least 60 credits in the concerned Major Subject. In addition to the above, 4-Year UG (Honours with Research) in Major Subject will be offered only to those students who have obtained CGPA 7.5 or more in the 3-Year UG programme.
- In addition to the defined practicum courses, the practicum courses may include seminar or other activities as recommended by the concerned Board of Studies in case of Non-Practicum subjects. The Practicum course may be replaced by a theory course wherever Board of Studies decides so.

SEMESTER SYSTEM

Under Learning Outcome Based Curriculum Framework-Choice Based Credit System (LOCF-CBCS) as per NEP-2020

(w.e.f. Session 2024-25)

1. Scope

This Ordinance is based on National Education Policy-2020 (NEP-2020), Learning Outcome Based Curriculum Framework-Choice Based Credit System (LOCF-CBCS) and is according to the Curriculum and Credit Framework for UG Programmes (CCFUGP) of University Grants Commission and as per Memo No. DHE-170005/5/2023-Deputy Director-NPE dated June 8, 2023 regarding implementation of the key components of NEP-2020 in Colleges and Universities.

- (i) The duration of the programme for the award of Undergraduate Certificate in Discipline will be one academic year and of Undergraduate Diploma in Discipline will be two academic years. The duration of Bachelor Degree in discipline will be three academic years and that of Bachelor Degree (Honours)/Bachelor Degree (Honours with Research) in Discipline will be four academic years. Each academic year will be divided into two semesters i.e., July to December and January to June. There shall be teaching of 15 weeks/90 days in each semester excluding admission and examination days.
- (ii) The nomenclature of the Certificate/Diploma/Degree will be as under:
 - (a) UG Certificate in <discipline>
 - (b) UG Diploma in <discipline>
 - (c) Bachelor of <discipline>
 - (d) Bachelor of <discipline> (Hons.)
 - or
 - Bachelor of <discipline> (Hons. with Research)

2. Key Terms

- (i) **Learning Outcome based Curriculum Framework (LOCF):** The learning outcomes of the programme (POs) are mapped against well-defined Course Outcomes (COs).
- (ii) **Choice Based Credit System (CBCS):** The CBCS provides choices to students to select disciplinary and interdisciplinary courses to fit into their own requirements and to learn at their own pace within the framework.
- (iii) **Programme:** A programme is made up of courses/subjects and leads to the award of a Certificate or Diploma or Degree after completing requisite courses successfully.
- (iv) **Course/Subject:** A course/subject refers to component of a programme. A course/subject may comprise of lectures/tutorials/practicum or laboratory work/field

practice/project work/seminar/community engagement and service/internship/dissertation, etc. or any combination of these.

- (v) **Credit:** A unit by which the course work is measured. It determines the number of hours of instructions required per week over the duration of one semester. For calculation of the teaching hours, one credit means one hour of lecture or one hour of tutorial or one hour of seminar or two hours of practicum/laboratory work per week over the duration of a semester.
- (vi) **Lecture:** Component of a course/subject which is taught by a teacher through lectures covering the contents of a course/subject.
- (vii) **Tutorial:** Component of a course/subject which involves problem-solving, learning through discussions and remedial teaching related to the contents and periphery of a course/subject with the direct involvement of a teacher.
- (viii) **Practicum:** A course/subject or a component of a course/subject which enables students to learn or to attain skills or to get procedural knowledge for the contents of a course/subject through practical/laboratory activity/project and to apply the studied principles/theory/ concepts related to the chosen field of learning, work/vocation, or professional practice in the field of learning, work/vocation under the supervision of a teacher.
- (ix) **Seminar:** A course/subject or a component of a course/subject which makes students to learn a specific topic through in-depth exploration and analysis of facts about the topic in a set-up that involves presentation, interactive discussions and collaborative learning under the supervision of a teacher.
- (x) **Internship:** A course/subject requiring students to participate in professional employment-related activity or work experience or co-operative education activity with an entity external to the educational institution normally under the supervision of an employee of an organization or an individual professional. A key aspect of the internship is induction into actual, formal and organized work situations. Internship involves working with local industry (Government or Private organizations), business establishments, artists, craft persons, etc. to provide opportunities for students to actively engage in on-site experiential learning.
- (xi) **Studio Activity:** A studio activity involves engagement of students in creative, artistic or experimental activities involving visual, digital, audio, video and other professional experiential work.
- (xii) **Field Work/Practice/Survey/Project:** A course/subject or a component of course/subject which enables students to participate in field-based learning/project, involving application of knowledge in solving/analyzing/exploring a real-life situation/difficult problem under the supervision of a teacher/mentor.
- (xiii) **Project Work:** A course/subject or a component of a course/subject which facilitates students to apply their knowledge, skills and critical thinking ability to complete a specific task in a given time frame through conceptualization, exploration and analysis of research-based activities to suggest tangible solutions for a given problem related to the chosen field of learning.
- (xiv) **Community Engagement and Service:** A course/subject or a component of a course/subject which exposes the students to the socio-economic issues prevailing in society so that the theoretical learning can be supplemented by actual life experiences to understand and generate solutions to real-life problems.

3. Courses

- (i) **Discipline Specific Courses (DSC):** A major course as discipline specific course is the field of study (subject) in which a student focuses for understanding and skills majorly in the chosen field of learning contributing to the core of the programme. This may include Core, Elective and Skill-enhancement courses.

- (ii) **Minor Courses (MIC):** Minor course aims to expand student's knowledge beyond the major field of study (DSC). This will also include **Vocational Course (VOC)** that will assist student in developing work-force relevant skills through practical work and enhances the employability of student.
- (iii) **Multidisciplinary Courses (MDC):** These courses are based on introductory knowledge in a subject. A student will study MDC in a subject other than the discipline of Discipline Specific and Minor subjects/courses to gain knowledge across the disciplines.
- (iv) **Ability Enhancement Courses (AEC):** These courses aim at enabling the students to achieve competency in the English language or Modern Indian Languages or other foreign languages with special emphasis on language and communication skills.
- (v) **Skill Enhancement Courses (SEC):** These courses aim at imparting practical skills, hands-on training, soft skills, etc. to enhance the employability of students.
- (vi) **Value-Added Courses (VAC):** These courses aim at enabling the students to acquire and demonstrate the acquisition of knowledge and understanding of human values, Indian Knowledge System, contemporary India, environmental science and education, digital and technical solutions, health and wellness, yoga education, sports and fitness, etc.

4 Evaluation terms

- (i) **Letter Grade:** It is an index of the performance of a student in a course. Grades are denoted by letters O, A+, A, B+, B, C, P, F and Ab depending on the score earned in that course.
- (ii) **Grade Point:** It is a numerical value allotted to each letter grade on a 10-point scale.
- (iii) **Credit Point:** It is the product of grade point and number of credits for a course.
- (iv) **Semester Grade Point Average (SGPA):** It is a measure of performance of a student in a semester. It is the ratio of total credit points secured by a student in all the courses registered in a semester to the total of the credits of the courses taken during that semester. It shall be expressed up to two digits after decimal place.
- (v) **Cumulative Grade Point Average (CGPA):** It is a measure of overall cumulative performance of a student in a programme over all the semesters. The CGPA is the ratio of total credit points secured by a student in all the courses of the programme to the sum of the total credits of all the courses of the programme. It shall be expressed up to two digits after decimal place.
- (vi) **Detailed-Grade-Certificate:** Based on the grades earned, a grade certificate shall be issued to all the registered students after every semester. The Detailed-Grade-Certificate (DGC) will display the course details (code, title, number of credits, grade secured) along with SGPA of that semester.

- 5 **Academic Bank of Credits (ABC):** It is a virtual/digital mechanism that contains information of the credits earned by individual students throughout their learning journey in Higher Education Institutions in India recognized by UGC. The Automated Permanent Academic Account Registry (APAAR) ID is also being introduced as a pivotal component. The APAAR ID serves as a lifelong academic passport, consolidating all achievements and credential of a student in one place. This will help enabling student mobility across higher education institution.

6 Programme Duration and Multiple Exit Options

All programmes shall be offered as per UGC list of 'Specification of Degree' prevailing from time to time. The programme duration and options for multiple entry and exit will be as per UG Curriculum Framework Scheme-D (*Appendix-I; Table-1*).

- (i) A student will be allowed an exit option after passing first academic year of the UG Programme with requisite 52 credits including the 4 credits of internship of minimum of 4 weeks duration as per scheme of the programme and will be awarded an Undergraduate Certificate in the discipline (Commerce/Business Administration/Computer Applications/etc.) (*Appendix-I; Table-2*).
- (ii) A student will be allowed an exit option after passing two academic years of the UG Programme with requisite 96 credits including the 4 credits of internship of minimum of 4 weeks duration as per scheme of the programme and will be awarded Undergraduate Diploma in the discipline (Commerce/Business Administration/Computer Applications/etc.) (*Appendix-I; Table-2*).
- (iii) A student will be awarded with Bachelor degree in the discipline (Commerce/Business Administration/Computer Applications/etc.) after successfully completing three academic years of UG Programme and earning requisite 132 credits including the 4 credits of internship of minimum of 4 weeks duration as per scheme of the programme (*Appendix-I; Table-2*).
- (iv) A student, who has successfully completed three years programme in a discipline and has earned minimum 60 credits in that discipline can opt for Honours Programme in that discipline in the fourth year. If a Department/College/Institute allows to continue the students or admits the student for fourth year of Honours Programme, then the student will be awarded with Bachelor degree (Honours) in the Discipline after successfully completing four academic years of UG Programme and earning requisite 180 credits including the 4 credits of internship of duration 4 weeks as per scheme of the programme (*Appendix-I; Table-2*).

Further provided that a Department/College/Institute will be able to admit students for Honours programme only if the institution has got the approval for the same from the University after obtaining approval from Director, Higher Education (DHE), Government of Haryana, where ever applicable

- (v) A student, who has successfully completed three years degree in a discipline and has earned minimum 60 credits in that discipline and obtained CGPA of 7.5 or more can opt for Honours with Research Degree Programme in that Discipline in the fourth year. If a student opts to continue or is admitted by a eligible Department/College/Institute to Honours with Research Programme in the fourth year, then the student will be awarded with Bachelor degree (Honours with Research) in the Discipline after successfully completing four academic years of UG Programme and earning requisite 180 credits including the 4 credits of internship of duration 4 weeks and 12 credits of Project/Dissertation as per scheme of the programme (*Appendix-I; Table-2*).

Further provided that a Department/College/Institute will be able to admit students for Honours with Research Programme only if the institution has got the approval for the same from the university after obtaining approval from Director, Higher Education (DHE), Government of Haryana, where ever applicable.

7 Admission to a UG Programme under Multiple Entry

- (i) The Department/College/Institute shall declare approved total number of seats available discipline-wise each year for fresh and lateral admissions.
- (ii) The Department/College/Institute can plan the number of seats discipline-wise in consonance with the faculty and infrastructure available.
- (iii) A student can pursue two Undergraduate Programme simultaneously through Open and Distance Learning (ODL)/online mode; or combinations of ODL, online and regular modes, from the same or different Universities/Institutions duly approved

by the UGC/AICTE/Regulatory Body/Central Government/State Government, in various combinations, viz.

- A student can pursue two full-time UG Programme in physical mode provided that in such cases, class timings and examination schedule for one programme do not overlap with the class timings and examination schedule of the other programme, and requirements under clause 7(iv) are fulfilled.
- A student can pursue two UG Programme, one in full-time physical mode and another in ODL/online mode; or up to two ODL/online programmes simultaneously.

The Department/College/Institute and the University shall not be responsible for any such overlapping and consequences thereof.

(iv) Minimum Eligibility Conditions for Admission

A candidate who has passed Senior Secondary Certificate Examination (Class XII level) of the Board of School Education, Haryana; or any other examination recognized as equivalent thereto with minimum passing marks in aggregate with English as one of the subjects, shall be eligible to join First Semester of the Undergraduate (UG) Programme.

Further, eligibility conditions for admission to a programme shall be applicable as mentioned in the scheme of the concerned programme.

A candidate having 2-Year Diploma from ITI or 3-Year Diploma from Polytechnic of minimum 2 years duration qualified with Hindi Core/English as one subject or as an additional subject at Class XII level is also eligible for seeking admission in First Semester of the UG Programme in Arts discipline or in the disciplines wherever mentioned so.

Note: Eligibility conditions are subject to change according to the implementation of National Curriculum Framework (NCrF) for school education or in accordance with any such guidelines issued by the Central/State Government or issued by University from time to time.

- (v)** A student who has been placed under compartment or allowed to re-appear in one subject only in Senior Secondary Certificate Examination (Class XII level) of the Board of School Education, Haryana; or equivalent examination of another University/Board may be allowed to study provisionally for the First Semester of the UG programme. Such student shall pass the compartment/re-appear subject before commencement of the examination of Ist semester of the concerned UG Programme. If a student does not clear the compartment/re-appear subject even before the commencement of the Ist semester examination, her/his provisional admission to concerned UG Programme shall be cancelled ab initio by the Chairperson/Principal/Director with intimation to the University. However, the Vice-Chancellor may relax this condition, in exceptional cases, oneself or on the recommendations of a committee constituted by the Vice-Chancellor.

For such students, the required percentage of marks for admission shall be determined by considering the minimum pass marks in compartment/re-appear subject.

- (vi) The student opting for exit must inform in writing to the Department/College/Institute by 30th June of every year. The student is allowed multiple entry into a UG Programme. For example, the student can re-enter into second year of a programme if she/he has taken an exit option after first year. Similarly, re-entry into the third year is allowed if exit option was exercised by a student after getting UG Diploma. In any case, the gap between the exit and the re-entry into the UG Programme should not be more than three years subject to completion of the whole UG Programme within seven years. Multiple entry shall be allowed in a Department/College/Institute subject to the availability of seats in that programme in that year in that Department/College/Institute. In case of re-entry, the scheme and syllabus currently running will be applicable.
- (vii) Lateral admissions against sanctioned vacant seats may be filled by a Department/College/Institute category wise following the State Govt. norms for reservation in an odd semester. Lateral admission may be provided in the 3rd and 5th semesters if a student has passed all the preceding examinations up to 2nd and 4th semester, respectively of the concerned programme under NEP Curriculum Framework. However, this will be subject to fulfilment of other eligibility conditions for the programme in which the admission is sought.

First preference in the lateral admission will be given to the students of that Department/College/Institute who had taken exit from that programme and are seeking re-entry into the same institution, for this a cut-of-date will be notified by Department/College/Institute.

8 Subjects/Courses of UG Programmes

- (i) A student of UG Programme (Interdisciplinary), herein after called Scheme-D, will study three courses of the discipline in each semester as prescribed in the scheme of the concerned programme.
- (ii) A student will study Discipline Specific, Minor, Minor (Vocational), AEC, VAC, SEC and MDC courses as per Curriculum Framework Scheme-D (*Appendix-I; Table 1*).
- (iii) For 1st and 2nd semester of UG Programme (Interdisciplinary) (Scheme-D), a student can choose a Minor Course of 2 credit from the pool of Minor subjects/courses offered by the Department/College/Institute in that semester or as prescribed in the scheme of the concerned programme.

From 3rd semester onwards, a Minor Course will be of 4 credits and will be taken from the pool of the offered Minor Courses of that subject taken in the first and semesters.

- (iv) A student will study three Multidisciplinary Courses (MDCs) in first three semesters. The Multidisciplinary Courses (MDCs) will be from the subject/course which is different from the Discipline Specific and Minor subjects/courses. Students are not allowed to choose or repeat courses already undergone at the Senior Secondary Level (Class XII) or Discipline Specific and Minor subjects/courses under this category. Provided further that if a Multidisciplinary Course (MDC) across the discipline cannot be offered by a Department/College/Institute, due to its constraints and available resources, then
 - A subject from the same discipline can be offered as MDC course if that subject also belongs to the list of subjects of some other discipline.
 - MDC can be opted out of MOOCs through SWAYAM.

- MDC can be completed out of online course(s) offered by GJUST.
- MDC can be completed from a cluster college i.e., from a neighbouring College/Institute or else.

Note: The student himself/herself has to pay the requisite fee and/or re-appear fee as applicable from time to time. Department/College/Institute shall not be responsible for any issue(s) related to MOOCs, online course(s) and from cluster college or else.

- (v) A student will select AEC, SEC, VAC and Minor (Vocational) courses from a pool of respective courses offered in Department/College/Institute.

Depending upon the availability of faculty and infrastructure, a Department/College/Institute may offer AEC, SEC, VAC and Minor (Vocational) courses from the respective pool of courses duly approved by the College/University. University will review and revise such pools from time to time by taking proposals of Department/College/Institute into consideration.

- (vi) A student will study VAC- 'Environmental Studies' which is mandatory and at least one SEC to gain computer competency before exit. The number of these courses will be offered by the Department/College/Institute according to the availability of faculty and infrastructure.

- (vii) In the subjects/courses which involve practicum, i.e., Practical/Laboratory/Studio/Project/ Survey/Field work, etc., a course of 4 credits will dedicate 3 credits for lectures and one credit for practicum or 4 credits for lectures. In other subjects/courses not having practicum component, a course of 4 credits will dedicate 3 credits for lectures and 1 credit for tutorial or 4 credits for lectures.

During 4th year, if the practicum course is offered as a separate course in that subject, all the credits will be dedicated to practicum.

In the case, when tutorial of 1 credit is not adopted/implemented in a subject, then all the credits of that course will be dedicated to lectures only.

- (viii) In case of AEC and VAC of 2 credits, the entire 2 credits will be allocated to lectures.
- (ix) In the SEC courses of 3 credit, 2 credit will be allocated to lectures and 1 credit to practicum/Seminar/tutorial.
- (x) In case of Minor (Vocational) courses/subjects, where practicum component is dominant, a course of 4 credits may allocate 2 credits to lectures and 2 credits to practicum. Similarly, a course of 4 credits may be divided into 2 credits of lectures and 2 credits of practicum in the subjects where the practicum component of the course is major and teaching-learning process mainly depends upon practicum, e.g. Music and Fine Arts.

9 Contact hours/workload

The weekly contact hours/workload for theory/practical/laboratory/studio/project/survey/field work, etc. components of the courses will be:

- (i) 1 credit theory/tutorial = 1 hour;
- (ii) 1 credit practical/laboratory/studio/project/survey/field work = 2 hours.
- (iii) The tutorial and practical/laboratory/studio/project/survey/field work will be conducted in groups of students and one group will comprise of 20 students.

10 Online Courses

With the permission of Department/College/Institute, a student can opt for online courses (at own level), up to 40% of the courses of the programme except Discipline Specific

Courses and Skill Enhancement courses, through online platform SWAYAM or online courses offered by GJUST, Hisar or through other such online platforms approved by the UGC as per university guidelines prevailing time to time.

11 Internship

Every student for the UG Programme shall be required to undergo 4 credits internship of minimum of 4 weeks duration before taking an exit or completing the degree programme.

- (i) A student for the UG Programme shall be required to undergo internship during summer vacation either after the second semester examination or after the fourth semester examination. If she/he opts to exit with Undergraduate Certificate in the discipline, then it shall be obligatory to complete the internship after second semester examination.

However, for those students who have taken lateral entry into the third semester and have completed internship of minimum of 4 weeks duration during first year, the internship is not required after the fourth semester examination

- (ii) A student will inform and get approval from the Chairperson/Principal/Director of the Department/College/Institute before going for an internship. The internship will involve working with local industry (Government or Private organizations/ Institutions), business establishments, artists, craft persons, or a professional (individual/organization). Student will submit a copy of the report (a hard copy and a soft copy in PDF) to the Department/College/Institute within 15 days after the completion of internship. A student must submit a certificate of attendance and work done report from the organization/professional where the internship was done. The evaluation of the internship shall be done by a committee comprising of at least two teachers appointed by the Chairperson/Principal/Director of the College/Institute. Marks will be awarded by the committee out of 100 marks on the basis of the report and viva-voce examination.
- (iii) The internship will be governed by the prevailing rules of the University from time to time.

12 Project/Dissertation

A student of fourth-year Bachelor Degree (Honours with Research) Programme will be required to work on the Research Project or do research during eighth semester. The Project/Dissertation work will be of 12 credits.

- (i) A student, who has been admitted in Honours with Research Programme, shall submit a request for allotment of a supervisor mentioning her/his research areas of interest in order of preference to the Chairperson/Principal/Director during seventh semester. The Department/College/Institute will allot a qualified supervisor to guide the student for doing research during Project/Dissertation work. A regular full-time teacher of that Department/College/Institute, who has been approved to supervise Ph.D. scholars by the university, will be eligible to guide the students of Honours with Research programme of that institution.
- (ii) The student will submit the synopsis to the supervisor. In case of University Teaching Department (UTD) the synopsis will be approved by the departmental research advisory committee after recommendation of the supervisor. In other cases, the

Principal/Director of College/Institute shall constitute a committee for this purpose at the College/Institute level. External experts may be involved wherever sufficient qualified regular teachers are not available.

- (iii) The student shall be required to submit three hard copies of her/his dissertation along with soft copy as PDF file to the Department/College/Institute by 30th June of the concerned year. The late submission can be allowed with late fees as decided by the university from time to time. The Anti-plagiarism policy of the university is to be strictly followed by the candidate and the supervisor. Similarity report as per Anti-plagiarism policy of the university is to be annexed with the dissertation.
- (iv) Evaluation of the dissertation shall be done by an external examiner. The dissertation work will be of total 12 credits (300 marks) and evaluation will be done in two components; report of dissertation (200 marks) and open viva-voce examination (100 marks)

13 Medium of Instructions and Examination

- (i) For Arts/Home Science/Commerce subjects, the medium of instructions shall be Hindi/English.
The question paper shall be set in both English and Hindi, wherever feasible, except in the case of
 - English, in which the questions shall be set in English.
 - Sanskrit, in which the questions shall be set in Sanskrit/Hindi.
 - Other languages, in which the questions shall be set in the language concerned.
- (ii) The students shall write their answers:
 - in English, in case of English language
 - in the language concerned, in the case of Modern Indian Languages
 - English/Hindi in the case of other subjects.
- (iii) For Physical Sciences/Life Sciences Subjects/Courses, the medium of instructions shall be mainly English. Hindi medium will also be offered wherever feasible and approved by the university. The question paper shall be set in English. Bilingual question paper (s) will be provided, wherever possible and approved by the university. The students can write their answers in English/Hindi depending on the medium of instructions and language of the course content/syllabus.

14 Programme and Course Learning Outcomes

Individual programmes of study will have well defined learning **Programme Outcomes (POs)** which should be attained for the award of a specific Certificate/Diploma/Degree.

Each course will have well defined learning **Course Outcomes (COs)** specific to the learning for a given course of study related to a disciplinary or interdisciplinary/multi-disciplinary area. Course Outcomes (COs) will be mapped to Programme Outcomes (POs). The attainment of Course Outcomes will lead to the attainment of the Programme Outcomes.

15 Assessment and Evaluation

(i) Student Progression and Mentoring

Each student shall be examined in the course(s) to help their progression through the programme as laid down in the scheme, syllabus and learning outcomes through a system of Continuous Comprehensive Assessment (CCA) using a mix of Internal and End-Term evaluation.

- Internal Assessment will be broadly 30% of the total marks and weightage of 70% shall be given to evaluation of End-Term examination(s).
- Internal Assessment (30%) shall be broadly based on the following defined components: Class Participation; Seminar/Presentation/Assignment/Quiz/Class Test, etc. in case of Theory examination and Seminar/Demonstration/Viva-Voce/Lab record, etc. in case of Practical examination; Mid-Term Exam.
- Internal Assessment Marks will be further distributed as per following tables:

- A student has to obtain minimum 40% marks (Grade 'P') in aggregate (sum of the Internal Assessment and End-Term Examination marks) and in End-Term Examination separately to qualify a course.
- (ii) The pass percentage will be 40% (Grade 'P') both for theory and practicum End-Term Examination.
- (iii) The Chairperson/Principal/Director shall ensure uploading of the Internal Assessment marks at least one week before the commencement of the End-Term Semester Examinations on the examination portal of the University or as notified by the Controller of Examinations of the University.
- (iv) Internal Assessment marks of a course shall be carried forward in case of re-appear examination of that course.
- (v) The Chairperson/Principal/Director shall preserve the record on the basis of which the Internal Assessment awards have been prepared, for inspection, if needed by the university, for one year from the date of declaration of semester examination results.

16 Eligibility for Examination

End-Term Examination shall be open to a regular student who

- (i) has been on the rolls of the Department/College/Institute during the semester.
- (ii) has passed the requisite qualifying examination as laid down above, if she/he is a candidate for the First Semester Examination.
- (iii) has her/his examination form submitted to the Examinations Branch through the Chairperson/Principal/Director of the concerned Department/College/Institute.
- (iv) has attended not less than 75% of the lectures in a course. This requirement shall be fulfilled separately for each course of the programme. A deficiency in the prescribed course (Lectures/Practicum, etc.) may be condoned by the Chairperson/Principal/ Director of the Department/College/Institute in deserving cases up to 15% (excluding 2% additional for Girl/Women student).
- (v) These shall also include loss of attendance due to participation in the cultural and sports assignments, etc. Provided that, a student who participates in the Inter-University Tournaments or Inter University Youth festivals or Republic Day Parade may be allowed additional condonation on this ground up to 10% in each paper on a certificate from the Dean/Director, Sports/Youth Welfare/Cultural Affairs, Placement Cell, NSS, ANO, NCC, YRC as the case may be, subject to the condition that such a student shall not be allowed to appear in the examination if his/her attendance, after condonation on all counts, falls below 50%.
- (vi) Provided that a candidate who has not attended the requisite percentage of lectures/practicum shall not be eligible to take the End-Term Examination in the concerned theory/practicum unless she/he repeats the course and obtains requisite attendance.

17 Duration for Passing the Programme

- (i) A student can complete a Bachelor degree programme within seven years. A student who fails to pass the whole examination(s) of a UG programme within seven years of admission to the programme, shall be awarded Undergraduate Certificate/Diploma on the basis of qualified courses as per credit point, if eligible (*Appendix-I; Table 2*).

- (ii) Each student will have to open an Academic Bank of Credit (ABC) account immediately for admission or during admission if admitted. At the end of each semester, credits earned by the students will be uploaded in her/his respective ABC account. A student registered in ABC account for a programme will be allowed to complete the respective programme within seven years or as per the time period stipulated in the ABC for accumulation of credits from time to time or within the period as prescribed by the university for the purpose.

18 Conditions for Promotion to Higher Semester and Rules for Re-appear

- (i) A student who has appeared and failed in one or more courses of the First Semester shall be allowed to study for and appear in the second semester. Such a student may pursue her/his studies for the next higher semester(s) and appear in the examination(s) for the same along with the examination for the lower semester(s).
- (ii) A candidate who has attended the prescribed classes of a course(s) of a programme in the Department/College/Institute in a semester and was eligible but did not appear in the End-Term examination or has appeared but fails, may be allowed on the recommendation of the Chairperson/Principal/Director of the Department/College/Institute to appear/re-appear as an ex-student in the End-Term examinations of that course(s) as the case may be, in the subsequent semesters examination up to two times when such examination(s) are held without attending the course(s) again. While re-appearing in the examination, the student shall be exempted from appearing in the course(s)/practical(s) in which she/he has obtained pass marks.

Provided that after completion of regular studies for the whole duration of a programme, the candidate will be allowed to appear in examination as an ex-student/private for the re-appear/left out courses under the permissible chances, within the prescribed time period to complete the programme.

- (iii) A candidate who could not complete or has failed in a project/internship, she/he will get only one chance to repeat the project work at the end of the next Semester. Further, if the candidate still fails or remains absent in the project/internship, then she/he will not be eligible for the award of the concerned UG Certificate/Diploma/Degree.

19 Examinations and Result

- (i) End-Term Examinations for the odd semesters shall ordinarily be held in November/December and for the even semesters in May/June, on such dates as may be notified by the Controller of Examinations from time to time.
- (ii) Supplementary examinations will be held for Re-appear candidates as under:

- (iii) The last date(s) by which the examination forms shall be uploaded on the examination portal shall be as per the schedule notified by the Controller of Examinations from time to time.

- (iv) The amount of examination fee to be paid by a student for each semester shall be as prescribed by the University from time to time.
- (v) The minimum Semester Grade Point Average (SGPA) to qualify a semester shall be 4.00 and minimum Cumulative Grade Point Average (CGPA) required for the award of the UG Certificate/Diploma/Degree shall be 4.00.
- (vi) The Examination Branch shall prepare the Grade/Result and the Controller of Examinations will notify the same.
- (vii) If a student is not able to pass any semester examination during her/his regular studies in the programme, her/his pass credits will be accumulated in the Academic Bank of Credits (ABC) and she/he can pass the deficient courses any time within seven years or as stipulated in the Academic Bank of Credits from time to time.
- (viii) A student who discontinues her/his studies at any point of time may be permitted to re-join the programme of study and complete balance credits.

(ix) Award of Grades

Award of grades and the corresponding grade points will be based on absolute marks as per the following table:

- The multiplication factor for conversion from SGPA/CGPA to equivalent percentage of marks shall be 10.
- A candidate eligible to take the examination obtaining Grade 'F'/'Ab' will be considered to have failed in the examination/course(s). Such a student will be required to re-appear in that examination/course(s) within the permissible chances.

20 Computation of SGPA and CGPA

The following shall be the procedure to compute the Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

- (i) The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a candidate in all the courses taken by the candidate in a semester to the sum of the number of credits of all the courses undertaken by the candidate in that semester, i.e.

$$SGPA (S_j) = \frac{\sum(C_i + G_i)}{\sum C_i}$$

where C_i is the number of credits of the i^{th} course and G_i is the grade point scored by the student in the i^{th} course in the j^{th} semester.

- (ii) The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme, i.e.

$$CGPA (S_j) = \frac{\sum(N_j + S_j)}{\sum N_j}$$

where S_j is the SGPA of the j^{th} semester and N_j is the total number of credits in that semester.

- (iii) The SGPA and CGPA shall be rounded off to 2 digits after decimal place and shall be reported in the Detail-Grade-Certificate (DGC).

A merit list will be prepared for a programme and Gold Medal will be awarded to a candidate securing highest CGPA provided the candidate must have passed all the semester examinations in the first attempt and within minimum duration of the programme. In case, when more than one student have the same CGPA, then Gold Medal shall be decided on the basis of actual obtained marks in the programme.

21 Improvement

- (i) A candidate who has passed a UG Programme from GJUST, Hisar and is desirous of improving her/his CGPA in the respective programme (Certificate/Diploma/Degree/Degree (Hons.)), will be allowed to appear within next four Semester examinations of passing the sixth semester examination to appear as an ex-student in one or more theory course(s) of any one or two parts, out of Part-I (Semester I & II), Part-II (Semester III & IV), Part-III (Semester V & VI) and Part IV (Semester VII & VIII) separately in four consecutive semester examinations and shall pay examination fee as for the whole semester examination in which she/he opts to appear. The rules, syllabus and fees for improvement examinations shall be applicable as prevailing at that time or as prescribed by the university from time to time.
- (ii) The result of improvement examinations shall be declared only if a candidate improves her/his CGPA of the respective programme. Provided further that if a student does not want to avail the remaining chances out of permissible four total chances for improvement, then she/he will submit an undertaking to this effect for declaration of her/his final result. The fact that student has improved the performance/grade shall be mentioned in the Detailed-Grade-Certificate (DGC).
- (iii) Improvement shall not be allowed in Internal Assessment/Practical/Internship/Field Work/Project/Seminar/Studio etc.

22 Award of Grace Marks

Grace marks will be awarded according to the university rules prevailing from time to time.

- 23 The ordinance in force at the time a student joins the programme shall hold good only for the examination held during or at the end of the academic year and nothing in this ordinance shall be deemed to debar the university from amending the ordinance and the amended ordinance, if any, shall apply to all the students whether old or new.
- 24 (i) In the event of any inconsistency in the rules or any clarification thereof, the matter shall be referred to the Vice-Chancellor for interpretation, whose decision shall be final. The Vice-Chancellor is also competent to remove any

inconsistency/make amendment in rules at any time and decide which provision shall take precedence over the other.

- (ii) The Vice-Chancellor is authorized to make changes/amendments in the ordinance of different Schemes for effective implementation of Curriculum and Credit Framework of Undergraduate and Integrated 5 years Programmes under National Education Policy 2020.
- (iii) Notwithstanding anything mentioned above, the Vice-Chancellor can relax any rule in exceptional cases or when situation demands so.

25 Transitory Provision

Students admitted to UG Programmes under semester system in Department/College/Institute prior to that academic session 2024-25 shall be governed by the old rules as applicable for that programme for that session. The present rules shall be applicable to the students who take admission in a programme according to Curriculum and Credit Framework for UG Programme (CCFUGP) as per NEP-2020 w.e.f. the academic session 2024-25.

- Discipline Specific Courses (DSC), Minor courses (MIC) including vocational (VOC), Ability Enhancement Courses (AEC); Value Added Courses (VAC); Multidisciplinary Courses (MDC), Core courses, Elective courses and Practicum Course of this programme.
- A student of UG Programme (Major) will study as per scheme of the programme.
- A student will study Discipline Specific Courses (DSC) including Core, Elective and Practicum courses from the major subject as per scheme of the programme.
- A student will study AEC, VAC, SEC, MDC and Minor (Vocational) Courses from the respective pools of the courses offered by Department/College/Institute duly approved by the University
- Minor subject will be different from the Major subject in the same discipline. Minor Course will be of 4 credits and will be taken out of the offered Core Courses of that subject (Minor subject).
- A student will opt for MDC course from the subject which is different from the discipline of major subjects and should also be different from the courses undergone at senior secondary level (Class XII).
- 4-year UG (Honours) or (Honours with Research) in Major Subject will be offered after completion of 3-Year UG programme (Single Major) to those students who have completed at least 60 credits in the concerned Major Subject. In addition to the above, 4-Year UG (Honours with Research) in Major Subject will be offered only to those students who have obtained CGPA 7.5 or more in the 3-Year UG programme.
- In addition to the defined practicum courses, the practicum courses may include seminar or other activities as recommended by the concerned Board of Studies in case of Non-Practicum subjects. The Practicum course may be replaced by a theory course wherever Board of Studies decides so.



PROCEEDINGS OF THE MEETING OF THE COMMITTEE CONSTITUTED BY THE VICE-CHANCELLOR HELD ON 27.06.2024 AT 10:00 AM IN THE COMMITTEE ROOM OF VICE-CHANCELLOR'S OFFICE TO DECIDE ALL ISSUES RELATED TO IMPLEMENTATION OF NEP-2020 IN AFFILIATED COLLEGES

Above said Committee was constituted by the Vice-Chancellor to decide various issues of affiliated degree colleges related to implementation of NEP-2020. The Dean Academic Affairs has given a detailed presentation on various aspects of NEP-2020. After presentation and detailed discussion, the Committee recommends the following:

- i). The draft ordinance of the undergraduate programmes under Scheme 'A' has been discussed and finalized. On the similar pattern, the ordinances under Scheme 'B', Scheme 'C' and Scheme 'D' have also been prepared and finalized accordingly.
- ii). The Committee recommends that the combination of subjects for Discipline Specific Courses (DSC) for Bachelor of Arts, Bachelor of Physical Sciences, Bachelor of Life-Science and other disciplinary programmes under NEP-2020 for affiliated degree colleges of GJUST, Hisar for the academic session 2024-25 has already been conveyed to Director General, Higher Education Haryana vide letter dated 24.05.2024 be followed while preparing the Scheme and Syllabi.
- iii). The pool of Minor Courses (MIC), Multi Disciplinary Course (MDC), Skill Enhancement Courses (SEC), Ability Enhancement Courses (AEC) and Value Added Courses (VAC) have been discussed and finalized.

- iv) The Committee considered the pool of Minor Courses, which were already submitted to the Director General, Higher Education vide letter dated 31.05.2024 have been reconsidered on the recommendation of affiliated colleges and recommends that the Language Course (English and Hindi) are not to be made compulsory under Minor Courses (MIC).
- v) The Scheme of Examinations and Coding pattern for affiliated colleges has been discussed and finalized.
- vi) The scheme of examinations and syllabi of all the undergraduate programmes being run by the affiliated degree colleges will be prepared by the respective Chairperson/ Dean of the Faculty concerned on top priority basis as per the framework and various type of schemes applicable and conveyed by the UGC and State Government, regarding implementation of NEP-2020. Further, the framework of various Schemes i.e. Scheme 'A', 'B', 'C' and 'D', ordinances/ guidelines/ instructions regarding NEP-2020 issued by the Dean Academic Affairs/ Dean of Colleges/ Academic Branch may also be followed while preparing the scheme of examinations and syllabi of all undergraduate programmes for the session 2024-25 under NEP-2020. Special attention is required while preparing the scheme of examinations and syllabi for the session 2024-25 in a time-bound manner, as the classes are to be started very soon.
- vii) The Committee recommends that the formation of class section i.e. strength of students, if conveyed by the Director Higher Education, the same will be followed. If Director, Higher Education has not conveyed any instructions/ guidelines in this regard, then the strength of students be considered as upto 60 for formation of a section in case of theory subjects.
- viii) The guidelines of Director Higher Education, for creation of Group for practical subject be followed. If no guidelines have been received from Director Higher Education in this regard, then strength of 20 students is required to create a group of practical subject.
- ix) To resolve the issue of Mathematics subject as part of Eligibility of BCA programme, a separate Committee may be constituted to revise the eligibility criteria from the next academic session i.e. 2025-26.

Ordinance governing UG Programme (Multidisciplinary) for affiliated degree College
as per National Education Policy-2020

SCHEME-A

(UG Certificate, UG Diploma and Bachelor Degree)

SEMESTER SYSTEM

**Under Learning Outcome Based Curriculum Framework-Choice Based Credit System
(LOCF-CBCS) as per NEP-2020
(w.e.f. Session 2024-25)**

1. Scope

This Ordinance is based on National Education Policy-2020 (NEP-2020), Learning Outcome Based Curriculum Framework-Choice Based Credit System (LOCF-CBCS) and is according to the Curriculum and Credit Framework for UG Programmes (CCFUGP) of University Grants Commission and as per Memo No. DHE-170005/5/2023-Deputy Director-NPE dated June 8, 2023 regarding implementation of the key components of NEP-2020 in Colleges and Universities.

- (i) The duration of the programme for the award of Undergraduate Certificate in Discipline will be one academic year and of Undergraduate Diploma in Discipline will be two academic years. The duration of Bachelor Degree in discipline will be three academic years. Each academic year will be divided into two semesters i.e., July to December and January to June. There shall be teaching of 15 weeks/90 days in each semester excluding admission and examination days.
- (ii) The nomenclature of the Certificate/Diploma/Degree will be as under:
 - (a) UG Certificate in Arts or UG Certificate in Physical Sciences or UG Certificate in Life Sciences
 - (b) UG Diploma in Arts or UG Diploma in Physical Sciences or UG Diploma in Life Sciences
 - (c) Bachelor of Arts or Bachelor of Science (Physical Sciences) or Bachelor of Science (Life Sciences)

2. Key Terms

- (i) **Learning Outcome based Curriculum Framework (LOCF):** The learning outcomes of the programme (POs) are mapped against well-defined Course Outcomes (COs).
- (ii) **Choice Based Credit System (CBCS):** The CBCS provides choices to students to select disciplinary and interdisciplinary courses to fit into their own requirements and to learn at their own pace within the framework.
- (iii) **Programme:** A programme is made up of courses/subjects and leads to the award of a Certificate or Diploma or Degree after completing requisite courses successfully.
- (iv) **Course/Subject:** A course/subject refers to component of a programme. A course/subject may comprise of lectures/tutorials/practicum or laboratory work/field practice/project work/seminar/community engagement and service/internship/dissertation, etc. or any combination of these.

- (v) **Credit:** A unit by which the course work is measured. It determines the number of hours of instructions required per week over the duration of one semester. For calculation of the teaching hours, one credit means one hour of lecture or one hour of tutorial or one hour of seminar or two hours of practicum/laboratory work per week over the duration of a semester.
- (vi) **Lecture:** Component of a course/subject which is taught by a teacher through lectures covering the contents of a course/subject.
- (vii) **Tutorial:** Component of a course/subject which involves problem-solving, learning through discussions and remedial teaching related to the contents and periphery of a course/subject with the direct involvement of a teacher.
- (viii) **Practicum:** A course/subject or a component of a course/subject which enables students to learn or to attain skills or to get procedural knowledge for the contents of a course/subject through practical/laboratory activity/project and to apply the studied principles/theory/ concepts related to the chosen field of learning, work/vocation, or professional practice in the field of learning, work/vocation under the supervision of a teacher.
- (ix) **Seminar:** A course/subject or a component of a course/subject which makes students to learn a specific topic through in-depth exploration and analysis of facts about the topic in a set-up that involves presentation, interactive discussions and collaborative learning under the supervision of a teacher.
- (x) **Internship:** A course/subject requiring students to participate in professional employment-related activity or work experience or co-operative education activity with an entity external to the educational institution normally under the supervision of an employee of an organization or an individual professional. A key aspect of the internship is induction into actual, formal and organized work situations. Internship involves working with local industry (Government or Private organizations), business establishments, artists, craft persons, etc. to provide opportunities for students to actively engage in on-site experiential learning.
- (xi) **Studio Activity:** A studio activity involves engagement of students in creative, artistic or experimental activities involving visual, digital, audio, video and other professional experiential work.
- (xii) **Field Work/Practice/Survey/Project:** A course/subject or a component of course/subject which enables students to participate in field-based learning/project, involving application of knowledge in solving/analyzing/exploring a real-life situation/difficult problem under the supervision of a teacher/mentor.
- (xiii) **Project Work:** A course/subject or a component of a course/subject which facilitates students to apply their knowledge, skills and critical thinking ability to complete a specific task in a given time frame through conceptualization, exploration and analysis of research-based activities to suggest tangible solutions for a given problem related to the chosen field of learning.
- (xiv) **Community Engagement and Service:** A course/subject or a component of a course/subject which exposes the students to the socio-economic issues prevailing in society so that the theoretical learning can be supplemented by actual life experiences to understand and generate solutions to real-life problems.

3 Courses

- (i) **Discipline Specific Courses (DSC):** A major course/subject as discipline specific course is the field in which a student focuses for understanding and skills majorly in the chosen field of learning contributing to the core of the programme. This may include Core, Elective and Skill-enhancement courses.
- (ii) **Minor Courses (MIC):** Minor course/subject aims to expand student's knowledge beyond the major field of study. This will also include **Vocational Course (VOC)**

that will assist student in developing work-force relevant skills through practical work and enhances the employability of student.

- (iii) **Multidisciplinary Courses (MDC):** These courses are based on introductory knowledge in a subject. A student will study MDC in a subject other than the discipline of Discipline Specific and Minor subjects/courses to gain knowledge across the disciplines.
- (iv) **Ability Enhancement Courses (AEC):** These courses aim at enabling the students to achieve competency in the English language or Modern Indian Languages (MIL) with special emphasis on language and communication skills.
- (v) **Skill Enhancement Courses (SEC):** These courses aim at imparting practical skills, hands-on training, soft skills, etc. to enhance the employability of students.
- (vi) **Value-Added Courses (VAC):** These courses aim at enabling the students to acquire and demonstrate the acquisition of knowledge and understanding of human values, Indian Knowledge System (IKS), contemporary India, environmental science and education, digital and technical solutions, health and wellness, yoga education, sports and fitness, etc.

4 Evaluation terms

- (i) **Letter Grade:** It is an index of the performance of a student in a course. Grades are denoted by letters O, A+, A, B+, B, C, P, F and Ab depending on the score earned in that course.
- (ii) **Grade Point:** It is a numerical value allotted to each letter grade on a 10-point scale.
- (iii) **Credit Point:** It is the product of grade point and number of credits for a course.
- (iv) **Semester Grade Point Average (SGPA):** It is a measure of performance of a student in a semester. It is the ratio of total credit points secured by a student in all the courses registered in a semester to the total of the credits of the courses taken during that semester. It shall be expressed up to two digits after decimal place.
- (v) **Cumulative Grade Point Average (CGPA):** It is a measure of overall cumulative performance of a student in a programme over all the semesters. The CGPA is the ratio of total credit points secured by a student in all the courses of the programme to the sum of the total credits of all the courses of the programme. It shall be expressed up to two digits after decimal place.
- (vi) **Detailed-Grade-Certificate:** Based on the grades earned, a grade certificate shall be issued to all the registered students after every semester. The Detailed-Grade-Certificate (DGC) will display the course details (code, title, number of credits, grade secured) along with SGPA of that semester.

5 **Academic Bank of Credits (ABC):** It is a virtual/digital mechanism that contains information of the credits earned by individual students throughout their learning journey in Higher Education Institutions in India recognized by UGC. The Automated Permanent Academic Account Registry (APAAR) ID is also being introduced as a pivotal component. The APAAR ID serves as a lifelong academic passport, consolidating all achievements and credential of a student in one place. This will help enabling students mobility across higher education institution.

6 Programme Duration and Multiple Exit Options

All programmes shall be offered as per UGC list of 'Specification of Degree' prevailing from time to time. The programme duration and options for multiple entry and exit will be as per UG Curriculum Framework- Scheme-A (*Appendix-I; Table-I*).

- (i) A student will be allowed an exit option after passing first academic year of the UG Programme with requisite 52 credits including the 4 credits of internship of

minimum of 4 weeks duration as per scheme of the programme and will be awarded an **Undergraduate Certificate in the discipline** (Arts/Physical Sciences/Life Sciences/etc.) (*Appendix-I; Table-2*).

- (ii) A student will be allowed an exit option after passing two academic years of the UG Programme with requisite 96 credits including the 4 credits of internship of minimum of 4 weeks duration as per scheme of the programme and will be awarded **Undergraduate Diploma in the discipline** (Arts/Physical Sciences/Life Sciences/etc.) (*Appendix-I; Table-2*).
- (iii) A student will be awarded with **Bachelor degree in the discipline** (Arts/Physical Sciences/Life Sciences/etc.) after successfully completing three academic years of UG Programme and earning requisite 132 credits including the 4 credits of internship of minimum of 4 weeks duration as per scheme of the programme (*Appendix-I; Table-2*).

7 Admission to a UG Programme under Multiple Entry

- (i) The Department/College/Institute shall declare approved total number of seats available discipline-wise each year for fresh and lateral admissions.
- (ii) The Department/College/Institute can plan the number of seats discipline-wise in consonance with the faculty and infrastructure available.
- (iii) A student can pursue two Undergraduate Programme simultaneously through Open and Distance Learning (ODL)/online mode; or combinations of ODL, online and regular modes, from the same or different Universities/Institutions duly approved by the UGC/AICTE/Regulatory Body/Central Government/State Government, in various combinations, viz.

- A student can pursue two full-time UG Programme in physical mode provided that in such cases, class timings and examination schedule for one programme do not overlap with the class timings and examination schedule of the other programme, and requirements under clause 7(iv) are fulfilled. The Department/College/Institute and the University shall not be responsible for any such overlapping and consequences thereof.
- A student can pursue two UG Programme, one in full-time physical mode and another in ODL/online mode; or up to two ODL/online programmes simultaneously.

(iv) Minimum Eligibility Conditions for Admission

A candidate who has passed Senior Secondary Certificate Examination (Class XII level) of the Board of School Education, Haryana; or any other examination recognized as equivalent thereto with minimum passing marks in aggregate with English as one of the subjects, shall be eligible to join First Semester of the Undergraduate (UG) Programme. In addition, the following conditions, if applicable should also be satisfied:

- to opt for Mathematics as a DSC, the candidate must have passed Mathematics as a subject in the qualifying examination.
- to opt for Chemistry as a DSC, the candidate must have passed Chemistry as a subject in the qualifying examination.
- to opt for Physics as a DSC, the candidate must have passed Physics as a subject in the qualifying examination.
- to opt for subject(s) in the discipline of Life Sciences, which consists of Botany, Zoology as a one or more than one subject(s), then the candidate must have passed Class XII with Biology as a subject.
- to opt for subjects of Physical Sciences discipline as Major subject(s), the candidate must have passed respective subjects in the qualifying examination.

Further, eligibility conditions for admission to a programme shall be applicable as mentioned in the scheme of the concerned programme.

A candidate having 2-Year Diploma from ITI or 3-Year Diploma from Polytechnic of minimum 2 years duration qualified with Hindi Core/English as one subject or as an additional subject at Class XII level is also eligible for seeking admission in First Semester of the UG Programme in Arts discipline or in the disciplines wherever mentioned so.

Note: Eligibility conditions are subject to change according to the implementation of National Curriculum Framework (NCrF) for school education or in accordance with any such guidelines issued by the Central/State Government or issued by University from time to time.

- (v) A student who has been placed under compartment or allowed to re-appear in one subject only in Senior Secondary Certificate Examination (Class XII level) of the Board of School Education, Haryana, or equivalent examination of another University/Board may be allowed to study provisionally for the First Semester of the UG programme. Such student shall pass the compartment/re-appear subject before commencement of the examination of 1st semester of the concerned UG Programme. If a student does not clear the compartment/re-appear subject before the commencement of the 1st semester examination, her/his provisional admission to concerned UG Programme shall be cancelled ab initio by the Chairperson/Principal/Director with intimation to the University. However, the Vice-Chancellor may relax this condition, in exceptional cases at own level or on the recommendations of a committee constituted by the Vice-Chancellor.

For such students, the required percentage of marks for admission shall be determined by considering the minimum pass marks in compartment/re-appear subject.

- (vi) The student opting for exit must inform in writing to the Department/College/Institute by 30th June of every year. The student is allowed multiple entry into a UG Programme. For example, the student can re-enter into second year of a programme if she/he has taken an exit option after first year. Similarly, re-entry into the third year is allowed if exit option was exercised by a student after getting UG Diploma. In any case, the gap between the exit and the re-entry into the UG Programme should not be more than three years subject to completion of the whole UG Programme within six years. Multiple entry shall be allowed in a Department/College/Institute subject to the availability of seats in the concerned programme in that year in that Department/College/Institute. In case of re-entry, the scheme and syllabus currently running will be applicable.
- (vii) Lateral admissions against sanctioned vacant seats may be filled by a Department/College/Institute category wise following the State Govt. norms for reservation in an odd semester. Lateral admission may be provided in the 3rd and 5th semesters if a student has passed all the preceding examinations up to 2nd and 4th semester, respectively of the concerned programme under NEP Curriculum Framework. However, this will be subject to fulfilment of other eligibility conditions for the programme in which the admission is sought.

First preference in the lateral admission will be given to the students of that Department/College/Institute who had taken exit from that programme and are seeking re-entry into the same institution, for this a cut-of-date will be notified by Department/College/Institute.

8 Subjects/Courses of UG Programmes

- (i) A student of UG Programme (Multidisciplinary), herein after called Scheme-A, will select three subjects/courses A, B and C in the first year out of the pool of subjects in that discipline offered by the Department/College/Institute as Discipline Specific Subjects/Courses. Minor subject/course is to be offered preferably from the same discipline and will be different from three subjects/courses which are opted as Discipline Specific Subjects/Courses. Any subject/course in a discipline can be a Discipline Specific or Minor subject/course for a UG programme. In case of Physical Sciences and Life Sciences disciplines, if the Minor Subject/course cannot be offered from the same discipline by a Department/College/Institute, then the Discipline Specific Subject/course may be offered from either of the two disciplines. For example, if a Department/College/Institute is unable to offer a Minor subject/course from the discipline of Life Sciences, other than three subjects Botany, Zoology and Chemistry which have been offered as three Major subjects/courses, then Department/College/Institute can offer any subject/course from the discipline of Physical Sciences as a Minor Subject.
- (ii) A student will study Discipline Specific, Minor, Minor (Vocational), AEC, VAC, SEC and MDC courses as per Curriculum Framework Scheme-A (*Appendix-I; Table 1*).
- (iii) For 1st and 2nd semester of UG Programme (Multidisciplinary) (Scheme-A), a student can choose a Minor Course of 2 credit from the pool of Minor subjects/courses from that discipline as offered by the Department/College/Institute in that semester. The same minor subject be studied in subsequent semesters.

From 3rd semester onwards, a Minor Course will be of 4 credits and will be taken from the pool of the offered Minor Courses of that subject which was chosen in the first and second semesters.

- (iv) A student will study three Multidisciplinary Courses (MDCs) in first three semesters. The Multidisciplinary Courses (MDCs) will be from the subject/course which is different from the Discipline Specific and Minor subjects/courses. Students are not allowed to choose or repeat courses already undergone at the Senior Secondary Level (Class XII) or Discipline Specific and Minor subjects/courses under this category. Provided further that if a Multidisciplinary Course (MDC) across the discipline cannot be offered by a Department/College/Institute, due to its constraints and available resources, then

- A subject from the same discipline can be offered as MDC course if that subject also belongs to the list of subjects of some other discipline.
- MDC can be opted out of MOOCs through SWAYAM.
- MDC can be completed out of online course(s) offered by GJUST.
- MDC can be completed from a cluster college i.e., from a neighbouring College/Institute or else.

Note: The student himself/herself has to pay the requisite fee and/or re-appear fee as applicable from time to time. Department/College/Institute shall not be responsible for any issue(s) related to MOOCs, online course(s) and from cluster college or else.

- (v) A student will select AEC, SEC, VAC and Minor (Vocational) courses from a pool of respective courses offered in Department/College/Institute.

Depending upon the availability of faculty and infrastructure, a Department/College/Institute may offer AEC, SEC, VAC and Minor (Vocational) courses from the respective pool of courses duly approved by the College/University. University will review and revise such pools from time to time by taking proposals of Department/College/Institute into consideration.

- (vi) A student will study VAC- 'Environmental Studies' which is mandatory and at least one SEC to gain computer competency before exit. The number of these courses will be offered by the Department/College/Institute according to the availability of faculty and infrastructure.
- (vii) In the subjects/courses which involve practicum, i.e., Practical/Laboratory/Studio/Project/ Survey/Field work, etc., a course of 4 credits will dedicate 3 credits for lectures and one credit for practicum or 4 credits for lectures. In other subjects/courses not having practicum component, a course of 4 credits will dedicate 3 credits for lectures and 1 credit for tutorial or 4 credits for lectures.

In extreme case, if the practicum course is offered as a separate course in that subject, all the credits will be dedicated to practicum.

In the case, when tutorial of 1 credit is not adopted/implemented in a subject, then all the credits of that course will be dedicated to lectures only.

- (viii) In case of AEC and VAC of 2 credits, the entire 2 credits will be allocated to lectures.
- (ix) In the SEC courses of 3 credit, 2 credit will be allocated to lectures and 1 credit to practicum/Seminar/tutorial.
- (x) In case of Minor (Vocational) courses/subjects, where practicum component is dominant, a course of 4 credits may allocate 2 credits to lectures and 2 credits to practicum. Similarly, a course of 4 credits may be divided into 2 credits of lectures and 2 credits of practicum in the subjects where the practicum component of the course is major and teaching-learning process mainly depends upon practicum, e.g. Music and Fine/Commercial Arts.

9 Contact hours/workload

The weekly contact hours/workload for theory/practical/laboratory/studio/project/survey/field work, etc. components of the courses will be:

- (i) 1 credit theory/tutorial = 1 hour;
- (ii) 1 credit practical/laboratory/studio/project/survey/field work = 2 hours.
- (iii) The tutorial and practical/laboratory/studio/project/survey/field work will be conducted in groups of students and one group will comprise of 20 students.

10 Exit option

When a student decides to continue for the second year and does not opt exit option after the second semester then she/he will select one of the following options before the beginning of 3rd semester.

- (i) Continue with Scheme-A or
- (ii) Shift to UG Programme with Single Major Subject/Course (Scheme-B).
- (iii) In the case when a student opts for second option i.e., Scheme-B, then the ordinance of Scheme-B shall be applicable from third semester onwards.

In the case when a student opts for UG programme with single major (Scheme-B), then she/he has to select the single major out of the three major subjects undertaken in first and second semester.

11 Online Courses

With the permission of Department/College/Institute, a student can opt for online courses (at own level), up to 40% of the courses of the programme except Discipline Specific Courses and Skill Enhancement courses, through online platform SWAYAM or online courses offered by GJUST, Hisar or through other such online platforms approved by the UGC as per university guidelines prevailing time to time.

12 Internship

Every student for the UG Programme shall be required to undergo 4 credits internship of minimum of 4 weeks duration before taking an exit or completing the degree programme.

- (i) A student for the UG Programme shall be required to undergo internship during summer vacation either after the second semester examination or after the fourth semester examination. If she/he opts to exit with Undergraduate Certificate in the discipline, then it shall be obligatory to complete the internship after second semester examination.

However, for those students who have taken lateral entry into the third semester and have completed internship of minimum of 4 weeks duration during first year, the internship is not required after the fourth semester examination

- (ii) A student will inform and get approval from the Chairperson/Principal/Director of the Department/College/Institute before going for an internship. The internship will involve working with local industry (Government or Private organizations/ Institutions), business establishments, artists, craft persons, or a professional (individual/organization). Student will submit a copy of the report (a hard copy and a soft copy in PDF) to the Department/College/Institute within 15 days after the completion of internship. A student must submit a certificate of attendance and work done report from the organization/professional where the internship was done. The evaluation of the internship shall be done by a committee comprising of at least two senior teachers appointed by the Principal/Director of the College/Institute. Marks will be awarded by the committee out of 100 marks on the basis of the report and viva-voce examination.
- (iii) The internship will be governed by the prevailing rules of the University from time to time.

13 Medium of Instructions and Examination

- (i) For Arts/Home Science/Commerce subjects, the medium of instructions shall be Hindi/English.
The question paper shall be set in both English and Hindi, wherever feasible, except in the case of
 - English, in which the questions shall be set in English.
 - Sanskrit, in which the questions shall be set in Sanskrit/Hindi.
 - Other languages, in which the questions shall be set in the language concerned.

(ii) The students shall write their answers:

- in English, in case of English language
- in the language concerned, in the case of Modern Indian Languages
- English/Hindi in the case of other subjects.

(iii) For Physical Sciences/Life Sciences Subjects/Courses, the medium of instructions shall be mainly English. Hindi medium will also be offered wherever feasible and approved by the university. The question paper shall be set in English. Bilingual question paper (s) will be provided, wherever possible and approved by the university. The students can write their answers in English/Hindi depending on the medium of instructions and language of the course content/syllabus.

14 Programme and Course Learning Outcomes

Individual programmes of study will have well defined learning **Programme Outcomes (POs)** which should be attained for the award of a specific Certificate/Diploma/Degree.

Each course will have well defined learning **Course Outcomes (COs)** specific to the learning for a given course of study related to a disciplinary or interdisciplinary/multi-disciplinary area. Course Outcomes (COs) will be mapped to Programme Outcomes (POs). The attainment of Course Outcomes will lead to the attainment of the Programme Outcomes.

15 Assessment and Evaluation

(i) Student Progression and Mentoring

Each student shall be examined in the course(s) to help their progression through the programme as laid down in the scheme, syllabus and learning outcomes through a system of Continuous Comprehensive Assessment (CCA) using a mix of Internal and End-Term evaluation.

- Internal Assessment will be broadly 30% of the total marks and weightage of 70% shall be given to evaluation of End-Term examination(s).
- Internal Assessment (30%) shall be broadly based on the following defined components: Class Participation; Seminar/Presentation/Assignment/Quiz/Class Test, etc. in case of Theory examination and Seminar/Demonstration/Viva-Voce/Lab record, etc. in case of Practical examination; Mid-Term Exam.
- Internal Assessment Marks will be further distributed as per following tables:

- A student has to obtain minimum 40% marks (Grade 'P') in aggregate (sum of the Internal Assessment and End-Term Examination marks) and in End-Term Examination separately to qualify a course.
- (ii) The pass percentage will be 40% (Grade 'P') both for theory and practicum End-Term Examination.
- (iii) The Chairperson/Principal/Director shall ensure uploading of the Internal Assessment marks before the commencement of the End-Term Semester Examinations on the examination portal of the University or as notified by the Controller of Examinations of the University.
- (iv) Internal Assessment marks of a course shall be carried forward in case of re-appear examination of that course.
- (v) The Chairperson/Principal/Director shall preserve the record on the basis of which the Internal Assessment awards have been prepared, for inspection, if needed by the university for one year from the date of declaration of semester examination results.

✓ 16 Eligibility for Examination

End-Term Examination shall be open to a regular student who

- (i) has been on the rolls of the Department/College/Institute during the semester.
- (ii) has passed the requisite qualifying examination as laid down above, if she/he is a candidate for the First Semester Examination.

- (iii) has her/his examination form submitted to the Examinations Branch through the Chairperson/Principal/Director of the concerned Department/College/Institute.
- (iv) has attended not less than 75% of the lectures in a course. "This requirement shall be fulfilled separately for each course of the programme. A deficiency in the prescribed course (Lectures/Practicum, etc.) may be condoned by the Chairperson/Principal/ Director of the Department/College/Institute in deserving cases up to 15% (excluding 2% additional for Girl/Women student).
- (v) These shall also include loss of attendance due to participation in the cultural and sports assignments, etc. Provided that, a student who participates in the Inter-University Tournaments or Inter University Youth festivals or Republic Day Parade may be allowed additional condonation on this ground up to 10% in each paper on a certificate from the Dean/Director, Sports/Youth Welfare/Cultural Affairs, Placement Cell, NSS, ANO, NCC, YRC as the case may be, subject to the condition that such a student shall not be allowed to appear in the examination if his/her attendance, after condonation on all counts, falls below 50%.
- (vi) Provided that a candidate who has not attended the requisite percentage of lectures/practicum shall not be eligible to take the End-Term Examination in the concerned theory/practicum unless she/he repeats the course and obtains requisite attendance.

17 Duration for Passing the Programme

- (i) A student can complete a Bachelor degree programme within six years. A student who fails to pass the whole examination(s) of a UG programme within six years of admission to the programme, shall be awarded Undergraduate Certificate/Diploma on the basis of qualified courses as per credit point, if eligible (*Appendix-I; Table 2*).
- (ii) Each student will have to open an Academic Bank of Credit (ABC) account immediately for admission or during admission if admitted. At the end of each semester, credits earned by the students will be uploaded in her/his respective ABC account. A student registered in ABC account for a programme will be allowed to complete the respective programme within six years or as per the time period stipulated in the ABC for accumulation of credits from time to time or within the period as prescribed by the university for the purpose.

18 Conditions for Promotion to Higher Semester and Rules for Re-appear

- (i) A student who has appeared and failed in one or more courses of the First Semester shall be allowed to study for and appear in the second semester. Such a student may pursue her/his studies for the next higher semester(s) and appear in the examination(s) for the same along with the examination for the lower semester(s).
- (ii) A candidate who has attended the prescribed classes of a course(s) of a programme in the Department/College/Institute in a semester and was eligible but did not appear in the End-Term examination or has appeared but fails, may be allowed on the recommendation of the Chairperson/Principal/Director of the Department/College/Institute to appear/re-appear as an ex-student in the End-Term examinations of that course(s) as the case may be, in the subsequent semesters examination up to two times when such examination(s) are held without attending the course(s) again. While re-appearing in the examination, the

student shall be exempted from appearing in the course(s)/practical(s) in which she/he has obtained passing marks.

Provided that after completion of regular studies for the whole duration of a programme, the candidate will be allowed to appear in examination as an ex-student/private for the re-appear/left out courses under the permissible chances, within the prescribed time period to complete the programme.

- (iii) A candidate who could not complete or has failed in a project/internship, she/he will get only one chance to repeat the project work at the end of the next Semester. Further, if the candidate still fails or remains absent in the project/internship, then she/he will not be eligible for the award of the concerned UG Certificate/Diploma/Degree.

19 Examinations and Result

- (i) End-Term Examinations for the odd semesters shall normally be held in November/December and for the even semesters in May/June, on such dates as may be notified by the Controller of Examinations from time to time.
- (ii) Supplementary examinations will be held for Re-appear candidates as under:

Even Semester	Along with the Second, Fourth and Sixth Semester

- (iii) The last date(s) by which the examination forms shall be uploaded on the examination portal shall be as per the schedule notified by the Controller of Examinations from time to time.
- (iv) The amount of examination fee to be paid by a student for each semester shall be as prescribed by the University from time to time.
- (v) The minimum Semester Grade Point Average (SGPA) to qualify a semester shall be 4.00 and minimum Cumulative Grade Point Average (CGPA) required for the award of the UG Certificate/Diploma/Degree shall be 4.00.
- (vi) The Examination Branch shall prepare the Grade/Result and the Controller of Examinations will notify the same.
- (vii) If a student is not able to pass any semester examination during her/his regular studies in the programme, her/his pass credits will be accumulated in the Academic Bank of Credits (ABC) and she/he can pass the deficient courses any time within six years or as stipulated in the Academic Bank of Credits from time to time.
- (viii) A student who discontinues her/his studies at any point of time may be permitted to re-join the programme of study and complete balance credits as per university rules.

(ix) **Award of Grades**

Award of grades and the corresponding grade points will be based on absolute marks as per the following table:

- The multiplication factor for conversion from SGPA/CGPA to equivalent percentage of marks shall be 10.
- A candidate eligible to take the examination obtaining Grade 'F'/'Ab' will be considered to have failed in the examination/course(s). Such a student will be required to re-appear in that examination/course(s) within the permissible chances.

20 Computation of SGPA and CGPA

The following shall be the procedure to compute the Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

- (i) The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a candidate in all the courses taken by the candidate in a semester to the sum of the number of credits of all the courses undertaken by the candidate in that semester, i.e.

$$SGPA (S_j) = \frac{\sum(C_i + G_i)}{\sum C_i}$$

where C_i is the number of credits of the i^{th} course and G_i is the grade point scored by the student in the i^{th} course in the j^{th} semester.

- (ii) The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme, i.e.

$$CGPA (S_j) = \frac{\sum(N_j + S_j)}{\sum N_j}$$

where S_j is the SGPA of the j^{th} semester and N_j is the total number of credits in that semester.

- (iii) The SGPA and CGPA shall be rounded off to 2 digits after decimal place and shall be reported in the Detail-Grade-Certificate (DGC).

A merit list will be prepared for a programme and Gold Medal will be awarded to a candidate securing highest CGPA provided the candidate must have passed all the semester examinations in the first attempt and within minimum duration of the programme. In case,

when more than one student have the same CGPA, then Gold Medal shall be decided on the basis of actual obtained marks in the programme.

21 Improvement

- (i) A candidate who has passed a UG Programme from GJUST, Hisar and is desirous of improving her/his CGPA in the respective programme (Certificate/Diploma/Degree), will be allowed to appear within next four Semester examinations of passing the sixth semester examination to appear as an ex-student in one or more theory course(s) of any one or two parts, out of Part-I (Semester I & II), Part-II (Semester III & IV) and Part-III (Semester V & VI) separately in four consecutive semester examinations and shall pay examination fee as for the whole semester examination in which she/he opts to appear.
- (ii) The result of improvement examinations shall be declared only if a candidate improves her/his CGPA of the respective programme. Provided further that if a student does not want to avail the remaining chances out of permissible four total chances for improvement, then she/he will submit an undertaking to this effect for declaration of her/his final result. The fact that student has improved the performance/grade shall be mentioned in the Detailed-Grade-Certificate (DGC).
- (iii) Improvement shall not be allowed in Internal Assessment/Practical/Internship/Field Work/Project/Seminar/Studio etc.

The rules, syllabus and fees for improvement examinations shall be applicable as prevailing at that time or as prescribed by the university from time to time.

22 Award of Grace Marks

Grace marks will be awarded according to the university rules prevailing from time to time.

- 23** The ordinance in force at the time a student joins the programme shall hold good only for the examination held during or at the end of the academic year and nothing in this ordinance shall be deemed to debar the university from amending the ordinance and the amended ordinance, if any, shall apply to all the students whether old or new.

- 24**
- (i) In the event of any inconsistency in the rules or any clarification thereof, the matter shall be referred to the Vice-Chancellor for interpretation, whose decision shall be final. The Vice-Chancellor is also competent to remove any inconsistency/make amendment in rules at any time and decide which provision shall take precedence over the other.
 - (ii) The Vice-Chancellor is authorized to make changes/amendments in the ordinance of different Schemes for effective implementation of Curriculum and Credit Framework of Undergraduate and Integrated 5 years Programmes under National Education Policy 2020.
 - (iii) Notwithstanding anything mentioned above, the Vice-Chancellor can relax any rule in exceptional cases or when situation demands so

25 Transitory Provision

Students admitted to UG Programmes under semester system in Department/College/Institute prior to the academic session 2024-25 shall be governed by the old rules as applicable for that programme for that session. The present rules shall be applicable to the students who take admission in a programme according to Curriculum and Credit Framework for UG Programme (CCFUGP) as per NEP-2020 w.e.f. the academic session 2024-25.

- A student of UG Programme (Multidisciplinary) will select three subjects A, B and C in the first year out of the pool of subjects in that discipline offered by the Department/College/Institute as Discipline Specific Course. Minor course can be offered from the same discipline and is different from three subjects opted as Major Subjects of that discipline. In case of Physical Sciences and Life Sciences disciplines, if the Minor Subject/Course cannot be offered from the same discipline by the Department/College/Institute, then the Minor Subject/Course can be offered from either of these two disciplines e.g. if a Department/College/Institute is unable to offer a Minor subject/course from the discipline of Life Sciences, other than three subjects Botany, Zoology and Chemistry which have been offered as three Major subjects, then Department/College/Institute can offer any subject from the discipline of Physical Sciences as a Minor Subject.

- For 1st and 2nd semester of UG Programme (Multidisciplinary), a student can choose a Minor course of 2 credit from the pool of Minor courses offered by the Department/College/Institute in that semester.
- From 3rd semester onwards, a Minor course will be of 4 credits and will be taken out of the offered Minor courses of a subject offered by Department/College/Institute in that semester.
- A student will opt for MDC from the course/subject which is different from the discipline of major subjects and should also be different from the courses undergone at senior secondary level (Class XII).
