

Prof. Narsi Ram Bishnoi, Vice-Chancellor also welcomed new members Prof. J.P. Yadav, Prof. S.C. Jain, Prof. Kamal Dutt Sharma, Prof. Narender Sheoran, Prof. Yogesh Chaba, Prof. Sujata Sanghi Dean, Prof. N.K. Bishnoi, Dean, Prof. Asha Gupta, Prof. Alka Sharma, Mrs. Suman Dahiya, Dr. (Mrs.) Sangeeta, Dr. Vijender Pal Saini, Dr. Kamlesh Duhan and Dr. Vivek Kumar Saini and also extended a vote of thanks and appreciation to outgoing members namely Prof. Dinesh Kumar, Prof. Vijay Kumar Kayat, Prof. Pawan Sharma, Prof. Devinder Singh, Prof. B.B. Goel, Prof. Devinder Kumar, Prof. V.K. The Vice-Chancellor has also introduced Dr. Vijay Kumar, Assistant Professor, Physics, Institute of Integrated & Honors Studies (Erstwhile University College), Kurukshetra University, Kurukshetra, who has been appointed as new Registrar of the University by the Hon'ble Governor, Haryana and Chancellor of Guru Jambheshwar University of Science &

Technology, Hisar and welcomed Dr. Vijay Kumar as Member-Secretary of the University Court.

The Vice-Chancellor appraised to the House about the major achievements of the Guru Jambheshwar University of Science and Technology, Hisar as under:

1. The University is an A⁺ Grade NAAC Accredited University with a CGPA of 3.38 in the fourth cycle of accreditation and assessment w.e.f. 18.10.2022. Previously, it has been thrice accredited with an 'A' Grade by the National Assessment and Accreditation Council (NAAC) in 2002, 2009 and 2014 every time with an increasing CGPA score.
2. The University has been granted graded Autonomy of Category-II by UGC. It is one of the 21 State Universities in the Country to have achieved this position.
3. Recently, the University has been ranked 47th in the 'State Public University' category and 55th rank in the Pharmacy Category in NIRF 2025.
4. Scopus Publication of Guru Jambheshwar University of Science and Technology, Hisar is 5290 with Institution h-index 131, which is highest in Haryana and citations more than 125049 with average paper citations 23.68, which is highest in the region.
5. Ranked 59th in India and ranked band 1201-1500 in Times Higher Education World University Ranking 2025.
6. Ranked 33rd in India and ranked band 801-1000 in the world in the 'Physical Science' subject category in the Times Higher Education World University Ranking 2025.
7. Ranked 68th in India and ranked band 1001-1250 in the world in the 'Engineering' subject category in the Times Higher Education World University Ranking 2025.
8. Rank Band 101-125 in the 'Management' Category and 101-150 ranked band in the University Category in NIRF 2024.
9. Ranked 22nd in India and 639th in the world in UI Green Metric World University Ranking 2024, the ranking on Green Campus and Environmental Sustainability initiated by Universitas Indonesia.

The House appreciated the efforts made by Prof. Narsi Ram Bishnoi, Vice-Chancellor at National/International levels and also congratulated the Vice-Chancellor for above mentioned achievements of the University.

The Registrar also welcomed all the worthy members of the University Court including the online members. Thereafter, the agenda was taken up for discussion and deliberation.

1. **Confirmed** the minutes of the 35th meeting held on 05.04.2024 (circulated vide letter No. Acad./2024/Court-35/1429-1457 dated 13.04.2024).
2. **Noted** the Follow-up action taken report on the decisions of the 35th meeting held on 05.04.2024 (Annexure-I Pages 3-6 of the agenda).

3. **Considered** the Budget Estimates for the financial year 2025-2026 and Revised Estimates for 2024-2025 of Guru Jambheshwar University of Science and Technology, Hisar.

The Finance Committee considered the above item vide resolution No. 3 in its meeting held on 28.03.2025 and recommended to the Executive Council and University Court as under :-

Resolved that:

- (i) **The Budget Estimates for the year 2025-2026 and Revised Estimates 2024-2025 as presented be approved.**
- (ii) **The Finance Committee also authorized the Vice-Chancellor to recast the Budget Estimates 2025-2026 at his own level in the manner he deemed appropriate to curtail the Budget Estimates within the resources available and the expenditure within the approved Budget Estimates 2025-26.**

In addition to this, the University urgently requires additional funds of Rs. 8000 lakhs in supplementary grants for the financial year 2025-26 to support the following crucial initiatives:

- Recruitment of 54 teaching posts (13 Associate Professors and 41 Assistant Professors) as mandated by the State Government. (Annexure-I, Pages-1-3 (Sr. No. 1-54 of the minutes of Finance Committee) in addition several numbers of teachers have been promoted under the Career Assured Scheme (1500 Lakhs)
- Recruitment of 55 non-teaching posts (Assistant Registrar, Account Officer, Junior Programmer, Assistants, Lab. Technician, Lab Attendants, Hostel Care-Taker, Account Clerk and Chowkidar) in compliance with the State Government's approval. (400 Lakhs) (Annexure-II, Pages 1-3 (Sr. No. 1-55) of the minutes of Finance Committee)
- Procurement of hard and soft infrastructure to align with the National Education Policy 2020, a significant project endorsed by the Prime Minister of India (1900 Lakhs) (Annexure-III, Pages 01 of the minutes of Finance Committee)
- Upgradation of labs with state-of-the-art equipment to elevate research capabilities in various disciplines, keeping pace with market trends. (800 Lakhs)
- Construction of a Teaching Block-VIII of Rs. 1000 Lakhs, Mechanical Engineering Workshop of Rs. 400 Lakhs and two additional hostels (Boys Rs. 1000 Lakhs and Girls Rs. 1000 Lakhs) to accommodate the growing student strength due to introduction of new programmes. Initially, to start above project's 41 crores is required.

The above recommendations be approved and forwarded to the Executive Council for its consideration and further approval.

Prof. B. B. Goel again congratulated the Vice-Chancellor and his financial team on the Budget Estimates of 2025-26 that deserves the applaud on the two comes. For the first time the Budgetary outlay of Rs. 415.82 crores Budget Estimates of 2025-26 against the actual budget of Rs. 193.97 crores of 2023-24 and a jump of around 166 percent from 2024-25 of Rs. 251 crores is really commendable. The second appreciation to the Vice-Chancellor and his team is that the capex has a whopping share around Rs. 85 crores in 2025-26 as against nearly Rs. 04 crores in 2023-24 and Rs. 25 crores in 2024-25 is a clear cut sign that the University is on the expansion mode in its academic and infrastructure facilities leading to the growth of the University and deserves applaud.

At the same time there are some concerns as well. The overall deficit of Rs. 222 crores in 2025-26 as against surplus of Rs. 30 crores in 2023-24 and projected deficit of Rs. 73 crores in 2024-25 is a cause of concern. Such a large deficit cannot be met out from surplus funds of Distance Education as claimed. The Self financing programmes are required to be made more sustainable. Income from the Consultancy, the Patents and the Instruments Labs needs to be generated on priority.

The Vice-Chancellor welcomed suggestions made by Prof. B. B. Goel and apprised the House that the Territorial Jurisdiction of the University to run the Open Distance Learning programmes is very limited i.e. within the District Hisar only and the State Govt. has already been approached to extend the Territorial Jurisdiction of the University within State of Haryana. Further, the University is also focusing on the online programmes being run through Centre for Distance and Online Education.

The Executive Council vide resolution no. 3 in its 101th meeting held 01.04.2025 at 11:00 AM has approved the above recommendations and approval of the Finance Committee and further recommended to the University Court.

Resolved that the above recommendations/approval of the Finance Committee and the Executive Council be approved.

4. **Noted** the Annual Accounts and Balance Sheet for the year 2023-2024 of Guru Jambheshwar University of Science and Technology, Hisar.

Resolved that "Annual Accounts" and "Balance Sheet" for the years 2023-2024 of the University be approved and further recommended to the Executive Council and University Court for its consideration and approval.

Besides the above, Sh. Jainder Singh Chhilar, IAS, Special Secretary Finance has raised some points on NEP-2020, Online Courses and revenue from patents, all the issues have been addressed in the meeting. As regards patents, 104 patents have been submitted and 20 patents has been published and some them are in

the pipeline towards commercialization. The list of patents published is as under:
