 - 2. Secretary of the Society/Trust of his/her nominee.
 - 3. Three outside experts of the level of Professors in the subject/courses of studies concerned, out of which one shall be from the University. In exceptional cases where Professor in the subject concerned are not available. Senior Asstt: Professor/Readers in the subject concerned with more than five years experience may be taken as experts.
- (ii) Selection Committee for non-teaching posts:
 - 1. President of the Society/Trust of his/her nominee.

 - Secretary of the Society/Trust of his/her nominee.
 Three experts in education administration of the level of Assistant Registrar, out of which one shall be from the affiliating University. Three members shall form the quorum.

No appointment letter shall be issued to the selected candidate(s) till the proceedings of the Selection Committee are approved by the University.

You are, therefore, requested to constitute Selection Committee for recruitment to the teaching/non-teaching posts/Librarians as per Ordinance mentioned above and send the recommendations to this university for approval.

In continuation of this office letter No. UCB/12/255-268, dated 01.03.2012, the following instructions/guidelines are issued for compliance to bring the transparency in the approval/appointment process of teaching faculties to be appointed in the affiliated college(s):-

- 1. The college will publish the advertisement for the teaching post(s) in at least two national dailies (not in local/city sheet) and submit the original tear sheet of the newspaper(s) containing the advertisement within a week of publishing the same.
- 2. The college will intimate the exact schedule of interviews for the post advertised in the newspapers to this office in advance.
- 3. The presence of expert(s) of the University in Selection Committee is must.
- 4. The college will send the list of all applicants with detailed synopsis to this office at least one week before the date of interview.
- 5. The college will display the list of eligible candidate(s) on its website at least one week before the date of interview.
- 6. The college will submit the proceedings of Selection Committee duly signed by all the members alongwith requisite documents in the sealed envelope to this office within one week of the meeting of Selection Committee.
- 7. The college will send the teachers return of the appointed candidate(s) on prescribed proforma alongwith verification letters of certificates of all examinations passed by candidate(s) from concerned University/Board within two months from the date of issue of approval letter by this office.
- 8. Out of three outside experts to be inducted in the Selection Committee for the post of Director/Principal, one shall be an approved or regular Director/Principal, who will be appointed by the Vice-Chancellor of the University and whose presence in the Selection Committee is must.

You are accordingly requested to comply with the above instructions failing which the proceedings of Selection Committee will not be accepted for approval of Director/Principal/Faculty.

It has been observed in the previous years that the affiliated colleges do not comply with the conditions imposed by the inspection committee in toto and do not submit the compliance report within the stipulated period even after requesting them a number of times. These conditions/deficiencies remain continue to the next year. A team from the office of Principal Accountant General (PAG), Panchkula, Haryana who visited this office in the Month of May/June and also revisited recently has taken a serious view of it and desired that a prompt action on the behalf of the University is required to be taken to ensure that colleges should comply with/remove all conditions/deficiencies pointed out by the inspection committee every year.

In the light of observation of the audit team, I am directed to intimate that the Vice-Chancellor has approved that if the colleges do not submit their compliance report with relevant documents after having complied with the conditions within stipulated period, the next coming session may be declared/treated zero admission session for the college.

It has been further approved that the compliance of conditions shall be got physically verified by a committee constituted by the Hon'ble Vice-Chancellor immediately after the college submits the compliance report to this office within stipulated period.

In light of said observation, the Vice-Chancellor has approved that the affiliated colleges may be directed to link their website with the university uploading the full details of land, building infrastructure, faculty and other staff with photograph, qualification, EPF/Unique identification (UID) Number, grade and salary being paid, mode of payment of salary, sanctioned intake viz-a-viz students actually enrolled (course-wise), audited financial statement of income and expenditure of the previous year and current financial year etc. and update the same by 10th of every month. The Institutes/colleges will also submit an affidavit to this effect to the university. The Head, UCIC, GJUS&T, Hisar will arrange to provide the proper link to the affiliated colleges on the University website.

I am, therefore, directed to request you to link the web site of your college/Institute with the with the university uploading the full details of land, building infrastructure, faculty and other staff with their photograph, qualification, EPF/Unique identification (UID) Number, grade and salary being paid, mode of payment of salary, sanctioned intake viz-a-viz students actually enrolled (course-wise), audited financial statement of income and expenditure of the previous year and current financial year etc. within a week and ensure the updation of the same by 10th of every month.
