The application(s) are invited for admission in AICTE approved B.Tech. (Mechanical Engineering) and B.Tech. (Computer Science & Engineering) programmes for **WORKING PROFESSIONALS** for the Academic Year 2024-25 from 14.08.2024. The candidate apply through online mode only. Online application (with online payment of Counseling Fee of Rs. 1000/-) can be made through University website: www.gjust.ac.in. **Last date to fill online application form will be 26.08.2024.**

Eligibility for Admission

- Professional working in Registered Industry/Organization (Central/State) /Private/Public limited company/MSMEs located within 75 Km radial distance from the institute.
- Minimum of one-year full time/ Regular working experience.
- Passed Minimum 3-years / 2-Years (Lateral Entry) Diploma examination in any branch of Engg. & Tech. with at least 45% marks (40% marks in case of candidates belonging to reserved category).

OR

Passed B.Sc. Degree from a recognized University as defined by UGC, with at least 45% marks (40% marks in case of candidates belonging to reserved category) and passed 10+2 examination with Mathematics as a subject.

OR

Passed B.Voc/3-year D.Voc. Stream in the same or allied sector

- An undertaking from the employer declaring that the applicant is an employee of the firm.

Admission Procedure

- Admissions in B.Tech. for working professionals shall be made on the basis of percentage of marks obtained in the qualifying examination.
- The Reservation policy notified by the State Government of Haryana is applicable for admissions.

Programme Intake and Fee Structure

- Intake: 30 seats
- Course Fees: 76,500/- per annum with an annual increase of 10% per year.

Candidate is required to deposit a semester fee of Rs. 42,350/- in cash/online (Debit/Credit card) on the spot and remaining fees in the next semester before 15th January.

Note: The course will only run if the strength of the students is greater than or equal to 10. In case there are less than 10 students in any of the course the full fee will be refunded by the University.
