It is notified for Information of all concerned that the fresh online applications are invited on the University portal against the vacant/ left over seat(s) in the various programmes (except B.Tech. & B.Pharm.) of University Teaching Departments of the University for the academic session 2024-25.

The interested candidate(s) can submit their online applications on the University portal alongwith requisite registration fee up to 13.09.2024. The On Spot Physical counseling-II will be held on 13.09.2024 in the Department concerned. The requisite fee as mentioned in the University Prospectus 2024-25 alongwith late fee of Rs.1000/- for admission to various programmes will be submitted on spot i.e. on the day of On Spot Physical Counseling-II i.e. 13.09.2024.

The On-Spot Physical Counseling for admission to vacant seat(s) of various programmes will be held on 13.09.2024 in the respective department. The admissions in the On Spot Physical Counseling-II will be made as per rules/ procedure mentioned in the University Prospectus 2024-25. If any eligible candidate, who has already applied through online application form and appeared in the entrance test or his/her name was in the list of academic merit and now participates in On Spot Physical Counseling-II to be held on 13.09.2024 will be given preference before the fresh applicants. The admission to the fresh candidates will be made on the basis of academic merit plus weightages, if any, as per criteria given in the University Prospectus 2024-25. The Procedure/ Criteria for preparing the merit list, Counseling Procedure and Important Note/ Guidelines for Counseling as mentioned in the University Prospectus 2024-25 will be followed for admission to all programmes.

The no. of vacant seat(s) uploaded on the University website by the respective Chairperson of the concerned University Teaching Departments in a programme may increase/ decrease due to withdrawal of admission or allotment of seat(s) in Physical Counseling/ On Spot Physical Counselling.

Further, if any seat(s) get vacated in a programme due to withdrawal before the On Spot Physical Counseling-II and the same was not uploaded on the University website by the Department concerned for inviting fresh applications, the same may also be filled-up in the On Spot Physical Counseling-II as per above procedure/ criteria of admission.
