It is informed that the Central Board of School Education (CBSE) vide its notification no. CE/CBSE/2024/E-file 163685 dated 04.09.2024 has discontinued the provision of issuance of original hard copy of Migration Certificate to the students of Class- XII from the session 2025-26. The digital copy of Migration Certificate will be used by the students for admission to other Educational Institutes.

The Vice-Chancellor has considered the matter and approved that the Digital/Online Migration Certificate issued by the CBSE or any other Board of Examination/University who do not issue the Migration Certificates in the form of hard copy but issues only in digital form/online may be accepted in respect of the students admitted in their courses of study offered by UTD/Affiliated Colleges for registration in the University subject to the condition **that the student concerned shall submit an affidavit duly attested by the Notary Public to the effect that Digital Locker/Online Migration Certificate submitted to this University for admission in UTDs/Colleges has not been submitted by him/her to any other institute/University for admission. If his/her statement is found false at any stage, his/her admission in the course shall liable to be cancelled and fees already deposited shall not be refunded in any case.**

You are therefore, requested to take further necessary action to adhere to the above orders and to bring to the notice of the students admitted in your Department/College for the session **2025-26.**
