Kindly refer to your Memo No. 726 dated 17.09.2025 on the subject cited above.



The grant of provisional affiliation of above said courses is subject to fulfilment of following conditions by the college:

1. Atleast one more full-time qualified faculty be appointed before the commencement of classes of the course.
2. The College is required to spend Rs. 5,00,000/- for One additional fully equipped computer lab with adequate number of systems, licensed software, LAN/Wi-Fi connectivity and UPS backup to meet course requirements.
3. Textbooks, reference books, journals and e-resources as per PGDCA curriculum norms of amount approx.. Rs. 50,000/- should also be procured.
4. Fire Safety Certificate in respect of College Building issued by Competent Authority is required to be submitted by the College.


