In pursuance of Memo. No. No.KW/1/3-2025-IT (1) dated 22.06.2026 issued by the Superintendent for Director General Higher Education, Haryana, Panchkula regarding reopening of UG admission portal 2026-27, the schedule for online submission of Registration Return/Continuation Return of students admitted in UG courses on university web portal along with prescribed fees and hardcopy of Registration Return/Continuation Return for the session 2026-27 is further extended as under:
