**NOTIFICATION**

The Vice-Chancellor on the recommendations of the Equivalence/Deans Committee in its meeting held on 23/04/2025 vide Resolution No. 1 is pleased to approve the following :-

The degree of M.Sc. (Economics) awarded by this University be treated as equivalent to degree of M.A. (Economics) of the State/Central Universities for the purpose of recruitment as well as further studies. It was also approved that the degree of B.Sc.(Hons)-Economics awarded by this University is equivalent with degree of B.A. (Hons.)-Economics/B.A. (Economics) awarded by the State/Central Universities for the purpose of recruitment as well as further studies.

Further, the Department of Higher Education, Department of Technical Education, Department of Secondary Education, Department of Economics and Statistical Affairs of the Haryana Govt. are requested to add the qualifications of M.Sc. (Economics) in the eligibility criteria where degree of M.A. (Economics) is required and also to add the qualifications of B.Sc.(Hons)-Economics in the eligibility criteria where B.A. (Hons.)-Economics/B.A. (Economics) is required for the purpose of recruitment of various posts in the State Govt.

The Haryana Public Service Commission (HPSC) and Haryana Staff Selection Commission are also requested for treating the M.Sc. (Economics) degree equivalent with M.A. (Economics) and B.Sc.(Hons)-Economics with B.A. (Hons.)-Economics/B.A. (Economics) for various recruitment purposes.


