You are, therefore, requested to submit the Eligibility-cum-Registration Slip / Continuation Return alongwith Annexure-I & II for the session 2025-26 as per the above schedule.



Further, following action are also required to be taken by the Chairpersons (UTDs)/Director (HSB) and PDUCIC as per notification already circulated vide Endst. No. Regn./UTD/2024/3149-85 dated 06.08.2024:

- I. The PDUCIC is required to add correction in the certificate mentioned in online-Eligibility-cum-Registration Slips as per sr. no. 2 of the Notification.
- II. The PDUCIC shall generate online course wise list of admitted students having details i.e. name of the course, course code, sanctioned intake, total no. of admitted students having a consolidated report of total number of students, Category wise details of students having category (admitted category (AI/HOGC/SC/DSC/BCA/BCB etc.), Original Category (no. of SC/DSC, BCA/BCB, EWS, PWD, FF/Ex-Serviceman, total no. of Male/Female/Transgender), Minority (Sikh, Jain, Muslims, Esai, Parsi etc.) Kashmiri Migrants, Supernumerary category students/International Students etc. (**Annexure-I**) and other such lists as desired by the Registration Branch and the Hardcopy of the same shall be submitted to the Registration Branch by the Chairperson, UTDs/School with Registration Booklet having Registration Slips in soft binding.
- III. The PDUCIC shall make the provision of annual continuation return of the students admitted in 2<sup>nd</sup> year onwards of the courses running in UTDs on the pattern of affiliated colleges having all particulars of the students collected in Ist year and the Continuation Return must have a column for fees details upto the year of Return, end semester results of the students of the year previous to the year of submission of Continuation Return as the State Govt. agencies/UGC/AICTE also seek data regarding result of previous year of the students promoted to the next year of a course. The PDUCIC shall generate the list of all continued students as per **Annexure-II**.
- IV. The panel for preparing/editing/updating the Eligibility-cum-Registration Slip / Continuation Return shall be made available to the Department concerned from the date of start of admission in the course upto the 20 days of the last date of admission as notified by the University. The Department concerned shall generate three hard copies of the Eligibility-cum-Registration Slip one each for Department, Student and Registration Branch. The Department shall submit the Hard copy of the Eligibility-cum-Registration Slip meant for Registration Branch to the Registration Branch with various consolidated statistics in forwarding letter with separate details of the students admitted in each category in separate annexures as to be conveyed by the Registration Branch. The Chairpersons/Director UTDs/School shall also submit the Hardcopy of the Continuation Return with various statistical data as desired to the Registration Branch within 20 days of the last date of promotion to odd semester as per prospectus of the particular academic session.
- V. The Director HSB/Chairperson, Department concerned shall be allowed to fill the Examination Form of the students provisionally in respect of whom the Registration Return/Slips have been submitted to the Registration Branch. The Department shall submit the examination form of only those students in IInd semester whose registration has been finalized by the Registration Branch.

- VI. The School/Department concerned shall ensure the proper submission of Continuation Return of the student of 2<sup>nd</sup> year onward of a course to the Registration Branch and shall not fill the examination form for end semester examination of a particular year of the students whose continuation return have not been submitted by the Department.
- VII. The PDUCIC shall make the students panel available to the Department permanently from the session 2024-25 for updating the status of the students enrolled in all years of the courses (i.e. Ist year/IIInd year/IIIrd year etc.). It will be the responsibility of the Director, HSB/Chairperson of the Department concerned to update the data immediately in case of left out/admission cancelled/name struck off/readmitted student.
