Terms & Conditions:

- 1. Quotation Signing** - The quotations must be signed by authorized signatory of the bidding firm/company on each page, along with seal of the firm/company, as the case may be.
- 2. Conditional Quotation** - Conditional quotations are not acceptable. Hence the supplier is advised neither to alter the specifications nor to mention anything on the quotation form, except cost, signature with seal, otherwise the quotation will not be considered.
- 3. Delivery Destination** - The quotations should be quoted as FOR GJUS&T, Hisar.
- 4. Delivery Period** - The delivery and installation is to be made within 30 days of the date of dispatch of the supply order.
- 5. Warranty Period** - Warranty period of the batteries will be 01 year or standard warranty whichever is higher, from the date of installation. Warranty should be through the company.
- 6. Delivery Period Extension** - The supply order(s) shall be executed within the time specified in this regard. However, in case of force Majeure / reasons beyond control of

the supplier, he may make a written request to the Vice-Chancellor for grant of extension for delivery period. The written request in this regard should clearly spell out such reason. The Vice-Chancellor, if he/she is satisfied with such reasons and further if the requested extension will not be detrimental to the interests of the university, may grant extension for a reasonable period for delivery of the item. The supplier would be required to indemnify the university against any loss on account of downfall of the price during the extended period.

- 7. Penalty for delayed supply** - In the event of the delayed supply, if accepted, the Registrar will be competent to impose penalty @ 1% per day of the purchase order, provided that the entire amount of penalty shall not exceed 10% of the total amount of purchase order. An appeal against these orders shall, however, lie to the Vice Chancellor whose decision shall be final.
- 8. Rejection of incomplete Quotations** - Incomplete quotations such as unsigned quotations, late submitted quotation, conditional quotation, quotation not confirming to the eligibility criteria and Technical specification or with any vague term such as 'Extra as applicable', will be considered as rejected.
- 9. Right to Bid rejection** - The University reserves the right to reject any or all offers at any stage without assigning any reason.
- 10. Quantity Variation** - The quantity shall be subject to increase or decrease as the case may be.
- 11. Packaging of Consignment** - The material should be packed in a strong case so as to avoid any damage, theft or pilferage in the transit, in which case the responsibility shall be that of the supplier.
- 12. Payment** - Within 30 days after successful inspection by the university.
- 13. Taxation** - Rates should be inclusive of all taxes.
- 14. Schedule** - The quotation floating date is 14/01/2025. The sealed quotation by **Registered / Speed Post/Courier** should reach in the office of **Director, Pt. Deendayal Upadhyaya Computer & Informatics Centre, Guru Jambheshwar University of Science & Technology, Hisar (Haryana), Pin Code-125001, Phone No. 01662-263179** on or before 28/01/2025 upto 5.00 pm. The quotation will be opened on 29/01/2025 at 11.00 am in the office of the **Director, PDUIC, GJUS&T, Hisar**. The quotation received after due date and time shall not be entertained.

- 15. Arbitration** - In case of any dispute both the parties will be bounded by the decision of the Vice Chancellor, GJUS&T, Hisar, as the arbitrator.
- 16. Jurisdiction** - All disputes shall be subject to Hisar jurisdiction.
- 17. Catalogue/literature** - The detailed literature/catalogue of the quoted instrument and its accessories should also be attached with the quotation. The specifications claimed by the firm should be clearly mentioned in the literature/catalogue also.
- 18.** The bidder must have successfully implemented/provided the equipment in at least three Universities/ Govt. Institutes/organizations of repute (Submit copies).
- 19.** The Bidder should not be under a Declaration of Ineligibility or black listed with any of the Government/Public sector unit Agencies (Attach signed Undertaking by OEM/bidder).
- 20.** OEM should have direct manufacturing facility in India to manufacture Projector from last 3 Years.
- 21.** OEM should have valid BIS certificate in their own name. Copies of the valid BIS are to be submitted.
- 22.** Manufacturers Authorisation Form (MAF) of OEM is required (Attach certificate).
- 23.** No deviations in the specifications of any of the above items will be accepted. The Bidder should clearly declare in the Compliance that all items meet all the specifications as required.
- 24.** Bidders are advised to study carefully the terms and conditions before quoting their bid.
