The amount of the fellowship shall be Rs. 15000/- per month and will be paid after confirmation of registration. It will be tenable for two years from the date of award of URF. Scholar will also have to publish one review article within one year of award of University Research Fellowship. This fellowship may be extended only for one more year i.e., 3rd year by the Vice-Chancellor, on the recommendations of the Committee consisting of the Chairperson, one Professor/Associate Professor of the Department and the Supervisor of the Scholar subject to the condition that Scholar has published at least one Research Paper in Scopus SCI Journal. Each scholar receiving this fellowship shall also receive a contingency amount of Rs. 10000/- per annum.

This will be subject to submission of all requisite documents i.e. bond appendix to ordinance XIV on stamp paper of Rs. 100/- with attestation, attendance, progress report of research work and undertaking duly verified by the concerned chairperson regarding not getting any financial benefit from any other sources and fulfill the all-other eligibility conditions by the concerned research scholar.


