## Sub: Extension in the **A**chedule of submission of Migration Certificate for the students admitted in UTD's/HSB/Affiliated Degree Colleges (except Education Colleges) for the session 2024-25 up to 31<sup>st</sup> July, 2025.

Sir/Madam,

It is to inform you that the Vice-Chancellor is pleased to extend the schedule for submission of Migration Certificate of the students admitted in UTD's/HSB/ Affiliated Degree Colleges (except Education Colleges) on the basis of lower examination passed from other Universities/Boards (other than HBSE) for the session 2024-25 upto 31<sup>st</sup> July, 2025 with a late fee of Rs. 5000/- failing which their candidature for concerned examination shall be suspended automatically w.e.f. 1<sup>st</sup> August, 2025.

Further, the student has to furnish an **affidavit** duly attested by the **Notary Public** to effect that he/she did not take/appear in regular examination of any other course from any University/Board during the admission in his/her course of study in this University simultaneously.

The Chairpersons/Directors/Principals of UTDs/HSB/Affiliated Degree Colleges concerned shall issue the orders of suspension of candidature for the examination concerned of the students under intimation to the Controller of Examinations & Registration Branch after 31<sup>st</sup> July, 2025 who fail to submit the Migration Certificates within the revised schedule clearly mentioning that they will not be allowed to appear in end semester examinations.

It is explicitly mentioned that no request of relaxation/waive off fine/late fee on account of late submission of Migration Certificate shall be entertained under any circumstances.

You are therefore, requested to take further necessary action to bring the extended schedule to the notice of the students admitted in your Department/College for the session 2024-25.
