Issuance of No Objection Certificate(NOC) for starting B.Sc. Nursing Course with (100 seats) & Post Basic B.Sc Nursing Course with (60 seats) in Department of Nursing, under the aegis of Guru Jambheswar University of Science and Technology, Hisar, Harayna.

Reference subject noted above.

The State Government has decided to grant No Objection Certificate (NOC) to start B.Sc Nursing Course with (100 seats) and Post Basic B.Sc Nursing Course with (60 seats) in Department of Nursing, under the aegis Guru Jambheswar University of Science and Technology, (Govt. University) Hisar, Harayna subject to the fulfillment of all conditions in this regard and on the following terms & Conditions of NOC:-

- This NOC is not a letter of permission for admitting students. The i. Trust/Institutions has to apply for permission letter for starting this Course and admitting students in School/ College to INC/HN&NMC/University concerned as per requirements.
- ii. The admissions will be made as per seats approved by INC from time to time.
- iii. The institution shall, at its own level seek affiliation from the University having jurisdiction in the State of Haryana, INC and HN&NMC before making admission. A copy of affiliation and approval so received shall be submitted to the Director General, Medical Education & Research Department Haryana.
- All the conditions of affiliation prescribed by the Affiliating University, iv. INC and HN&NMC will have to be met with by the applicant.
- The Trust/Institutions will recruit the staff as per Government, University, V. INC and HN&NMC guidelines and pay the salary to the staff directly in their Aadhar linked Bank Accounts.
- The Trust/Institutions will give an affidavit to the effect that Institution will vi. create a provident fund for the welfare of employees.
- Before admitting the students, the applicant will deposit an amount of Rs. vii. 20.00 Lakh for each Degree course in the shape of FDR initially fixed for five years in the name "Member Secretary, Haryana State Medical Education Society" payable at Panchkula. The FDR will be handed over in viii.
- The FDR shall be renewed at time of renewal of the NOC or well before ix.
- In case the Institute is not found able to run/sustain itself, the NOC will be withdrawn after providing an opportunity of hearing to the institution and FDR submitted by the Trust/Institutions shall be forfeited and utilized for continuing the studies of the enrolled students/payment of salary of the staff and other costs of running the Institution till the completion of ongoing session. In case the funds available in the School/College are not sufficient,

the balance amount shall be recovered from the Trust/Institutions, its promoters and Trust/Institutions as per law including through arrears of land revenue.

No financial assistance/grant in any case in any form will be given by the X. State Government to run these courses/institution to the Trust. The institution will have to bear all the recurring and non recurring expenditure for all time to come from its own resources.

xi. Tuition fee and other charges to be taken from the students will be as per the norms of the affiliating University, INC, HN&NMC and DMER.

- The Trust/Institutions will not sub-let/lease out the NOC further and will xii. use the same for itself for establishing ANM(F)/GNM/B.Sc./M.Sc. Nursing School/College at the place other than the one mentioned in the application form for the NOC.
- The Institution has to comply with the provisions of Haryana Private Health xiii. Sciences Educational Institution Act, 2012.
- The Institution has to comply with the terms & conditions of Nursing xiv. policy issued vide Government Memo No. 16/11/2023-6HB-IV dated
- The Government may impose any other reasonable conditions in public XV. interest at any time, which shall be binding on the Institution/Trust.
- The Institution, at any time, may be inspected through the inspection xvi. Committee without any notice.
- The Institution would take all steps to ensure that no incidence of ragging occurs in the School/College and abide by all the instructions about ragging issued by the Government of India, State Government and Hon'ble Supreme Court of India from time to time.

The Building intended for Nursing Education will not be used for any other

The State Government has right to withdraw the NOC without any notice in xix. case of any adverse report about the Trust/Institutions and its promoters or in case any of the paper submitted by it are found to be false. XX.

Any contravention of the above stated conditions shall result in withdrawal of the NOC and legal action against the defaulting Trust, Institution and/or
