It is hereby notified that the Executive Council has resolved the following amendment in Clause (i) & (ii) of Rule 3.1 and clause 8 of Re-evaluation Rule vide resolution 26 & 32 of 104th meeting of the Executive Council held on 24.03.2026 and the amended Re-evaluation Rules will apply with immediate effect as under:-

<p>3.1(i) A candidate of University Teaching Departments, affiliated colleges and the courses being run through Distance Education may apply for re-evaluation of answer books (s) in theory papers only on the prescribed form in an examination taken by him/her within 15 days including the date of uploading of DMC on the university website or dispatch of D.M.C. from the University, whichever is later, enclosing therewith the Original Detailed Marks Cards/downloaded DMC from University website. In case of improvement a student can apply for re-evaluation from the date of declaration of his/her result within 15 days, if their result shows "No Change" and fee as prescribed for re-evaluation</p> <p>3.1(ii) The Controller of Examinations in exceptional cases, may permit, with a late fee of Rs.1100/- in case of a candidate who submits the re-evaluation form after stipulated period but not later than 30 days of the dispatch of DMC.</p> <p>No re-evaluation form will be accepted thereafter under any circumstances</p>	<p>3.1(i) A candidate of University Teaching Departments, affiliated colleges and the courses being run through Distance Education may apply for re-evaluation of answer books (s) in theory papers only on the prescribed form in an examination taken by him/her within 15 days including the date of uploading of DMC/result on the university website or dispatch of D.M.C. from the University, whichever is later, enclosing therewith the Original Detailed Marks Cards/downloaded DMC from University website. Remuneration to the Re-evaluator The re-evaluator be paid a Remuneration Rs. 25/- per answer book subject to a minimum of Rs. 250/- upto 06 answer books and a minimum of Rs. 400/- for more than 06 & upto 16 answer books per subject exclusively for re-evaluation.</p>
