(Biotechnology) program for academic session 2025-27 on the basis of rank secured in Graduate Aptitude Test- Biotechnology (GAT-B) 2025 conducted by Regional Centre for Biotechnology, Faridabad on behalf of Department of Biotechnology, Govt. of India. The eligibility conditions, distribution and reservation of seats and fee structure for admission to this program is as under:

- **Eligibility Conditions:** The eligibility qualifications for admission to DBT supported M.Sc. (Biotechnology) program shall be Bachelor's in any discipline of Biological Sciences/ Agricultural Sciences/ Fishery Sciences/ Veterinary Sciences/ Pharmacy/ Medicine (MBBS/BAMS/BDS/B.Tech.) Biotechnology with at least 55% marks or its equivalent grade point average.
