NOTIFICATION

The Vice Chancellor is pleased to allow the following amendment in Clause-6 "Other Important information/ note related to Eligibility/ Admission", page 81, Chapter-4, "Eligibility for Admission" of University Prospectus for admission to all regular programmes for academic session 2024-25 under Section 11(5) of the University Act, 1995 in anticipation approval of the Academic Council and Executive Council from next semester (i.e. commencing from January, 2025 onwards):

Existing Clause-6 of University Prospectus 2024-25

If a student is absent from the classes continuously for <u>fifteen days</u> without intimating to the Chairperson/ Incharge of the Department, her/his name shall be removed from the Department's roll. However, she/he may be allowed re-admission by the Chairperson on payment of fee of Rs. 1500/taking into consideration the possibility of fulfilling the requirement of attendance to be eligible to appear in the end semester examinations. For the students detained for entire semester/ session, the prescribed full fee of semester/ session will be charged in addition to re-admission fees.

Amended Clause-6 of University Prospectus 2024-25

If a student is absent from the classes continuously for **five days** without intimating to the Chairperson/ Incharge of the Department, her/his name shall be removed from the Department's roll. However, she/he may be allowed re-admission by the Chairperson on payment of fee of Rs. 1500/- taking into consideration the possibility of fulfilling the requirement of attendance to be eligible to appear in the end semester examinations. For the students detained for entire semester/ session, the prescribed full fee of semester/ session will be charged in addition to readmission fees.

- 2. The condition of absence continuously for <u>fifteen days</u> without intimating to the Chairperson/ Incharge of the Department be replaced with <u>five days</u> in the Ordinance of the University as well as other concerned documents for University Teaching Departments of the University.
- 3. Further, it has also been approved by the Vice-Chancellor that every teacher is required to submit the details of attendance of students subject-wise and class-wise to the Chairperson of the Department concerned on monthly basis. The office of the Chairperson concerned will maintain the record and display the attendance report on the "Notice Board" of the department for information of the students. The Chairperson of the department concerned will also write a letter about monthly attendance by registered post to the parents of the student(s) concerned as well as through E-Mode (Whatsapp group/Email/SMS) having shortage of lecture with the request to direct their ward to attend the classes regularly. A copy of the proforma for attendance record of students at (Annexure-I) alongwith specimen of intimation letters to be sent to the Parents/ Guardians of students regarding continued absence from classes and monthly attendance record of their wards at (Annexure-II) is enclosed herewith.

In addition to above, the department will intimate the parents about monthly attendance through E-mode (Whatsapp group/ E-mail/ SMS etc.).

All the Chairpersons/Director of the University Teaching Departments/Haryana School of Business will ensure the compliance of the instructions in their department.

If a student is absent from the classes continuously for <u>Five days</u> without intimating to the Chairperson/ Incharge of the Department, her/his name shall be removed from the Department's roll. However, she/he may be allowed re-admission by the Chairperson on payment of fee of Rs. 1500/- taking into consideration the possibility of fulfilling the requirement of attendance to be eligible to appear in the end semester examinations. For the students detained for entire semester/ session, the prescribed full fee of semester/ session will be charged in addition to readmission fees.
