

About Guru Jambheshwar Ji Maharaj



Guru Jambheshwar Ji Maharaj was a saint and great environmentalist of 15th century. Amongst all the saints of the 15th century, Guru Jambheshwar Ji was unique in preaching about the conservation of biodiversity to his followers. He also included the same in his 29 commandments. Thus, Guru Jambheshwar Ji was not only a religious 'GURU' but a great ecologist and environmentalist, many centuries ahead of the scientists.

He was born in 1451 A.D. (Samvat 1508) on 8th day of dark half of the Lunar month Bhadrapad on Janamashtami, in a village Pipasar situated in the revenue jurisdiction of Nagaur district of Rajasthan, India. He adopted the life of an ascetic teacher in 1484 AD and started living on the Samrathal, sand Dhora hill of Mukam village situated in Nokha tehsil of Bikaner district of Rajasthan. He enshrined in his followers' compassion towards nature and protection of life as the supreme religious goal.

He founded the Bishnoi sect in 1485 AD on eighth day of the black fortnight of the month of Kartika of the year 1542 of the Vikrami Era at Samrathal Dhora and prescribed 29 commandments dealing with various aspects of life. He spent the remaining 51 years of his life in spreading his great vision. He expounded his religious philosophy and the essence of these principles in the form of verses. These spiritual verses have a vigour of their own, vibrant, passionate and sincere. These are distinguished by their vivid and conversational style and moral exhortation. Guru ji achieved 'Nirvana' in 1536 in village Lalasar District Bikaner, Rajasthan.

Among the 29 commandments laid down by Guru Jambheshwar Ji, eight commandments have been prescribed to preserve biodiversity and encourage good animal husbandry. Seven commandments provide directions for healthy social behaviour. Ten Commandments are directed towards personal hygiene and maintaining good basic health. Four commandments provide guidelines for worshipping God daily and always remember that God is omnipresent. Guru Jambheshwar Ji had occupied a unique place in the Bhakti movement. Though his area of activity had been mainly the desert land of Thar, yet he had been touring other places too. During these extensive tours he has been spreading the message within and outside the country;

"Jeeya Nai Jugati or Mhan (Moova) naimugati".
(To live is a device and to die is salvation)

CHAPTER-1

ABOUT THE UNIVERISTY

General

Guru Jambheshwar University of Science & Technology, Hisar (formerly Guru Jambheshwar University) is a State University established on October 20, 1995 by an Act of the Legislature of the State of Haryana to facilitate and promote studies and research in emerging areas of higher education with a focus on new frontiers of technology, pharmacy, environmental studies, non-conventional sources energy and management studies and also to achieve excellence in these and connected fields. It was formally inaugurated on November 1, 1995. It is named after Guru Jambheshwar Ji Maharaj, a saint environmentalist of 15th century.

The University is situated at Hisar, a rapidly growing town situated at 167 Km. from Delhi on Delhi – Rohtak – Hisar –Sirsa - Fazilka National Highway (NH-9) and at a distance of 231 Km. from Chandigarh on NH-65. The University is situated over a sprawling area of about 372 acres. The campus is laid out with picturesque landscape, numerous buildings of various designs and wide road network. It presents a spectacle of harmony in architecture and natural beauty. Approximately, 275 acres of land have been developed providing with all facilities such as water supply, street lighting, electricity supply and parks/lawns etc. The University has two cafeterias with the facility of big dining hall, kitchen, store etc. Besides, there is a Shopping Centre where several facilities, such as saloon, laundry, post office, bookshop, bank with ATM facility, grocery shop, sweets shop, computer and photocopying facilities, etc. are available to the residents.

The University has been recognized by the University Grants Commission (UGC) under Section 2(f) for recognition of degrees on 11.1.1996 and under section 12(B) of the UGC Act to be eligible for central assistance on 07.02.1997.

The University is 'A+' Grade accredited by National Assessment and Accreditation Council (NAAC) in the 4th cycle of assessment and accreditation w.e.f. 18.10.2022 to 17.10.2027 with the CGPA of 3.38 and before this the university was having 'A' grade for the past 20 years.

In the prestigious national ranking 'India Rankings 2024-released by Department of Higher Education Ministry of Education Government of India, the university has been ranked 47th in the 'State Public University Category and 55th in the Pharmacy Category. Further, the University has been also been ranked between 101-150 rank band in the University Category and rank band 101-125 in the Management Category.

The University has also been ranked in band 1201-1500 in the world in and 59th in India in the world wide renowned Times Higher Education World University ranking 2025. Further, the University has been placed in the Rank Band 401-500 in the world and at 41st place in India in the Young University Rankings by the Times Higher Education World University Ranking 2024, Rank Band 501-600 in Asia University Rankings by the Times Higher Education World University Rankings 2025 and 69th place in India, Rank Band 1001-1250 in the world in the 'Engineering' subject category in the Times Higher Education World University Rankings 2025 68th place in India and Rank Band 801-1000 in the world in the 'Physical Science' subject category and 33rd in India in the Times Higher Education World University Rankings 2025.

Moreover, in the ranking on green campuses and environmental sustainability initiated by Universitas Indonesia the University has been ranked 22nd in India and 639th in the world in UI Green Metric World University Rankings 2024. Dr. A.P.J Abdul Kalam Central Instrumentation Laboratory is a well acclaimed lab. which not only provides facilities to researchers of the University but also caters to the research needs of other Institutions of the region. The University has well sought-after Pandit Deendayal Upadhyaya Innovation and Incubation Centre and Start Up Schemes to foster innovative ideas of its students. The University has been awarded 1st Prize at State level for spreading awareness about "Prevention of Alcoholism and Substance Abuse". The efforts of the University are recognized by the Social Justice and Empowerment Department, Government of Haryana by rewarding it with a cash prize. The University has constantly motivated and encouraged interdisciplinary collaboration and Research. More than 5503 research papers have been published by the faculty in peer reviewed journals of repute which are listed in SCOPUS with more than 1,20,632 citations to their credit. The h-index of the University is 136 and this is the highest h-index of any University in the State of Haryana. Average Paper Citation is 21.92 which is also highest in the region. Numerous research projects have been completed in different departments and there are several ongoing research projects being handled by our faculty. The University has acquired FIST and PURSE grant from the DST and grant under SAP programme by UGC.



Location

The University is situated at Hisar, a rapidly growing town 167 Kms. from Delhi on the bye pass on Delhi-Sirsa-Fazilka National Highway (NH-9). It is at a distance of about 231 Kms. from Chandigarh on N.H. No. 65. It is well connected by rail and road. It is one of the principal cities catering to the administrative and commercial needs of huge rural population. It is a major centre of higher education and research with three major Universities of the State, several research institutions, degree colleges, breeding farms and a growing industrial environment. An Army Cantonment located in Hisar enriches its cultural life.

Jurisdiction

The State Government vide notification No. S.O.7/H.A. 17/1995/S.4/17 dated 21.06.2017 has defined the jurisdiction and authorized the university to exercise its power on all type of colleges of District Hisar.

Research Frontiers

The University has a dedicated team of well qualified faculty members, engaged in teaching and research activities. The total number of papers published by the faculty in Scopus since inception is more than 5000. Besides this, the faculty members have published 48 text books including 17 edited books and contributed 76 chapters in books since 2009-10. The h-index of the University has also gone up to 136 at present from 17 in 2009-10 with more than 5500 publications and over 1,20,000 citations as per Scopus Database. On the basis of h-index, the University has been sanctioned PURSE grant of Rs. 10.25 crores for research in the year 2016. Faculty members mobilized and completed projects worth more than Rs.2.5 crores during last 4 years. Eight departments of the university have been awarded the SAP-DRS projects by UGC and the same has been added to their stature and infrastructure. In addition to this, Department of Bio & Nano Technology is being provided HRD grant for

M.Sc. Biotechnology course by the Department of Biotechnology, Govt. of India since 2000, Bioinformatics Facility (BIF) grant by Department of Biotechnology, Govt. of India since 2006, HRD grant for M.Tech. Nano Science & Technology by Ministry of Science & Technology Govt. of India under Nano Mission program. DST-FIST grants have been awarded to Departments of Bio & Nano Technology, Pharmaceutical Science, Chemistry and Physics. The University has been funded thrice by TEQIP Scheme by World Bank, Board of Research In Nuclear Science (Department of Atomic Energy) and other agencies like MHRD, MHFW, Ministry of Defence (DRDO), Ministry of Social Justice and Empowerment, Ministry of Youth Affairs and Sports, National Board for Higher Mathematics, Distance Education Council, Ministry of Women and Child Welfare, Department of Scheduled Castes, Haryana. Further, International collaborative project includes sponsorships by DRDO, DST, Govt. of India and Ministry of Science & Technology, Thailand which is currently implemented by this university jointly with Asian Institute of Technology, Bangkok, Thailand. The MoU with INFLIBNET for electronic dissemination of Ph.D. thesis through open access in Shodhganga is in place.

Dr. Bhim Rao Ambedkar Library

The University Library came into existence in 1996 and is housed in a circular designed three-storey large building. It is named after the great Indian Jurist, Economist, Politician and Social Reformer Dr. Bhim Rao Ambedkar. The seating capacity of the University Library is 400 seats. The Library runs in two shifts i. e. 9.00 A.M. to 5.00 P.M. and 11.00 A.M. to 7.00 P.M. and remains open on Saturdays and Sundays also. The timing of Night Reading Hall is 8 A.M. to 12 Midnight, however during examinations, it remains open ROUND THE CLOCK. Realizing the crucial role of up-to-date information services for conducting high level R&D activities, the Library since its inception

has been in the continuous process of building and updating a standardized collection with latest publications. In these endeavours, by the end of June, 2025, the Library has a collection of 136067 books and 6722 bound volumes of Journals. For getting the information about individual Library Account Status and Availability of books is provided through Web-OPAC. The Library has ordered 199 printed Indian Journals and subscribed 43 Magazines and 20 Newspapers.



The Library has always been in forefront in the application of latest information and communication technology, whenever available. In addition to the wired Internet connection provided to Research Scholars & Faculty Members, the Library has also provided the Wi-Fi facility for its users. To make it accomplish, the Library in its electronic repository, has access to approx. One Nation One Subscription (ONOS), Central Sector Scheme of Ministry of Education (MoE) provides the access of 13000+ E-journals from 32 publishers and 5 Databases. The Library has purchased/subscribed more than 312000 E-books from EBSCO (Academic E-Books Collection), JSTOR, Emerald, Institute of Physics, The MIT Press, Wiley-IEEE Press, Cambridge University Press and McGraw Hill Express Library. Apart from this, the access of about 7 lakh E-Books from World E-Books Library and South Asia Archive (SAA) has been provided through National Digital Library of India initiative. In addition, 18310 structured video Lectures of IITs through National Programme on Technology Enhanced Learning are also accessible over Campus Wide Network.

The Library has one Research Database Lab for the Research Scholars and Faculty Members. This lab is equipped with state-of-the-art facilities. Moreover, the University has signed MoU with INFLIBNET for Shodhganga Repository and so far, 750 theses have been uploaded onto the platform of Shodhganga and 61 University approved synopsis onto the platform of ShodhGangotri upto March, 2025. On the University Foundation Day, Dr. Bhim Rao Ambedkar Library organized Book Exhibition on 20 October, 2024, During the year 2024-25, the library has provided and Information Science that are enrolled in other Universities. Library has organized a user awareness program on Economic Outlook Database on 24.04.2024. From July, 2024 to June, 2025 total issue for home lending was 23652 books and total 79512 books were consulted by the members of the Library. The Library recorded 93209 visitors during this period.



Apart from the above, the Library provides the facility of detect and check similarity in research work by using "Turnitin" - An anti-plagiarism Software. Library is a member of the National Digital Library. Moreover, for accessing the resources of prominent Higher Education Institutions we are the member of NDLI CLUB also.

Pt. Deendayal Upadhyaya Computer and Informatics Centre

The Pandit Deendayal Upadhyaya Computer and Informatics Centre (PDUCIC) is established with an aim to act as central facility to meet the computing requirements of students, research scholars, staff and faculty of the University. The centre is equipped with 225 desktop computers

of latest configuration alongwith 04 dedicated servers to cater the ICT activities of the University.

The centre hosts the information centric website of University for students/ stakeholders /readers for the latest information about the University Centre also host an independent website for "Centre for Distance and Online Education". University online services are developed and maintained by the centre for catering the need of university affiliated colleges for students management. Further, the centre provides free internet facility to the University students. All computers are connected on 1G Network and internet facility is provided through 1Gbps NKN link of CWN Cell.

Many online tests for recruitment and placements are also conducted in PDUCIC from its very inception. The PDUCIC has effectively been performing task of building up data processing capabilities of many branches of the University and playing a vital role in imparting intensive training time to time to the staff of the University. In addition, there is a full-fledged language lab with Wordsworth software to enhance the language skills and personality development of the students. The timings of the PDUCIC are 9.00 AM to 7.00 PM during teaching session and 9.00 AM to 5.00 PM during summer & winter vacations.



Campus Wide Networking Cell

In order to cater needs of Information & Communication Technologies for students, staff and faculty of university, Networking Cell has been set up to cater the IT needs, computing

requirements and to look after the Campus Wide activities. All the Teaching Departments, Hostels, Administrative Block and Residential Area have been connected with a combination of wired and wireless network. At present, the campus has been provided connectivity through 4500 nodes and 350 Wi-Fi Access Points (Approx.) The internet connectivity has been provided through 1 Gbps NKN link free of cost to Faculty, Staff and Students of the University. A redundant link of 1 Gbps has also been setup for providing 24x7 internet facilities. All the teaching staff (Regular and Contractual), Non-teaching staff and research scholars has been provided E-mail address (username@gjust.org) through Google Workspace. The network security has been provided through high secured hardware UTM. This cell ensures that proper network security rules are adhered to. One hundred twenty four cameras with centralized monitoring system and 250 cameras with local monitoring system have been installed for security purpose.

Hostels

There are nine hostels (four for boys, four for girls and one for working women) which can accommodate more than 2000 students. All the hostels are fully equipped with basic amenities like commercial RO with UV & ozonator, Water coolers, LED TV, electric geysers, telephone facilities, insect killers, adequate playgrounds and other recreational facilities like chessboards, carom boards, badminton and gym equipped with tread mills, exercise cycle & abdominal exerciser, etc. The hostels have ambulance facility (24X7) for students residing in hostels for any medical emergencies. There are also free internet and Wi-Fi facilities for the students in hostels. The lawns around the hostel are developed aesthetically to provide refreshing view to the residents. The girls hostel complex in which all the girl hostels come under a common boundary wall having Air-conditioned Cyber Cafe, general store, beauty parlor, confectionary shop and Photostat shop. Each girls' hostel and working women hostel is provided with sanitary pad vending machine &

sanitary pad incinerator. The CCTV cameras have been installed at various places for security purpose. The University has signed an MoU with LG Electronics Limited (LGEIL) to provide high-quality washing machines for laundry facilities (on nominal Payment basis) in the hostels. Further, each hostel has a common room where newspapers and latest magazines are available to the students. The meal is provided as per healthy & balanced menu at reasonable rates and menu items & quality check is done randomly by the Mess Committees, Wardens, Coordinators, Deputy Chief Wardens and the Chief Wardens. Hostel accommodation will be provided according to latest hostel rules. The prospective hostellers are also required to submit medical fitness certificate at the time of admission. The hostel residents are governed by the terms and conditions as contained in the University Hostel Regulations. The university administration with the very energetic and dedicated team of hostel administrations ensures a better quality of life for all the hostel residents.

Ch. Ranbir Singh Auditorium

Ch. Ranbir Singh Auditorium forms the main component of architectural composition of the Central core of University Campus. The main hall is large enough for an audience of over 1800 persons and additional facilities of three



Seminar Halls on the ground floor, one with a capacity of 250 persons and other two with a capacity of 125 persons each. This building is intended for convocations, conferences, seminars, workshops, concerts, ballets, film shows, plays and other stage performances etc. of national & international level. Ch. Ranbir Singh Auditorium building is one of the beautiful

and State-of-the-Art Auditoriums in India and it has been awarded by National Planning Commission of India (Construction Industry Development Council Vishwakarma Awards 2014) under best construction project at National level. This Auditorium building has also been awarded by National Planning Commission of India under best maintained structures at National level.



Sports Facilities

The Directorate of Sports Department was established in the year 1996. The entire Sports Complex is spread in an area of 40 Acres. Following indoor and outdoor activities:

Dr. APJ Abdul Kalam Central Instrumentation Laboratory

The Dr. APJ Abdul Kalam Central Instrumentation Laboratory is nestled within the vibrant campus of Guru Jambheshwar University of Science and Technology, Hisar. Since its inception in the year 2000, this cutting-edge facility has been a beacon for students, research scholars, and teachers actively involved in ground breaking R&D pursuits across the dynamic realms of Science, Technology & Engineering. Our state-of-the-art laboratory, currently housed in a modern structure spanning an area of 7212 sq.ft and adorned with modern amenities, is tailored to inspire scientific excellence. The CIL cater to the needs of the students, research scholar and teachers of this university as well as other educational institute and industry in order to promote research activities. Researchers from about 115 academic institutions and research centers nationwide have already experienced the transformative capabilities of our facilities. Over the years, the laboratory has acquired sophisticated equipment funded by the DST under the PURSE program and MHRD under

the RUSA scheme. Apart from supporting researchers through sample testing, the CIL conducts training programs for skill upgradation of research scholars and capability enhancement of technical staff. The CIL is presently having sophisticated Instruments like-

The CIL cater to the needs of the students, research scholar and teachers of this university as well as other educational institute and industry in order to promote research activities.

Training and Placement Cell

The Centralized Training & Placement Cell of the university works on Integrated fronts of enhancing employability of our budding professionals and offering maximum employment opportunities to them. Having been equipped with state-of-the-art infrastructure in form of Seminar Hall, Group Discussion Room, Interview Room & WiFi facility, Training & Placement Cell facilities various campus placement drives through Pre-Placement talks, written tests, group discussions & personal interviews. The cell facilitates the students to participate in off-campus or pool-campus placement drives held at various institutions/ industries. The cell offers internship opportunities to the students by conducting Internship drives or In-house Internship cum Training programs.



For grooming the students, cell runs a wide spectrum of programs such as GJUS&T Weekly Online Aptitude Test (GWOAT), UDBHAVANA talk shows, Industry Interaction Programs (IIP), Industrial Visits, Various Speakathon Competitions through Speakathon Club, Coding Competitions through its coding club, Employability Assessment tests, In-house Training on trending technologies, GATE training and many more. The glimpses of all these programs are also regularly updated on all social media platforms as well as in form of its quarterly newsletter namely TPC-CHRONICLE. All these activities of T&P Cell are carried out by highly motivated team of students as activity coordinators, Department and Class placement Coordinators in able guidance of departmental teacher coordinators.

University Health Centre

- ❖ UHC is a primary health center established in 1997 for the medical needs of students, staff and their family members.
- ❖ It is spacious enough to accommodate four doctor's cabins for OPD, one Dental clinic, one observation room with three beds facility, minor O.T, one dispensing room, one laboratory and one medicine store.
- ❖ It is well equipped with equipments like ECG machine, nebulizer, autoclave, foetal monitor, autoanalyser, hematology analyser, Oxygen concentrator etc.
- ❖ Dental clinic is very well equipped with modern equipments like RVG, Apex locator, scaler etc.
- ❖ Homeopathic services are also available.

Health Centre Staff :-

- ❖ Staff of Health Centre includes one Senior Medical Officer, three Medical Officers, one Dental Surgeon, one Chief Pharmacist, five Nurses, three Pharmacists, one Homeopathic doctor, one ECG Technician, one Tech. officer, two Lab. Technicians, three Lab Attendants, and one Lady Attendant.

Various facilities provided at health Centre are :-

- ❖ Medical aid for all the common ailments with routine blood, urine and stool tests. Patients requiring day care are managed here only.
- ❖ Health Centre provides medical care during the cultural and sports events at the event site.
- ❖ Health Centre runs Medical Reimbursement Cell which deals with medical reimbursement cases as per Haryana re-imbursement policy.
- ❖ Health Centre fully participates in Children vaccination programs along with the Civil hospital staff. It has also been part of national pulse polio campaign from time to time.

- ❖ Health camps and talks are also conducted by Health Centre on regular basis.
- ❖ Health Centre remains open continuously from 7:30 am to 8.00 pm. After 8.00 pm two ambulances parked in girls and boys hostel to take the patients to the approved hospitals for management.
- ❖ Health Centre is a day care Centre. For indoor services all the hospitals on Govt. panel are on University panel (<http://haryanahealth.nic.in/Empanelment.html>) for reimbursement purposes.



SC/ST& Scholarship Cell

SC/ST Cell has been set up in the University to ensure proper implementation of various scheme of the UGC/AICTE, the Government of India and the State Govt. concerning scholarship, stipends etc. for welfare of the students. The guidelines, for various types of scholarship/stipends as revised from time to time by the Central and State Governments & University website are notified to all departments which are got displayed on the Notice Board of the concerned department. This cell ensures that these guidelines are strictly adhered to. The reservation to SC, BC etc. and other categories will be admissible as per reservation policy of the State Govt. The following types of scholarship are granted to the SC and BC candidates under the Scheme of Govt. of India/State Govt.

- (i) Post Matric Scholarship to SC/ST students (Govt. Scholarship Scheme).
- (ii) Stipend to B.C. students under Post Metric Scholarship Scheme.
- (iii) All Scholarship Schemes are available on concerned website for applying.

Centre of Industry Institute Partnership (CIIP)

The Centre of Industry Institute Partnership (CIIP) has been established to promote interaction between faculty, students and industry, mainly through consultancy & IPR. The prime objective of the IIP Centre is to reduce the gap between industry expectations (practice) and academic offerings (theory) by direct involvement of industry to attain a symbiosis. The activities planned under this centre will benefit academia in terms of substantial streams of external funding, enhanced opportunities for faculty and students to work on ground breaking research, vital inputs to keep teaching and learning on the cutting edge of a discipline, and the impact of delivering solutions for pressing global challenges.

The core areas under the gambit of CIIP includes Consultancy & IPR. The purpose of consultancy is to promote the interaction of between academia industry & research organizations as a vehicle for augmenting current levels of excellence in teaching and research, and thus leading to funds generation. Under IPR, CIIP facilitates to manage and protect the intellectual property rights of the University, faculty members, research scholars, students and others involved in the novel work, product, ideas and inventions, etc. It is also aimed to ensure the 'Commercial Use' of University's in-house research and technology-outcomes by the outside world.

The consultancy policy of our university specifies the rules and norms regarding consultancy and obligations depending upon the nature of consultancy. This policy has well defined provisions of revenue sharing among university and consultants. The rules laid down in the consultancy policy are expected to fulfil the commitment of the University to promote

academic freedom and provide a conducive environment for research and development of commercial importance.

UGC-MALAVIYA MISSION TEACHER TRAINING CENTRE (Erstwhile UGC-Human Resource Development Centre)

The UGC-Human Resource Development Centre (HRDC) of the University has been renamed as UGC-Malaviya Mission Teacher Training Centre (MMTTC) in November, 2023. The centre was established during the 11th Plan (2009) in accordance with the National Policy of Education (NPE-1986) with a vision 'To Facilitate Human Development and Professional Excellence in Academics' and a mission 'To equip and enrich the participants with requisite professional and personal skills to make them grow as excellent human beings for their best possible contribution in personal, professional and societal domain.

The objectives of MMTTC are to enhance the participants' motivation, skills and knowledge through systematic orientation in specific subjects, techniques and methodologies, and thereby inculcate the right kind of values that would in turn encourage them to take initiatives for innovative and creative work. The functions of MMTTC in the university are to plan, organize, implement, monitor and evaluate a variety of programmes for diverse stakeholders.

- **Faculty Induction Programmes** are organized for newly appointed Universities and Colleges teachers to acquire and improve art of teaching, to understand the linkages between education and economic, socio-economic and cultural development, to utilize opportunities for development of personality, initiative and creativity, and to promote computer literacy as well use of ICT in teaching and learning process.
- **Refresher courses** are organized for corporately senior Universities and Colleges teachers to keep abreast of the latest developments in their specific subjects, and also to understand the organization and management of a college/ university and to

perceive the role of teachers in the total system.

- **Interaction programme-cum-workshop for the Ph.D. Scholars** is also organized on the theme of 'Research Methodology' to sharpen their research skills and facilitate their research work.
- **Short-term programmes** ranging from 2-3 days to one week are also organized for academic staff, non-academic staff, and Ph.D. scholars on need based themes.
- **Programmes for Heads of departments, Principals, Deans, Officers,** etc. are organized with a view to acquaint and sharpen the top-level administration skills which is helpful for effective decision making and its implementation to achieve the excellence in the connected fields.

While following the UGC instructions, the MMTTC also organizes special courses for teachers to sensitize them in key areas like Disaster Management, Values and Spiritualism etc. In addition to UGC sponsored programmes the MMTTC also organized the need based programmes on Faculty Development, Staff Development, Capacity Building, and Research Methodology for Ph.D. scholars funded by other national and international agencies like RUSA, World Bank and Indian Council for Social Science Research (ICSSR), MHRD etc.



MMTTC also conducted AICTE sponsored Professional Development Programme and also offer a comprehensive suite of staff training programmes under the State Training Policy, designed to elevate the skills and competencies of university's non-academic staff. By participating in these programs, university's staff are empowered to enhance their

professional capabilities, foster a culture of continuous improvement, and contribute to the academic excellence and operational efficiency of our institution.

The centre was selected among the ten HRDCs under RUSA Scheme of MHRD, Govt. of India and sanctioned a grant of Rs. 1.00 Crore. This grant was utilised for Faculty Quality Improvement Programmes and for Infrastructure Development. In addition, the Department of Higher Education, MHRD, Govt. of India had notified UGC-HRDC, GJUS&T, Hisar as National Resource Centre (NRC) for conduct of Annual Refresher Programme in Teaching (ARPIT) on Pedagogical Innovations and Research Methodology. Three programmes ARPIT-2018, 2019 & 2020 were successfully conducted through SWAYAM portal.

An international project from the university of Nova-Gorica & UNESCO chair on Open Technologies for OERs entitled Emergency Remote Teaching: Response of Pandemic Pedagogy as A New Normal Teaching has been designed and delivered in 2022. Some new initiatives like Blog, Youtube Channel and Online Radio have also been initiated to enhance skills among teachers.

The National Assessment and Accreditation Council (NAAC) has judged the centre of the University as First out of 66 Academic Staff Colleges in the country and put it in the front-seat in 2012.

As a whole, the MMTTC endeavours to cater to training and development needs of teachers, academic administrators, researchers and non-academic staff. The prospective plans are to make this centre as a full-fledged "Training Centre for Academia and Administration" and to transform it into "Knowledge Disseminating and Resource Generation Centre" for the university by way of providing Training, Development and

Consultancy facilities.

Centre for Behavioural Research & Intervention

The basic aim of the Centre for Behavioural Research and Intervention (CBRI) is to take care of psychological wellbeing of students and to develop the positive attitude among youth particularly the students. The CBRI has been involved in providing psychological counselling to students and patients. Career counselling, personality development, awareness programme, community intervention programme, conducting workshops and seminars on psycho-social problems are some of the major objectives of the Centre. The Centre is also working on sponsored research projects in the field of behaviour modification, HIV /AIDS, Violence etc.

Students' Welfare

The office of the Dean Students' Welfare looks after Students' Welfare in numerous ways and also monitors various cultural activities. Some important facilities provided by this office are as follows:

➤ **EARN WHILE YOU LEARN" SCHEME**

The spirit of the scheme is based on the idea of enabling needy students to meet some educational expenses with dignity. This scheme provides support to some needy students for Department/ office related work for fixed hours in a week with remuneration Rs. 100/- per hour subject to maximum of Rs. 2400/- per month. In this scheme 45 students were given a chance to avail this facility in the year 2025.

➤ **FINANCIAL ASSISTANCE TO THE NEEDY STUDENTS**

Dean Students Welfare office provides financial assistance every year to the needy students of various Departments as per the criteria set by the office/university. In this scheme 94 students were provided financial assistance of Rs. 6,73,500/- in the year 2025.

➤ **FUNDING OF EDUCATIONAL & INDUSTRIAL TOURS**

The office of Dean Students Welfare bears 50% of expenditure incurred on Educational tours & Industrial tours for regular students of the University. The University also provides to the students free of cost participation in various sports tournaments, inter-university youth festival and industrial visits, if they are part of course curriculum etc. The Bus services are also provided in the campus for commuting from city gate to TB-VII during morning and evening hours. The various Educational/ Industrial/ Cultural/ Sports tours in (2024-25) were arranged for the students of different departments of the university.

➤ **STUDENTS INSURANCE SAFETY POLICY**

The Regular students of the University Teaching Departments are insured for Rs. 1,00,000/-. It also covers Medical Expenses under accidental cases upto Rs. 25,000/-. During the year (2024-25) total 9229 students were insured under "Students Insurance Safety Policy" with The Oriental Insurance Co. Ltd, Hisar.

➤ **RAILWAY CONCESSION VOUCHERS FACILITY**

The students from far off places are provided Railway concession vouchers for visiting their homes during vacations and attending academic activities at far off places.

➤ **FINANCIAL HELP FOR VARIOUS FUNCTIONS**

- Air Wing under the control of 1 Haryana Air Squadron NCC Hisar.



The Motto of NCC is "Unity and Discipline". The main objective of NCC is to develop a highly motivated, patriotic, selfless, disciplined, and enterprising youth - who is capable of providing leadership in any walk of life for the betterment of the nation. NCC activities are based on certain core values to prove it a responsive, learning and continuously evolving organization. NCC training philosophy is based on the concept "Empowerment of Youth" to earn the "Right to Lead". Training methodology consist of Institutional Training, Camp Training, Social Service and Community Development, Personality Development, Competence Assessment/Certificate Examination.

Currently NCC training is imparted as extra-curricular activity to volunteer students of university who enroll as cadets. University has implemented the scheme and syllabi of NCC as Additional/Optional course as per NEP, 2020 under CBCS from academic session 2021-22 for the students of B.Tech. Programme who enrolled as NCC cadet. NCC course consisted of 24 credits in total for 6 semesters distributed as 08 credit for theory, 06 credits for practical and 10 credits for two annual training camps. Further, National Cadet Corps (OE-NCC-391-T) is also implemented as Open Elective Course in 5th semester for all the students of B.Tech. Programme except the students enrolled in NCC from academic session 2021-22.

Pandit Deendayal Upadhyaya Innovation & Incubation Centre (PDUIIC)

Pt. Deendayal Upadhyaya Innovation & Incubation Centre (PDUIIC) was established in Guru Jambheshwar University of Science & Technology, Hisar, Haryana in 2018 and digitally Inaugurated by the Hon'ble Prime Minister Sh. Narendra Modi on 3rd February, 2019 under the scheme of RUSA 2.0 with budget outlay of fifteen crores.

PDUIIC facilitates the dream of prospective Young Innovators from conceiving the idea to technological development by coordinating and promoting Incubation and Innovation driven activities for achieving their goal towards startups in the areas of National concern.

In PDUIIC, the students, young innovators who have just begun to take-off get access to all resources including building infrastructure Labs/ICT facilities, business support services, mentoring, training programs, technical, management and legal support to enhance their skills. Moreover, PDUIIC also offers financial assistance in terms of stipend for the selected innovative projects, skill development by conducting Internship/Training/Workshops/Seminars/Hackathon, industrial and educational visits and seed money for establishing Start-up Cell/Companies.

PDUIIC has state of art Building and Lab Infrastructure including IDEA Lab: Prototyping, Mechanical workspace, IoT Lab, brainstorming

room, Common Workplace and many more for the students to create an Innovation and Incubation eco-system in the University. At present, 21 innovative projects (under RUSA) have been sanctioned and more are under consideration. MoUs are also signed to promote training/workshop and innovation, startup and product development activities.

The request thus received will be examined and processed by the concerned Department & office regarding eligibility for the admission. Once the process is completed and candidate is found eligible, she/he will be given an offer letter for admission through e-mail. The student will have to report for admission in the University during admission period which is usually from June to mid-August along with the requisite fee of USD \$2000 per year and all the original documents. Once the documents are verified, the student will be asked to deposit the fee and get final admission. The fee will be deposited through bank draft or online transaction.

 - c) Scanned copy of Category Certificate, if the candidate is claiming for reservation category (in jpg format, (Max (W-H): 1200-1600px, Min (W-H): 400-400px, size upto 200kb).
 - d) APPAR ID: it is essential for the candidate to create their APPAR ID in order to share their credit information on Academic Bank of Credit (ABC) for the purpose of receiving flexible, integrated and multi-disciplinary education from multiple institutions.

- iii) **Score Card, Certificate of UGC-NET/UGC-CSIR-NET, Certificate of Fellowship/Scholarship qualified in UGC-NET/UGC-CSIR-NET/DBT/ICMR/-(JRF-valid)/Provisional DST INSPIRE Fellowship (one year validity subject to the final offer of fellowship as per criteria of DST failing which admission to Ph.D. shall be treated cancelled),** SRF award letter from various national funding agencies like UGC/ICMR etc. with proof of working under the mentorship of faculty member of GJUS&T etc., if any. (Original Certificate/Letter issued by UGC or the concerned agency, duly certified, shall be acceptable.)
- iv) DMC of Pre-Ph.D./Ph.D. course work including the course **Research and Publication Ethics (RPE) notified by UGC vide D.O. No. F.1-1/2018 (Journal/Care) in 2019 and Research Methodology Course** (with at least 55% marks in each paper or its equivalent grade in the UGC 10-point scale or an equivalent CGPA in a point scale wherever grading system is followed) in respect of a candidate who seeks exemption from Ph.D. coursework on the basis of Pre-Ph.D./Ph.D. course work already completed as per UGC regulations from this University or from any other State/Central Universities/Institutes of eminence or from Private Universities accredited and awarded at least “A grade” by NAAC. They may be exempted from Ph.D. course work by the Vice-Chancellor subject to the condition that such candidate has to follow the complete admission process of the Ph.D. Programme. The validity of the course work will be three years from the year in which he/she passed the Ph.D. course work. The candidate will be required to **submit the fee mentioned in clause 13.4 along with Registration fee and Caution money (Refundable) and Alumni Fee mentioned in clause 13.3 of the Chapter-13 (Fee Structure).**
- v) Category (SC/BC, PH/(Differently-abled persons) / ESM / FF) certificate for Reservation in proper format and Income & Asset Certificate for claiming benefit of reservation under EWS. The specimen formats are given from **Annexure B-I to B-VII.**
- vi) Character Certificate along with attested copy.
 - (a) **For Candidates who have recently qualified:**
The candidates, who have recently passed the qualifying examination, must submit Character Certificate from the Head of the Institution last attended as per specimen given in **Annexure B-VIII.**

(b) Private/Distance Education Candidates:

The candidates who have passed the qualifying examination as private candidates **or through Distance Education mode** should submit their Character Certificate duly signed by a First-Class Executive Magistrate.

(c) Gap in Study:

The candidates, who have gap in their academic career after the qualifying examination, must furnish a gap certificate, in the form of affidavit on non-judicial paper or certificate from the employer (if in service) and should also furnish a separate character certificate of gap period duly attested by Notary Public.

- vii) Certificate of Bonafide Resident of Haryana. The candidates who have passed their qualifying examination through regular mode from a University/College/School situated within the State of Haryana, will be deemed to be Haryana Residents and need not submit certificate of Bonafide Resident of Haryana. All others are required to submit the same in the format prescribed at **Annexure-A-IV**.
- viii) Proper "Income" certificate / Affidavit in case of SC/BC candidates seeking any concession.
- ix) The Employee wards seeking admission on the seat reserved for them and **Foreign Nationals or SRF having project under the mentorship of GJUS&T faculty member** should also submit Consent/ Recommendation of his/her supervisor of the concerned subject before start of counselling. (The consent given by the supervisor should remain within limit as per **subclause-11.2 of clause-11 of Chapter-12: Ordinance-Doctor of Philosophy of the Information Brochure-Ph.D.**)
- x) 'No Objection Certificate' issued by the competent authority for pursuing Ph.D. programme in the format available at Clause-14 of the Ordinance-Doctor of Philosophy available at Chapter-12 of this Information Brochure, if employed. The relieving certificate alongwith orders of sanction of leave issued by the present employer of the candidate is required to be submitted in the concerned department of the university within two weeks of admission in Ph.D. programme.
- xi) Original Migration Certificate issued by the last attended institute/university.

If a candidate is not able to submit the migration certificate at the time of counselling for one or the other reason, he/she will have to submit the same before the commencement of course work examination without any late fee or upto the date of approval of research synopsis by DRC with late fee of Rs. 1000/- failing which his/her candidature for the Ph.D. programme shall stand cancelled automatically. However, the same may be regularized by the Vice-Chancellor with late fee of Rs. 2000/-

- 6.2 The Chairperson of the Department concerned shall forward one set of above documents duly attested by him, submitted by the candidate to the Registration Branch within 15 days of the admission of the candidates.

CHAPTER-7

ADMISSION OF FOREIGN NATIONALS

- 7.1 The Ph.D. seats for foreign students will be supernumerary in nature.
- 7.2 Foreign nationals should submit the consent/recommendation of research supervisor of the concerned subject at the time of applying for admission in Ph.D. programme. The consent may be obtained through the online correspondence.
- 7.3 Foreign nationals should bring the equivalency of degree from Association of Indian Universities (AIU), New Delhi within a period of three months from the date of admission in the University failing which the admission shall stand cancelled.
- 7.4 Fee (inclusive of all kinds of fees) : US \$ 1000 per half year

CHAPTER-9

SCHOLARSHIPS/FELLOWSHIPS

9.1 UNIVERSITY RESEARCH FELLOWSHIP:

Each eligible Department will have two fellowships every Year. The amount of the fellowship shall be Rs. 15000/- per month after confirmation of registration. It will be tenable for two years from the date of admission/joining in the course work. The fellowship may be extended only for one more year i.e. 3rd year by the Vice-Chancellor, on the recommendation of the committee consisting of the Chairperson, one Professor/Associate Professor of the department and the Supervisor of the Scholar subject to the condition that Scholar has published at least one Research Paper. Each scholar receiving this fellowship shall also receive a contingency amount of Rs. 10000/- per annum.

In addition to above, URF (six or 20% of the allocated URF in the academic session whichever is higher) will be allowed to SC candidates.

Criteria for the selection/award of URF will be on the basis of qualifying combined merit of admission for Ph.D. programme.

The contingency amount of Rs. 10000/- per annum may utilized for consumables, minor equipments, stationary, travel, registration fee for attending conferences/seminar, workshop within India with the prior approval of the Chairperson of the Department on the recommendation of the Supervisor.

The non-consumable articles purchased out of the contingency amount will be first entered in the stock register of the Store of the concerned Department and then the article will be issued to the research scholar(s) so as to ensure that on expiry/termination/relinquishment of fellowship by scholar/supervisor, these are to be returned to the Department by the scholar.

The unspent balance, if any, out of the contingency amount of the previous year will not be carried forward to the next year.

9.2. STUDY GRANT SCHEME FOR Ph.D. SCHOLARS IN THE FIELD OF SOCIAL SCIENCES:

The Indian Council of Social Science Research, North-Western Regional Centre, MHRD has a Study Grant Scheme for scholars who are doing Ph.D. in the field of Social Sciences for consulting Libraries/Archives/Data Centres in different cities/town in India for collecting research material. The purpose of study grant is to provide financial assistance to Ph.D. scholars in the field of Social Sciences. Therefore, interested Ph.D. scholars may find detailed information and Application form for above said scheme from the website www.icssrnwrc.org.in.

9.3 HSCST FELLOWSHIP PROGRAMME:

The Haryana State Council for Science & Technology (HSCST), Panchkula has introduced fellowship programme for students pursuing Ph.D. in science subjects. Under this scheme, fellowships are awarded to students holding M.Sc. or equivalent degree, with minimum 55% marks and on the basis of their performance in National Eligibility Test (NET) conducted by CSIR twice in a year. The research fellowships are in science subjects, namely Life Science, Physical Science, Chemical Sciences, Mathematical Sciences, Engineering Sciences and Earth Atmospheric Ocean & Planetary Sciences etc. The maximum period of fellowship is five years and the amount is Rs.18000/- per month for the first two years and Rs.21000/- per month for the 3rd year onwards. The fellowship carries an annual contingency grant of Rs. 20000/-. However, any change in amount of fellowship from time to time will be applicable. The details of the scheme are available on HSCST website www.dstharyana.org.

*As per Haryana Govt. notification dated 15th may 2020, 15th may 2020, fifty percent of the twenty percent seats reserved for scheduled castes for admission shall be set aside for candidates belonging to deprived scheduled castes as enumerated in the Annexure enclosed with the Govt. notification. Where a seat is set aside for candidate from the deprived scheduled castes for

admission in Govt. Education Institutions is not filled up due to non-availability of candidate of the deprived scheduled castes possessing the requisite qualification, the same will be made available to the candidate of schedule castes.

*Further, as per Haryana Govt. notification No. 22/163/2024-5HR-III dated 13th November, 2024 issued from Haryana Govt. Chief Secretary Organization Human Resources Department (Human Resources-III Br.), the Scheduled Castes in Haryana has been categorized in two subcategories i.e. Deprived Scheduled Castes (DSC) and Other Scheduled Castes (OSC) as per List enclosed at **Annexure A-1. Within existing 20% quota reserved for Scheduled castes for the purpose of direct recruitment to Govt. Jobs as well as admission in Government/Government Aided Educational / Technical Professional institutions. One half of the quota within 20% quota shall be reserved for candidates belonging to Deprived Scheduled Castes. If and only if suitable candidates of Deprived Scheduled Castes are not available, then suitable candidates of Other Scheduled Castes may be admitted against the balance Seats. Similarly, one half of the quota reserved for Scheduled Castes shall be reserved for candidates belonging to Other Scheduled Castes. If and only if suitable candidates of Other Scheduled Castes are not available, then suitable candidates of Deprived Scheduled Castes may be admitted against the balance seats.**

As per letter No. 22/12/2019-1GS-III dated 25th February, 2019 of Govt. of Haryana General Administrative Department, the persons belonging to Economically Weaker Sections (EWSs) who are not covered under the existing scheme of reservation for Scheduled Castes, Backward Classes (Block-A) and Backward Classes (Block-B) shall get 10% reservation in admission to Government/ Govt. Aided Institutions in the State of Haryana. The Director General Higher Education, Haryana vide Memo No. KW30/3-2019 Co (2) dated Panchkula, the 07.06.2019, has clarified that the calculation for the purpose of reservation for Economical Weaker Section (EWS) be done on the existing number of seats.

The Director Higher Education, Haryana vide its Memo. No. KW303/3-2019 Co. (2) dated 24.06.2021 has further clarified that 10% reservation for Economical Weaker Section (EWS) will be 50% of the State Quota and will be 42.5% of the total intake (i.e. 50% of General Category out of 85% of Haryana domicile).

****In the event of quota reserved for physically handicapped remains unutilized due to non-availability for suitable category of handicapped candidates, it may be offered to the Ex-servicemen and their wards (1%) and the dependents of Freedom Fighters (1%).**

Further, 3% Horizontal reservation is also provided to Ex-servicemen/ Freedom Fighters and their dependents by providing reservation within reservation of 1% of General Category, 1% out of Scheduled Castes and 1% from Backward Classes category for admission to the various educational institutions of the Government and Government aided/ institutes located in Haryana. As far as block allocation in Block A and Block B of Backward Classes category is concerned year wise rotational system will be adopted. For example, if 'A' Block of Backward Classes are given seats in the academic year 2006, the next block i.e. 'B' Block of category to Backward Classes will be given seats in the next academic year i.e. 2007 and so on.

The criteria for exclusion of persons within the Backward Class as creamy layer notified vide Notification No. 40/13/2024-1SW dated 16th July, 2024 by Haryana Government Social Justice, Empowerment, Welfare of Scheduled Caste and Backward Classes and Antyodaya (SEWA) Department will be applicable.

(C) Important Instructions for Reserved Category Seats:

- 1) The reservation of seats is as per the Reservation Policy of the State Govt. and is subject to any change/ amendment by the State Govt. from time to time. The distribution

and reservation of seats for various categories **for admission to Ph.D. course (2025-26)** as per above guidelines of Haryana Govt. is given at the end of this chapter.

- 2) All the eligible candidates whether from Haryana or from Reserved Categories shall also compete for seats allocated under All India Category.
- 3) All eligible candidates of reserved categories shall be considered first for Haryana Open General Category seats.
- 4) For Haryana Resident (Refer to **Annexure A-IV**)
- 5) Govt. of Haryana letter No. 62/62/2011-6 GSI dated 17th January, 2012 regarding grant of Bonafide resident of Haryana, the State Govt. has decided that the children/wards/ dependents of the employees of Punjab & Haryana High Court, who are discharging their duties in connection with the affairs of the State of Haryana and have not availed facility from their parent State, the State of Punjab and U.T. Administration Chandigarh, would also be eligible for grant of Resident Certificate of the State of Haryana only for the purpose of admission in academic/ technical/ medical Institutions of the State of Haryana.
- 6) Candidates claiming reservation under Scheduled Caste category are required to submit the certificate as per **Annexure B-II** and Backward Class (Block 'A' & 'B') candidates on the prescribed proforma as per **Annexure B-III**.

The BC candidates (Block 'A' & 'B') for benefit of reservation shall also have to furnish an affidavit / undertaking to the effect he/she is not covered under the criteria of creamy layer as per **Annexure B-IV**. The said Affidavit/ Undertaking shall be furnished

- both by the father and mother of the candidates.
- 7) The candidates claiming reservation under EWS are required to furnish an Income and Asset Certificate as per prescribed format at **Annexure-B-V**
 - 8) Only those candidates having a permanent disability of not less than 40% (being otherwise fit for admission to the course) will be considered for admission (on seats reserved for PH / Differently-abled person of Haryana). "Differently-abled persons" Certificate must be from the Chief Medical Officer of the concerned District. "Differently-abled" candidates belonging to Haryana are required to submit the certificate as per **Annexure B-VI**.
 - 9) Children & grand-children (Maternal & Paternal) of Freedom Fighters of Haryana who wish to be considered for reservation must submit a certificate from the Deputy Commissioner of the concerned District (**Annexure B-VII**).
 - 10) Candidates who have passed their qualifying examination in **regular mode** from a University/ College/ School situated within the State of Haryana, will be deemed to be Haryana Residents and will not be, required to submit certificate of Bonafide Resident of Haryana. All others are required to submit the same as per format prescribed in **Annexure-A-IV**.
 - 11) A candidate, who applied for both-reserved and general categories, will be considered first in general category. In case, he/she is not selected in General Category, he/she will be considered in reserved category. In case a candidate who applies for two reserved category seats, e.g. for SC/ESM, BC/ESM etc. will be considered in both the categories as per merit in respective category.
 - 12) The seats remaining vacant under reserved category will be filled up in the manner indicated in the **Chapter-11: "Counselling" of this Ph.D. Information Brochure-2025-26**.
 - 13) If the seats reserved for "differently-abled persons" remain vacant due to non-availability of suitable "differently-abled persons", it may be offered to Ex-servicemen and their wards (1%) and dependents of Freedom Fighters (1%). The reservation policy is subject to revision/State Government decision and the same, as applicable on the last date of submission of admission form, shall be followed.
 - 14) If a candidate is admitted on the basis of claim that he belongs to the State of Haryana but at any subsequent time it is discovered that his claim was false, his admission shall stand cancelled and all fees and other dues paid by him/her shall be forfeited. The University may take such other action against the student and his/her parents/ guardians as it may deem proper in the circumstances of any particular case.

If and only if suitable candidates of Deprived Scheduled Castes are not available, then suitable candidates of Other Scheduled Castes may be admitted against the balance Seats. Similarly, one half of the quota reserved for Scheduled Castes shall be reserved for candidates belonging to Other Scheduled Castes. If and only if suitable candidates of Other Scheduled Castes are not available, then suitable candidates of Deprived Scheduled Castes may be admitted against the balance seats.

CHAPTER-11

COUNSELLING

There will be two counsellings for admission to Ph.D. Programme.

11.1 Documents required at the time of Counselling:

All original certificates mentioned in Chapter-6 along with two sets of self-attested photocopies of the same.

11.2 Counselling Procedure:

- I. It is mandatory for all candidates seeking admission to attend the counselling, as per the notified schedule given in Chapter-4 of this Information Brochure. On the day of counselling, the candidates will be called for counselling /admission on their turn in order of merit.
- II. The counselling will start at 10.00 am as per the schedule in the office of respective Chairperson/Director of the department/school of the university for admission to Ph.D. Programme for the session 2025-26 (Summer Term).
- III. The candidate, who reports late i.e., after his/her name had been called, will be considered subject to availability of seats at that point of time in the respective category.
- IV. The venue of the counselling will be the respective Departments. Any change in the venue will be notified on the University website/departmental notice board.
- V. The candidate is required to be present before the Admission Committee of respective department to mark his/her presence and discuss his/her research area and then he/she will produce all original certificates for verification and checking his/her eligibility for the programme for which he / she is eligible.
- VI. On ascertaining the eligibility, the Committee will allot the seats as per merit/ preference subject to availability of seats.
- VII. The Committee will issue provisional admission letter, on the basis of which the candidate will have to deposit fees **as per Fee prescribed at Chapter-13: Fee Structure** on the spot through online mode failing which their admission shall stand cancelled.
- VIII. After that, the candidate will report to the Chairperson/Director of the department/ school to get his/her provisional Regn-cum-Roll No., time table, Library card, Hostel accommodation etc.
- IX. If any candidate fails to deposit his fee on the day of 1st counselling, his seat/admission shall be forfeited and vacant seat so arisen and all other vacant seats will be filled in 2nd counselling from the same merit list of 1st counselling from those candidates who attended the 1st counselling.

- X. The seats remaining vacant in reserved category **and seats remaining vacant in Economically Weaker Section (EWS)** in 1st phase (10:00 a.m. to 1:00 p.m.) of the 2nd counselling will be converted into General Category of Haryana (HOGC) in 2nd Phase (2:00 p.m. to 5:00 p.m.). **However, the vacant seat(s) of DSC will be offered to eligible candidates of OSC before conversion into General category of Haryana (HOGC). Similarly, the vacant seat(s) of OSC will be offered to eligible candidates of DSC before conversion into General category of Haryana (HOGC).**

The seats of BC-A or BC-B category remaining vacant will be filled by drawing combined merit list of the eligible candidates belonging to these categories before conversion into General category of Haryana (HOGC). Similarly, the vacant seats of “differently-abled person” category will be filled from the eligible candidates of ESM/FF category, on merit before conversion into General category.

11.3 Important Note for Counselling:

- I. Request for changing the date of counselling will not be entertained. The counselling also establishes the identity and antecedents of the candidates. All original certificates will be verified at the time of counselling.
- II. The mere fact that an applicant has been called for the counselling does not guarantee admission to Ph.D. programme. The admission will exclusively depend upon the number of seats available in a course. The seats will be filled exclusively on the basis of relative merit of the candidates under each category.
- III. At present, no seat is available under ESM/FF category. But, if the seats reserved for the “PH/Differently-abled persons” remain vacant due to non-availability of eligible candidates for such seats, the same shall be offered to the Ex-servicemen and their wards and the dependents of Freedom Fighters in order of merit, i.e. one who amongst these two categories is higher in merit will get the seat.

CHAPTER-12

ORDINANCE-DOCTOR OF PHILOSOPHY

In accordance with UGC (Minimum Standards and Procedure for the Award of Ph.D. Degree) Regulations, 2022

(w.e.f. July, 2025)

1. The Regulations contained in this Ordinance may be called Guru Jambheshwar University of Science & Technology (GJUS&T) Minimum Standards and Procedure for award of Ph.D. Degree.
2. These Regulations shall apply to Guru Jambheshwar University of Science & Technology and its affiliated Colleges/Institutes/Departments/School
3. The Degree of Doctor of Philosophy (Ph.D.) may be awarded in various Faculties/School of the University.
4. Research in the University leading to the Degree of Doctor of Philosophy shall be governed by various Boards of Studies & Research in the Departments/School subject to the general guidelines issued by the Academic Council.
5. The students registered in Ph.D. Programme shall be called as Research Scholar. There shall be two categories of research scholars; Full Time and Part Time.

Full time scholars shall remain present in the University for conducting their research work minimum for a period as mentioned under Residential Requirement as per clause 14.

The scholars getting fellowships will have to remain on campus throughout their research work during their fellowship period.

Part time scholars will be full time working professionals working in National Research Organizations/Labs, industry, government organizations/departments/Public Undertaking/Autonomous Bodies, Regular/Permanent Teachers working in Govt. Colleges/Govt. Aided Colleges/State Universities/Central Universities; Regular teachers, Teachers working on contract basis in the minimum basic salary of Rs. 57700/- and Regular non-teaching staff of Guru Jambheshwar University of Science & Technology. They will be allowed exemption from the stay period provided that they have access to research facilities at their places of work that are approved by the Departmental Research Committee of the Department concerned. A Part time scholar shall have contact hours with their supervisors for minimum of 180 hours per year till submission of the thesis. The seat will be supernumerary in nature. The admissions to Part time Ph.D. Programme will be offered in Winter Term.

6. Academic Eligibility

A candidate who wishes to be accepted as a candidate for Ph.D. programme must satisfy the following academic criteria:

- i) A Master 's degree programme (1-year/2-semester Master's degree after a 4-year/8-semester Bachelor's degree programme or a 2-year/4-semester Master's degree after a 3-year Bachelor's degree programme in the subject concerned or in an allied subject or **qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body** with at least 55% marks **(50% for SC/ST, OBC (BC-A & BC-B non-creamy layer), Differently-abled candidates having at least 40% disability and Economically Weaker Section (EWS) of Haryana)** in aggregate or its equivalent grade in a point scale wherever grading system is followed or an equivalent degree from a foreign educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of the educational institutions.
- ii) **For Haryana School of Business:** A Master's degree programme (*1-year/2-semester Master degree after a 4-year/8-semester Bachelor's degree programme or 2-year/4-semester Master degree after a 3-year Bachelor's degree programme*) or any other degree recognized equivalent thereto in Business Administration or Economics or Commerce or in allied subjects or Two years Post Graduate Diploma in Management recognized as equivalent to MBA by AICTE/AIU or Graduates having passed their final examination of the Institute of Chartered Accountants of India with 55% marks **(50% for SC/ST, OBC (BC-A & BC-B non-creamy layer), Differently-abled candidates having at least 40% disability and Economically Weaker Section (EWS) of Haryana)** in aggregate or its equivalent grade in a point scale wherever grading system is followed.
- iii) For any inter-disciplinary research, Ph.D. degree will be awarded by the Faculty of the Department concerned in which the candidate is registered.
- iv) The State Govt. reservation policy will be followed for admission in Ph.D. programme.

NOTE: The allied/relevant subject will be decided by the Admission Committee of the department concerned.

7. Procedure for Admission to Ph.D. Programme

- i) The admission in Ph.D. Programme shall be made twice a year in two terms i.e. Summer Term (July to December) and Winter Term (January to June). The course work shall also be conducted two times accordingly.
- ii) Applications for enrolment to Ph.D. Programme shall be advertised twice a year normally in the month of April/May for Summer Term and in the month of October/November for Winter Term.
- iii) The Academic Session shall be treated from 1st July to 30th June of the subsequent year.
- iv) The Teaching Departments/School/GJJM Institute of Religious Studies of the University shall declare the total seats **twice a year for Ph.D. admission in beginning of each term (Summer Term & Winter Term) of the academic session.** The University shall notify the number of seats to be offered by each Department/School/Institute for admission to Ph.D. programme **on biannual basis as per** schedule decided from time to time in accordance with the State reservation policy strictly. The number of seats once declared shall not be increased in any circumstance.
- v) **Admission of the candidates shall be made in the following manners:**
 - a) **Without Entrance Test:** The admission to Ph.D. Programme of the candidates having qualified for UGC-NET/UGC-CSIR-NET, UGC/ UGC-CSIR-JRF(valid) in the subjects where NET is conducted by the UGC/UGC-CSIR, candidates having qualified for JRF through Biotechnology Eligibility Test (BET) conducted by DBT, candidates qualified for award of JRF(valid) through National Level Test conducted by Indian Council for Medical Research (ICMR) and similar national level test with qualified certificate with JRF award letter, candidates having Provisional DST INSPIRE Fellowship (one year validity subject to the final offer of fellowship as per criteria of DST failing which admission to Ph.D. shall be treated cancelled) shall be made on the basis of Interview without Entrance Test (except Ph.D programme in Subject of Electronics & Communication Engineering where admission will be made on the basis of Entrance Test as mentioned in subclause-b) ahead).
 - b) **Through Entrance Test:** The admission to Ph.D. Programme in the subjects where UGC does not conduct NET examinations i.e. in Engineering/Technology Programmes (Mechanical Engineering, Electronics & Communication Engineering, Electrical Engineering, Printing Technology, Food Technology etc. except Computer Science & Engineering as NET examination is conducted by UGC-CSIR in Computer Science), Data Science & Artificial Intelligence, Pharmaceutical Sciences and Physiotherapy, shall be made through Entrance test (to be conducted in Winter Term as per schedule notified by the University) followed by an Interview.
 - c) The interview shall be intended to test the research acumen of the candidate. The candidate shall appear before Interview committee for interview with a concept note of 500 words about research. The Interview shall be of 30 marks and the candidate must obtain at least 50% marks in order to qualify the

interview. The number of candidates called for interview may be decided by the Department concerned on the basis of number of Ph.D. seats available.

d) The Interview Committee for conducting Interview for Ph.D. admission in a department/School shall consist of the Chairperson/Director of Department/School, one Professor, one Associate Professor, one Assistant Professor on seniority and rotation basis, and three senior teachers (01 Professor, 01 Associate Professor and 01 Assistant Professor) if available amongst teachers who gave seats for Ph.D. admission.

vi) **Summer Term:** The Ph.D. seats will be offered to the candidates at subclause v) a) above in the following preferences as per merit criteria mentioned in subclause-x A:

- a. UGC-NET/UGC-CSIR qualified candidates declared eligible in **category-1 (Eligible for admission to Ph.D. with award of JRF (valid), Assistant Professor)**
- b. The candidates qualifying for award of JRF (valid) through BET conducted by the Department of Bio Technology.
- c. The candidates qualifying for award of JRF through national level examination conducted by Indian Council for Medical Research (ICMR).
- d. Candidates having Provisional DST INSPIRE Fellowship (one year validity subject to the final offer of fellowship as per criteria of DST failing which admission to Ph.D. shall be treated cancelled)
- e. UGC-NET/UGC-CSIR qualified candidates declared eligible in **category-2 (Eligible for i) admission to Ph.D. without JRF and ii) appointment as Assistant Professor).**
- f. UGC-NET/UGC-CSIR qualified candidates declared eligible in **category-3 (Eligible for admission to Ph.D. programme only and not for award of JRF or appointment as Assistant Professor).**

Note: The marks obtained in the UGC-NET /UGC-CSIR NET by the candidates in Categories 2 and 3 will be valid for a period of one year for admission to Ph.D.

No admission through Entrance test will be offered to Ph.D. Programmes in Summer Term. Further, admissions to Ph.D. Programme of Engineering/Technology except Department of Computer Science & Engineering, and Ph.D. programmes in Data Science & Artificial Intelligence, Physiotherapy, Pharmaceutical Sciences shall also not be made in Summer Term.

vii) **Winter Term:** The Ph.D. seats for admission to Ph.D. programmes shall be offered to the candidates in both manners mentioned at subclause (v) i.e. **a) without Entrance Test** for the subjects where NET is conducted by UGC/UGC-CSIR as mentioned at subclause (v)a) in the preferences mentioned in subclause (vi) above as per merit criteria mentioned in subclause x) **A ahead** and **b) Through Entrance Test** for subjects mentioned at subclause (v) b) as per merit criteria mentioned at clause x) **B ahead**. The syllabi of Entrance Test will be decided by the concerned Teaching Departments/School based on **(50 % research methodology and 50% subject specific based on core courses of the qualifying Post Graduate programme)**. The detailed syllabi shall be uploaded by the department on the University Website.

Conversion of vacant reserved category seats to Haryana Open General Category (HOGC) shall take place as per procedure mentioned in Chapter of “Counselling” of the Ph.D. Information Brochure published in each term.

- viii) Entrance Test will be of 100 marks and a candidate must secure 50% marks (45% marks for **SC/ST, OBC (BC-A & BC-B non-creamy layer), Differently-abled candidates having at least 40% disability and Economically Weaker Section (EWS) of Haryana**) to qualify the same.
- ix) **The seats for following categories of candidates will be treated supernumerary in nature and their admissions will be subject to the prior consent of teacher in the departments/school (one teacher may give consent to one candidate only) as per eligibility and availability of seats under him/her mentioned under Clause-11 of this Ordinance:**

A) Seats for the candidates to be Enrolled in Ph.D. Programme-Part-Time mode to be offered in Winter Term:

The candidates enrolled for Part-Time Ph.D. Programme are required to qualify UGC/UGC-CSIR NET National Eligibility Test (Category-1/2/3) in the subjects where the UGC conducts the National Eligibility Test and the candidates applied for Ph.D. Programmes in other subjects/disciplines where UGC does not conduct National Eligibility Test are required to qualify the Entrance Test conducted for admission to Ph.D. All the candidates are also required to appear for interview before Interview Committee. The following categories of the candidates may enrol for Part-Time Ph.D. Programme.

- a) Regular teachers of Guru Jambheshwar University of Science & Technology.
- b) Regular Non-teaching employees of GJUS&T, Hisar having five year experience
- c) Teachers working on contract basis in GJUS&T, Hisar.
- d) Regular/Permanent teachers working in Govt. Colleges/Govt. Aided Pvt. Colleges/State Universities/Central Universities
- e) Candidates having experience of at least 05 years in relevant field as First Class /Class-A Officer (Level-10 and above in pay matrix as per 7th Pay commission or Grade Pay of Rs. 5400-15600 or above) at the level of Managers, Senior Scientists, Senior Administrators working in various Govt. Organizations/State Universities/Institutes of National Repute/National Research Organizations/Public Undertakings/Autonomous Bodies **OR** professionals having experience of 05 years as Deputy General Managers/General Managers or (equivalent thereof) or Deputy Director/Director (Equivalent thereof) working in Industry registered with the Registrar of Company under the latest Companies Act in Govt. of India.

B) The SRF awardee from various national funding agencies like UGC/ICMR/CSIR etc. working under the mentorship of faculty member of GJUS&T. He/She is not required to take Entrance Test for admission to Ph.D. however he/she will have to appear for interview for Ph.D. admission. He/She will be registered only with the faculty under the mentorship of whom he/she works on the project assigned to him/her.

C) One supernumerary seat for children/wards of the regular University Employee in each University Teaching Department/School/Guru Jambheshwar Ji Maharaj Institute of Religious Studies.

If more than one candidate applies for admission on this seat in a Department/School, the merit will be decided as per separate merit list drawn as per subclause x) A mentioned ahead for those who are not required to appear in Entrance Test for Ph.D. (i.e. for Entrance Test Exempted category), and as per sub clause x) B for those who are required to appear in the Entrance Test to get admission in Ph.D.

The children/wards of the University Employee shall be first considered in the merit list of General candidates/respective reserved categories competing for the advertised Ph.D. seats before being considered for the supernumerary seat reserved for them.

D) One supernumerary seat with each teacher in each University Teaching Department/School/Guru Jambheshwar Ji Maharaj Instt. of Religious Studies for International Students. These students shall be exempted from Entrance Test for admission to Ph.D. Programme subject to the fulfilment of the eligibility condition mentioned at Clause-6 (**Academic Eligibility**). Their admission shall be made on first come first serve basis as per guidelines/ norms decided by the office of Dean International Affairs (formally Dean International Students) from time to time.

x) The merit list for admission to Ph.D. Programme shall be prepared by Department/School according to the following criteria:

A. For candidates exempted from Entrance Test:

a. UGC-NET/UGC-CSIR-NET qualified candidates declared eligible in **category-1 (Eligible for admission to Ph.D. with award of JRF (valid), Assistant Professor and Ph.D. Admission), JRF valid awarded by DBT, ICMR mentioned at clause 7vi) a, b,c**

Merit prepared on the basis of performance of Interview as per provision of preference (separate merit list for each preference given at 7 vi)

b. UGC-NET/UGC-CSIR qualified candidates declared eligible in **category-2 (Eligible for i) admission to Ph.D. without JRF and ii) appointment as Assistant Professor).**

- i) 70% weightage of marks obtained in NET examination
- ii) 30% weightage of performance in Interview.

- c. UGC-NET/UGC-CSIR qualified candidates declared eligible in **category-3 (for Ph.D. admission only without JRF and Assistant Professor)**:

- i) 70% weightage of marks obtained in NET examination
- ii) 30% weightage of performance in Interview.

Note:

- i) The separate merit list for each category of candidates UGC/UGC-CSIR NET, DBT-NET, ICMR-NET etc. will be prepared as per provision of preferences given at clause 7 vi)
- ii) The marks obtained in the NET by the candidates in Categories 2 and 3 will be valid for a period of one year for admission to Ph.D.

B. For the candidates Passing Entrance Test

- i) 70% weightage of marks in the Entrance Test.
 - ii) 30% weightage of performance in Interview.
- xi) The admissions in Ph.D. Programme shall be made through separate counselling to be organized by the Department/School concerned for the candidates exempted from Entrance Test and the candidates to be admitted through Entrance Test as per schedule mentioned in Admission Information Brochure.
 - xii) The number of seats for Ph.D. Programme in each subject will be as per availability of seats in the respective Department/School of the University.
 - xiii) The Admission Committee of the Department will consist of the Chairperson of the Department, one Professor, one Associate Professor, one Assistant Professor by seniority and rotation and a nominee of the Vice-Chancellor. All these members must satisfy eligibility conditions to be the Ph.D. Supervisor. If any of the faculty (Professor/Associate Professor/Assistant Professor) is not available in the Department concerned, faculty members from other departments within the same faculty may be associated with the Admission Committee with the prior approval of the Vice-Chancellor.
 - xiv) The result of Entrance Test will be considered for admission to Ph.D. only during the session in which the test was held and the same will not be considered in the subsequent year(s), that is, if a candidate wants to be considered for admission next year, he/she will have to appear for the entrance test afresh.
 - xv) The candidate standing in merit list prepared as per criteria in sub-clause x) will be given provisional admission in Ph.D. Program with the submission of required fee prescribed in clause (25) of the Ordinance or to be prescribed time to time. The admitted candidates will be allotted provisional Enrolment No./Registration No. by the University. The provisional Enrolment No. allotted to the scholar will become the Registration No. as and when his/her registration for Ph.D. programmes recommended by the BOS&R of the Department/School concerned is approved by the Vice-Chancellor.

8. Course Work

- i) The duration of the Ph.D. coursework will be of one semester. It will be offered in the first semester. It will consist of 04 papers.
- ii) Each paper of the course work PPD-101 & PPD 103 will be of 4 credits. The papers PPD-102 & PPD-104 will be of 02 credits each. 4 credits paper will be of 100 marks and 2 credits of 50 marks as per scheme.
- iii) The scheme for Ph.D. coursework is as under:

PPD-101: Research Methodology: The syllabus of the course PPD-101: "Research Methodology" will have different contents for Ph.D. programmes which are categorized in the following three broad disciplines. The content of the course should be common within a discipline.

Science Discipline: All the courses run under the Faculty of Physical Sciences, Faculty of Environmental and Bio Sciences & Technology and Faculty of Medical Sciences.

Engineering Discipline: All the courses run under the Faculty of Engineering & Technology.

Social Sciences & Humanities Discipline: All the course run under the Faculty/School of Haryana School of Business, Faculty of Media Studies, Faculty of Religious Studies and Faculty of Humanities and Social Sciences.

PPD-102: Review of Literature and Seminar - It includes discussions on research ethics, presenting a seminar on review of published research or on own published review/survey paper or training or field work done in the relevant area of research etc.

PPD-103: Departmental Elective Course

It includes an elective course related to the relevant field of research and it will be offered by the respective department/school.

(Not more than 4 departmental Elective courses will be offered by each department/School).

PPD-104: Research and Publication Ethics (RPE)

It includes basics of philosophy of science and ethics, research integrity, publication ethics.

- iv) The scholars shall review 20 to 30 research papers and shall submit the report as well as present seminar before a three members committee duly constituted by the Dean, Research and Development and headed by the Chairperson/Director or Senior teacher of the Department/School for evaluation of paper PPD-102: Review of Literature and Seminar at Departmental level.
- v) The Staff Council of the Department/School shall finalize supervisors for the candidates admitted in Ph.D. Programme within one month of the commencement of coursework so that the scholars can have necessary guidance for the paper 'PPD-102 Review of Literature and Seminar' and start preparing synopsis for their research proposal. The Staff Council shall allot supervisors in the order of merit of the candidates, while also considering the specialization of the supervisor.

- vi) The qualifying marks in each paper of the course work shall be 55% or its equivalent grade in the UGC 10-point scale. If found necessary, the Chairperson/Director of the Department/School may allow a candidate to undertake any additional paper/ course work in any sister department of the University.
- vii) There shall be an external examination of Ph.D. course work to be conducted centrally not Department wise by the Controller of Examinations. The coursework examination for Summer Term will be normally conducted in the 2nd half of December and the result will be declared within the 2nd week of January. The reappear examination for course work shall be conducted within two months of the declaration of the result of the main examination of the course work and a second chance shall be given with the batch of the Winter Term.

The coursework examination for Winter Term shall be normally conducted in the 2nd half of June and the result shall be declared within the 2nd week of July. The re-appear examination for course work shall be conducted within two months of the declaration of the result of the main examination of the course work and a second chance shall be given with the batch of the Summer Term.

- viii) It is only on satisfactory completion of Ph.D. course work, which is an essential part of the Ph.D. programme, a candidate shall be eligible to apply for registration to Ph.D. programme after successful completion of coursework. The admission of the candidate to the Ph.D. programme who fails to pass Ph.D. course work within stipulated period mentioned in sub clause-vii above shall stand cancelled.
- ix) A candidate is required to earn at least 75% attendance for the Ph.D. course work to be eligible for appearing in examination.
- x) All full time Ph.D. scholars, irrespective of discipline, shall be required to train in teaching/education/pedagogy/writing related to their chosen Ph.D. subject during their doctoral period. Ph.D. scholars may also be assigned 4-6 hours per week of teaching/research assistantship for conducting tutorial or laboratory work
- xi) A candidate who has already completed Pre-Ph.D./Ph.D. course work including the course **Research and Publication Ethics (RPE) notified by UGC vide D.O. No. F.1-1/2018 (Journal/Care) in 2019 and Research Methodology Course** as per UGC regulations from this University or from any other State/Central Universities/Institutes of eminence or from Private Universities accredited at least "A grade" by NAAC may be exempted from Ph.D. course work by the Vice-Chancellor subject to the condition that such candidate have to follow the complete admission process of the Ph.D. Programme. The validity of such course work will be three years from the year in which he/she passed the Ph.D. course work. These candidates will be required to pay the fee prescribed for the half year (applicable on the candidates after completion of course work) started from the date of admission upto the half year in which they submit the thesis along with Registration fee, Alumni fee and Caution money (Refundable) as per Fee structure prescribed by the University time to time.

- xii) The Chairperson/Director of UTD/School concerned shall maintain a list of Ph.D. Supervisor (specifying the name of the supervisor, his/her designation, and the department/School), alongwith the details of Ph.D. scholars (specifying the name of the registered Ph.D. scholar, the topic of his/her research, date of admission) admitted under them on the University website and update this list every academic year.

9. Process of Registration for Ph.D. programme

- 9.1 The candidate shall submit the Application(s) to the Chairperson/Director of Department concerned/School on the prescribed form (**Appendix-Form-‘B’**) along with synopsis for registration to Ph.D. programme so that the registration may be recommended by Departmental Research Committee (**DRC**) within **six months** from the declaration of result of the course work. The duration of six months for submission of synopsis for recommendation of registration to Ph.D. Programme in respect of the candidate having exemption in course work shall be counted from date of admission. The extension of further six months for submission of application for registration along with synopsis, on the recommendation of the Supervisor, may be given by the DRC in special circumstances on the merit of the case. If the candidate fails to submit the research synopsis even during the extension period granted by the DRC, his/her admission in Ph.D. programme shall be cancelled abinitio. However, her/his cancellation of admission may be revoked on the recommendations of DRC by the Vice-Chancellor on the merit of the case with a revocation fee of Rs. 20000/- subject to the condition that the scholar has to complete his/her thesis within the maximum period allowed in ordinance.
- 9.2 The Chairperson/Director of the Department/School concerned shall place the application(s) before the Departmental Research Committee. The candidate(s) will be invited to defend their synopsis/research proposal before DRC in the presence of Dean of concerned faculty and the Vice-Chancellor or his/her nominee. The Departmental Research Committee may
- i) Recommend the research proposal for consideration by the Board of Studies & Research (BOS&R).
 - OR
 - ii) Suggest suitable changes in the research proposal.
 - OR
 - iii) Reject the proposal.
- 9.3 The Departmental Research Committee shall consist of all the regular faculty members of the department with Ph.D. Degree. However, outside member may be associated with the permission of the Vice-Chancellor.
- 9.4 The Departmental Research Committee will adopt the following procedure:
- a) While considering the applications for registration, the DRC will consider the synopsis submitted by the candidates.
 - b) While recommending the registration of the candidate for consideration by Board of Studies & Research, the DRC shall clearly state whether in its opinion:
 - i) The subject proposed for research is suitable or not.
 - ii) The supervisor(s) is/are eligible or not.

The DRC may either reject the synopsis or may suggest suitable changes in the synopsis for reasons to be recorded. The candidate is required to resubmit the revised synopsis after having incorporated the suggested changes within a period of time specified by the Departmental Research Committee.

- c) "In special circumstances viz. in the case of subjects of interdisciplinary/multidisciplinary/inter speciality nature, the DRC may recommend a Co-supervisor who can be from within the University or its affiliated Govt./Govt. Aided Colleges running PG program in the subject concerned or from other universities (In case of Private University, it should be accredited at least "A grade" by NAAC)/Institutes of National Importance/Eminence and various Govt. Research Organization and Research Labs in the country/any autonomous institute established by the State Govt./Central Govt. as well, for reasons to be recorded. The qualifications for a Co-supervisor will be the same as prescribed for the supervisor at clause-11 of this Ordinance. The teacher to act as Co-supervisor is required to submit his consent on the prescribed proforma (Appendix-I) available on the University Website to the Chairperson of the concerned Department at the time of submission of synopsis by the research scholar for consideration of DRC."
- 9.5 The DRC shall clearly mention the Registration No., Name of the scholar, Topic of Research, Name of Supervisor, Co-supervisor if any recording full justification in its recommendations. The recommendations of the DRC for Ph.D. registration shall be placed before the BOS&R for its consideration and approval. The meeting of the BOS&R will normally be held within one month of the meeting of the DRC. The BOS&R recording the specific details of scholars as recommended by the DRC shall submit the recommended cases of Ph.D. registrations to the Vice-Chancellor for consideration and approval through Dean, Research and Development. If the BOS&R recommends the title of research with minor change in case of any scholar, the justification for the same shall be recorded by the BOS&R in its minutes.
- 9.6 The recommendations of BOS&R shall be placed before the Vice-Chancellor through Dean Research and Development for confirmation of the Registration of the scholars. After the approval of the Vice-Chancellor, the provisional admission/registration of the research scholar shall be confirmed and he/she shall be finally registered for the Ph.D. program. Consequently, the provisional enrolment number allotted to the research scholar shall become his/her Registration Number. **However, the Vice-Chancellor in cases where he deems appropriate, may refer the recommendations of the BOS&R for confirmation of Registration of the scholar of the department concerned to Academic Council for approval.**
- 9.7 The date of confirmation of registration of the research scholar shall be the same on which the BOS&R recommends the registration of the candidate. In case of research scholars with UGC-JRF, the date of joining/provisional admission in the department for Ph.D. programme shall be considered as date of registration to upload their master data on UGC portal for the purpose of grant of fellowship.
- 9.8 The Chairperson/Director of the Department/School shall make best efforts to provide infrastructural facilities to the scholars on continuous basis.

- 9.9 The Chairperson/Director of the Department/School shall provide a soft copy of the e-Synopsis of the scholar registered for Ph.D. programme to the University Library within one month of the confirmation of the registration to upload the same on INFLIBNET website as per UGC guidelines.

10. Modification in Topic of Research

A candidate may, normally not later than two years after his/her registration, modify the topic of Research on the recommendations of the Board of Studies & Research. However, minor modifications may be allowed even later on, on the recommendations of the BOS&R and with the approval of the Vice-Chancellor.

11. Qualifications of the Supervisor/Co-Supervisor

- 11.1 Any full-time regular Professor/Associate Professor of the University with a Ph.D. degree with at least five research publications in peer reviewed or refereed journals and any regular full time Assistant Professor of the University with a Ph.D. degree with at least three research publications in peer reviewed or refereed journals can act as Research Supervisor/Co-supervisor. The publications should be of high quality journals as per UGC CARE list. The conditions on publications are applicable to the co-supervisors from other universities/institutes as well. Ph.D. degree awarded by the University under the supervision of a faculty member who is not an employee of the University would be in violation of this Ordinance.

Provided that in areas/disciplines where there is no, or only a limited number of peer-reviewed or refereed journals, the Vice-Chancellor may relax the above condition for recognition of a person as Research Supervisor with reasons recorded in writing.

- 11.2 A regular teacher fulfilling the requirements as mentioned in sub clause 11.1 above, may supervise/co-supervise the following numbers of research scholars at a time:

Designation	No. of Research Scholars
Professor	08
Associate Professor	06
Assistant Professor	04

The total number of scholars under a faculty member either as supervisor or co-supervisor shall not exceed the number of scholars prescribed above in any case.

A Teacher may also supervise two Ph.D. scholars under supernumerary seats (one for International Students and one for other categories mentioned at subclause ix of clause 7 of this Ordinance) over and above his/her maximum prescribed limit as mentioned in above table. No fresh registration will be allowed by BOS&R/Vice-Chancellor to teachers who proceeded on Extra Ordinary Leaves. However, in the case of teachers on EOL/ left/superannuated, the University may allow him/her to continue to act as supervisor if major part of research work has already been completed under his/her supervision. The teachers who superannuate from the service can continue as Co-Supervisor of the scholars already registered under them after superannuation, but not after attaining the age of 70 years. In case, new supervisor in place of the

superannuated supervisor is allotted to the scholar and if the new supervisor to be allotted has reached the maximum limit of scholars, the seat of such scholar under new supervisor shall be treated over and above the limit of the scholars, he/she is entitled to supervise at that time. However, such seat will be adjusted against the seat vacated by any scholar under him in future to remain the total number of seats within prescribe limit.

Note:

- a) After the submission of Ph.D. thesis by the Research Scholar, the said seat of the teacher concerned will be considered as vacant.
- b) The GJUS&T faculty members shall obtain NOC from the University before giving their assent to become co-supervisor for Ph.D. students registered in other institutes/universities.

11.3 In case of relocation of a female Ph.D. scholar due to marriage or otherwise (due to transfer of her/her husband in case of Govt. Employee), the research data shall be allowed by the Vice-Chancellor on the recommendations of DRC/BOS&R with the consent of the supervisor to be transferred to the Higher Educational Institution to which the scholar intends to relocate, provided all other conditions in this ordinance are followed, and the research work does not pertain to a project sanctioned to the University/Supervisor by any funding agency. Such scholar shall, however, give due credit to the parent institution and the supervisor for the part of research already undertaken. Further, such female Ph.D. scholars from other State Universities may also be allowed by the Vice-Chancellor on the recommendations of DRC/BOS&R of the department concerned to be migrated to this university with the consent of the teacher provided that there is vacant seat with the teacher under which she wants to do her research work.

12. Change of Supervisor/Co-supervisor

The change of Supervisor may be allowed:

- i) In case the Supervisor has expired or has left the service of the University.

OR

- ii) By mutual consent of both the Supervisor and the Research Scholar.

OR

- iii) In case of extreme hardships where it becomes almost impossible for a research scholar to continue his/her research work with the Supervisor or in case the Supervisor or the research scholar requests for the change of Supervisor on valid/genuine grounds, the candidate or supervisor will represent to the Chairperson/Director of the Department/School, who will put the matter before the DRC and BOS&R for decision. However, the change of Supervisor in either cases will be allowed after the approval of the Vice-Chancellor.

Note: In case of change of supervisor due to his/her sad demise, the seat of the scholar under the new supervisor will be treated over and above the maximum limit of scholars, a teacher is entitled to supervise.

13. Period of Research Work

- i. Every research scholar shall submit his/her thesis within a period of six years (including Ph.D. course work) but not before three years from the date of commencement of the course work failing which his/her registration shall be treated as cancelled. The minimum and maximum period of submission of thesis for the scholars permitted exemption of course work will be 2½ year and 5½ years from the date of admission in Ph.D. Programme.

However, the candidate may be allowed re-registration for extension of further two years (upto 8th years) paying a re-registration fee of Rs. 50,000/-, in exceptional cases, by the Vice-Chancellor on the recommendations of the Supervisor and the Departmental Research Committee. The Departmental Research Committee shall give proper justification while recommending such reregistration for extension mentioning the extent of work done by the scholar. Provided that the total period of completion of a Ph.D. Programme shall not exceed eight (08) years from the date of commencement of the coursework/date of admission. All the scholars running on extension shall submit their semester fees as usual till the half year in which they submit their thesis.

- ii. The women candidates and Persons with Disability (having more than 40% disability) may be allowed an additional relaxation of two years for submission of Ph.D. thesis, one year at a time by the Vice-Chancellor on the recommendations of Supervisor and Departmental Research Committee with extension fee of Rs. 25,000/- per year. However, total period for completion of a Ph.D. programme in such cases shall not exceed ten (10) years from the date of commencement of coursework/date of admission. In addition, the women candidates may be provided Maternity Leave/Child Care Leave once in the entire duration of Ph.D. for up to 240 days. The period of maternity leave shall be considered towards counting of stipulated period of submission of thesis. The Department concerned shall issue the leave orders to this effect under intimation to the Registration Branch, Accounts Branch and Secrecy Branch.
- iii. No research scholar shall join any other regular course of study while doing research. The Vice-Chancellor may, however, allow a candidate to appear in any examination or to attend a course which is conducive to his or her research and is of minor nature, including improvement of any previous result.

14. Residential Requirement

- i. All the employed candidates seeking admission to Ph.D. programme (full time/part time) shall have to produce NOC from their employer at the time of counselling stating that:
 - a) The candidate is permitted to pursue studies on a part-time/full time basis.
 - b) His/her official duties permit him/her to devote sufficient time for research.
 - c) He/She will be relieved from the duty to complete the coursework.

After admission, they shall have to submit their leave sanction orders and relieving certificate from their employer for the entire duration of the first semester of the Ph.D. course work within two weeks of the date of admission failing which their admission stands cancelled.

- ii. Further, a three years residential requirement is mandatory for all the candidates during the entire Ph.D. Programme. The scholars getting fellowships/scholarship will have to remain on campus throughout their research work during their fellowship/scholarship period.

The supervisor concerned shall maintain the record of attendance of each scholar to ensure the fulfilment of the residential requirement and submit the same to the Chairperson/Director of the Department/School concerned on monthly basis. The supervisor shall submit a certificate to this effect to the Controller of Examinations at the time of submission of thesis.

- iii. In case, a research scholar intends to join service after the enrolment in Ph.D. course, he/she will have to submit an application to the Chairperson/Director of the Department/Institute/School concerned to seek permission from the competent authority of the University, subject to the fulfilment of stay condition required under subclause (ii).

In case, a scholar gets the service during the 1st semester of Ph.D. course work, he/she shall also submit leave sanction orders and relieving certificate from his/her employer for the remaining period for the 1st semester alongwith submission of NOC from his/her employer as mentioned in sub clause-(i) within 15 days of his appointment in service, with the application seeking permission of the competent authority

Further, if such candidate(s) has been getting any kind of scholarship from the University or from outside organizations (i.e. University Research Scholarship/Fellowship, JRF/SRF etc.), he or she shall also mention it in the application seeking permission of the competent authority and the same shall be discontinued automatically from the date of his joining in the service. The Chairperson/Director of the concerned Department/Institute/School shall inform the concerned branches about it. Such scholar shall inform the respective funding agency about the discontinuation of the fellowship through Supervisor and do the needful as per terms and condition of the fellowship.

A full time Research Scholar if selected to a regular Govt. job may be allowed to be converted to Part Time scholar after completion of course work by the Vice-Chancellor on the recommendations of Departmental Research Committee (DRC). The seat of the scholar so converted in Part Time mode shall not be treated as supernumerary. The same shall remain in the prescribed limit of scholars, a teacher is entitled to supervise as mentioned in table at sub clause 11.2 of clause 11.

- iv. A Part-Time Research Scholar will be allowed exemption from the stay period of three years provided that they have access to research facilities at their places of work that are approved by the Departmental Research Committee of the Department concerned. A Part time scholar shall have contact hours with their supervisors for minimum 180 hours per year till submission of the thesis.

15. Requirements after completion of Course Work-Ist semester

- i) Every research scholar will be required to show continuous semester wise progress after the completion of course work (Ist Semester) of his/her Ph.D. work from IInd Semester onward till the submission of the thesis and it will be monitored by the supervisor of the candidate.
- ii) Every research scholar shall be required to submit his half yearly (semester report) on the prescribed proforma (**Appendix-II**) **within 10 days of end of each semester**. The supervisor of the research Scholar will give assessment about the progress of the scholar. The Report shall be placed before the Departmental Research Committee for its evaluation in its meeting to be held preferably in the month of **January and July**. The progress report along with receipt of fee paid for that half year (Semester) will be submitted to the Chairperson/Director of the department/school concerned for record and he/she will ensure, before accepting the progress report, that the scholar has paid all fees/dues up to the period of the submission of the half yearly report. In case two consecutive six monthly (**semester**) reports are unsatisfactory, the Chairperson/Director of the Department/School, on the recommendations of the DRC may recommend to BOS&R for cancellation of the registration. However, the DRC will record in writing the reasons for the report to be unsatisfactory and issue a show cause notice to the scholar to explain his version before recommending the cancellation of registration to the BOS&R. The Chairperson of the Department concerned shall submit one copy of the filled up proforma of progress report of the scholar (Appendix-II) to the Registration Branch along with minutes of DRC.
- iii) Once in a year, the Research Scholar will present a seminar on his/her research conducted in the previous year, before DRC. This seminar will be organized by the Chairperson/ Director of the Department/School concerned.

The Ph.D. scholars shall publish two research papers [not review article(s)] relevant to the research topic/thesis having the complete address of the university with research scholar as first author, supervisor(s) as corresponding author in refereed journal(s) as per UGC CARE list. The inclusion of Co-authors from outside institutions other than Co-supervisor can only be done with prior approval (before communicating) of Dean, Research & Development with proper justification. The Ph.D. scholar is also required to present at least one research paper in international/national conference/seminar/workshop/symposium before the submission of the thesis, and produce evidence for the same in the form of certificate/acceptance letter or the reprint of the published paper. The copy of published papers and certificate of presentation(s) should also be submitted along with the Ph.D. thesis. However, only publications having the name of supervisor and affiliation of the University shall be considered.

- iv) Prior to submission of the thesis, the student shall make a Pre-submission Ph.D. presentation before DRC. It may be open to all faculty members and research students for getting the feedback and comments which may be incorporated into the draft thesis under advice of the supervisor.

16. Cancellation of Registration/Re-Registration

The Vice-Chancellor, on the recommendations of the BOS&R, may cancel the registration of a research scholar whose research work has been reported to be unsatisfactory by the Board of Studies & Research of the department/school concerned or who has not submitted his/her two consecutive progress reports before DRC or who has been found indulged in any fraudulent activity/ misconduct/ misbehaviour/ malpractice/ malfeasance/ wrongdoing/ grave indiscipline. However, if Vice-Chancellor deems appropriate, may refer the matter to the Academic Council for its consideration and approval. However, approval of Academic Council is not necessary if the scholar himself/herself requests to the Chairperson concerned for cancellation of his/her registration in Ph.D. programme. There will be no refund of fee, if any deposited by the scholar in the university in any case.

In case of cancellation of registration due to any reason except due to involvement in any fraudulent activity/ misconduct/ misbehaviour/ malpractice/ malfeasance/ wrongdoing/ grave indiscipline, the scholar may request for re-registration with a re-registration fee of Rs. 50,000/- for consideration of DRC/BOS&R. The re-registration shall be allowed by the Vice-Chancellor on the recommendation of BOS&R under the same Supervisor or new supervisor as deemed appropriate by DRC/BOS&R. The re-registered candidate shall submit the thesis under prevailing rules of Ph.D. in the University. DRC/BOS&R shall examine appropriateness of existing topic/title of research and may recommend change in case of outdated/non-relevant research proposal. After re-registration, same rules of submission of thesis as applicable on fresh registration shall be applicable on the re-registered scholar. The scholar shall pay all semester fees till the half year in which the thesis is submitted by him/her.

17. Appointment of Examiners

On submission of the application/request along with an abstract of the thesis including synopsis/chapter scheme with minimum two research publications [not review article(s)] having the complete address of the university with research scholar as first author, supervisor as corresponding author and having good impact factor, at least one certificate of participation and presentation of thesis research work in international/national seminar/conference/symposium outside Haryana, by the research scholar (irrespective of his/her session of admission/Registration) to the Chairperson duly certified and recommended by the Supervisor that his/her research work is complete and the PhD thesis is ready for submission, the supervisor will draw a list of at least **10** examiners/specialists [**02** from Haryana and Eight from different states (one from each state)] (with complete mailing address, mobile number and email address) keeping in mind their specialization for the evaluation of the thesis of her/his research scholar before DRC. The specialists recommended shall be either Professors or persons of eminence and their specialization shall be relevant to the topic of the thesis. Names of only those persons shall be recommended who are known to be physically fit and are able to undertake a journey for the conduct of viva-voce examination, if invited. Further, the Departmental Research Committee of the respective departments/school shall recommend a panel of at least **08** examiners from the list of examiners/specialists provided by the supervisor confidentially. No examiner should be from the institutes/universities located in Hisar. There should not be more than 02 examiners from the institute/universities located in Haryana. No two examiners should be from the same outside state and university/institute.

18. Submission of Thesis

- i) A scholar shall submit his/her thesis in English/Hindi medium. He/she shall submit four copies of the thesis along with six copies of the summary of the thesis in about 300 words in English/Hindi medium indicating how far the thesis embodies the result of his own research and in what respects his/her investigations appear to him/her to advance the knowledge of subject of his/her thesis. The candidate may submit the copies of the summary within one month of the meeting of DRC in which Pre submission seminar presentation was given, so that the Controller of Examinations (COE) may get the examiners appointed in anticipation of the submission of the thesis. The summary may be sent to the examiners while seeking their consents for evaluation of the thesis.
- ii) The candidate shall submit his/her thesis in e-version as well as in printed version within six months from the date on which the DRC has approved the appointment of examiners provided that the Board of Studies and Research may, for satisfactory reasons, extend the period by a maximum of another six months only subject to the condition that the extension period should remain within stipulated period of PhD programme.
- iii) The scholar shall initially submit the thesis in soft binding form alongwith soft copy of the thesis preferably in pen drive. After the evaluation of thesis by the examiners, if both the examiners find the thesis worthy of being awarded Ph.D. degree, the Secrecy Branch shall inform the scholar through the supervisor within 15 days to submit hard bound copy of his/her thesis. If the thesis has been accepted with minor changes, the Secrecy Branch will intimate the scholar through the supervisor within 15 days of receipt of both the evaluation reports. The scholar will submit the revised thesis incorporating all the changes, suggested by the examiners, in hard bound form in the Department concerned. The scholar and supervisor shall submit a signed declaration along with the Final thesis that all the modifications suggested by both the examiners have been incorporated in the final thesis. The thesis finally submitted shall be in PDF format with all the essential elements (like Title of Thesis, declaration regarding prevention of plagiarism, certificates, abstract, dedication, Acknowledgement, table of contents, list of abbreviations, list of tables and figures, list of appendices (if any), chapters, conclusion, References, list of publications, Proof of Publications) as given in **Appendix-III**. It shall be up to 200 pages typed both sides (Font - Times New Roman, Size-12 and Line spacing-1.5) excluding the pages having title, acknowledgement, contents, references etc. and shall be a piece of research work characterized either by discovery of new facts or enunciation of a new theory or theories or by fresh interpretation of known facts. In either case, it shall evince the capacity of the candidate for critical examination and judgement. The literary presentation of thesis should be of a high standard-concisely laid out in a logical sequence. It should be far from grammatical and typographical errors. The research work cited in the thesis must be referenced properly. The research scholar should save and upload each certificate and chapters in a separate file using an agreed file naming conventions in *PDF* format as given in **Appendix-IV**. All the files will be converted in PDF format and finally submit the softcopy of the final hard bound thesis preferably in pen drive.

- iv) The research supervisor will verify and certify that the scholar has submitted complete, correct and same version of thesis that is submitted in print version as given in **Appendix-V**
- v) The research scholar is also required to submit the certificates regarding compliance of UGC, Regulations 2009/2016/2022, Similarity Index of the thesis, Indexing of his/her publications based on the thesis work, Ph.D. Ordinance compliance as per format mentioned in **Appendix-VI**
- vi) The research scholar should also submit declaration/consent for assigning non-exclusive rights to archive and distribute their doctoral work through Shodhganga as well as through university's IPR in full-text. A draft copy of the Form is enclosed as **Appendix-VII**.
- vii) The research scholar should register himself/herself on Shodhganga web site and create an account so as to submit his/her thesis, create metadata for his/her thesis based on bibliographic information and assign appropriate keywords/descriptors.
- viii) Further, the thesis will be uploaded only after the award of degree.

19. Evaluation of Thesis

19.1 The thesis shall be finally referred to two examiners, out of which at least one shall be from outside the State, selected by the Vice-Chancellor from the panel drawn by DRC. The evaluator will state categorically whether in his or her opinion:

- a) Thesis should be accepted for the award of Ph.D. Degree;
OR
- b) It should be referred to the scholar for presenting it again in revised form;
OR
- c) It should be rejected.

The evaluator shall state reasons for approval or rejection of the thesis. If he or she recommends re-submission/ rejection, he or she shall specifically indicate what modifications he or she wants the candidate to effect and incorporate in the thesis.

In case one of the examiners rejects the thesis, the Vice-Chancellor will send the thesis for evaluation to the third examiner for taking a final decision. If the third examiner also does not recommend acceptance of the thesis, the thesis shall be rejected and the Ph.D. scholar shall be declared ineligible for the award of a Ph.D. If the examiner(s) recommends re-submission with modifications, in that case the candidate shall be asked to modify the thesis and submit the same after having carried out all the modifications within a year with a certificate from the supervisor(s) that all the modifications have been carried out as suggested by the examiner.

A re-submitted thesis shall be examined by the examiner(s) who evaluated the original thesis unless any of them is unable or unwilling to do so in which case substitute(s) shall be appointed from the panel by the Vice-Chancellor. The examiner(s) for the revised thesis will only see whether the objections raised have been met or not.

19.2 A candidate whose thesis is rejected shall not be registered again for the Ph.D. Degree with the same topic.

20. Viva-Voce Examination

- 20.1 The viva-voce examination shall be held by a Board of Examiners consisting of Supervisor and one of the examiners who evaluated the thesis, to be nominated by the Vice-Chancellor, within a period of one month of the receipt of reports of evaluation of thesis through online/offline mode. In case both the examiners who evaluated the thesis are unable to conduct the viva-voce, the Vice-Chancellor shall appoint another examiner out of the panel to conduct the viva-voce examination.
- 20.2 The offline viva-voce examination shall, unless ordered otherwise by the Vice-Chancellor, be held in the University at Hisar. The date, time and subject of the thesis shall be notified by the Chairperson/Director of the Department/ School concerned among the teachers and the research scholars of the faculty concerned, who may be permitted to be present at the time of the viva-voce examination. The teachers/scholars permitted to be present shall be allowed to ask any questions to the examinee, once the viva by the external expert is over.
- 20.3 After the viva-voce examination, the reports of all the examiners shall be placed before the Research Degree Committee consisting of the Vice-Chancellor, the Dean of the Faculty concerned, Dean Research and Development, Chairperson of the University Teaching Department/Director of School and one of the Supervisor/Co-supervisor. It shall be the function of the Committee to consider the reports and to recommend to the Academic Council whether:
- i) The degree be awarded;
OR
 - ii) The thesis be revised and resubmitted for re-examination
OR
 - iii) The thesis be rejected

Further, provisional degree shall be issued from the date of meeting of Research Degree Committee to such students in whose cases the Research Degree Committee has recommended for the award of Ph.D. Degree.

21. After finalization of the award of Ph.D. Degree, one copy (both hard and soft) will be sent to the University Library and the other to the Department. The third copy may be returned to the candidate. Further, the University shall submit a soft copy of the Ph.D. thesis to the UGC within a period of thirty days, for hosting the same in INFLIBNET, accessible to all Institutions/Universities.
22. Prior to the actual award of the Degree, the University shall issue a certificate certifying that the degree has been awarded in accordance with the provisions of UGC (Minimum standards and Procedure for award of Ph.D. Degree) Regulations, 2022. Further, the date of award of Ph.D. degree i.e. date of meeting of Research Degree Committee should clearly be mentioned on the Ph.D. degree, irrespective of the date of convocation.

23. Publication of Thesis

No thesis shall be published without the prior permission of the University. The research scholar may apply to the Chairperson of the Department for permission to publish his/her thesis. The Chairperson/ Director will place the request before the Departmental Research Committee which shall satisfy itself that the thesis is in publishable form. It will be guided by the reports of the examiners. A certificate will be obtained from the supervisor to the effect that the necessary improvements suggested by him/her and the examiners have been duly carried out. All published thesis will be put on University website and will include catalogue and abstract of the thesis.

24. Withdrawal of Ph.D. Degree due to Plagiarism

The Academic Council, on the recommendation of the Vice-Chancellor, shall have the right to withdraw the degree if plagiarism or duplication or any other form of malpractice is detected later at any stage, and to initiate such further action as it deems fit. Provided that the Vice-Chancellor shall get the complaint in the matter investigated confidentially and shall give the accused an opportunity to explain before he/she makes his/her recommendation on the matter to the Academic Council. There shall be no limitation of time for this action of the Academic Council.

25. Fee Structure: Fees to be paid by Ph.D. candidate during the Ph.D. programme will be as laid down by the University from time to time.

26. In case of any clarification/ambiguity/dispute, the power to interpret the rules vests with the Vice-Chancellor, the decision of the Vice-Chancellor will be final and binding.

27. All disputes are subject to the jurisdiction at Hisar.

13.7 Examination Fee (to be paid at the time of submission of thesis): **Rs.15000/-**

13.8 The Scheduled Caste students of Haryana whose family income from all sources is up to Rs.2.50 Lacs per annum as prescribed by the State Govt. for Post Matric Scholarship and who produce, at the time of admission, the "Caste" and "income" certificates etc. issued by the competent authority and updated Parivar Pehchan Patra (PPP), are not required to pay any kind of fees and they are not required to pay security/caution money. The eligible SC students will apply the Post Matric Scholarship forms on the concerned Portal. Instructions regarding Bonafide Residents of Haryana issued vide letter No. 62/17/95-6 GSI Dated 3rd October, 1996, No. 62/32/2000-6GSI dated 23rd May, 2003 and No. 62/27/2003-6GSI dated 29th July, 2003 by the Chief Secretary to Government Haryana.

Subject: Bonafide residents of Haryana - Guidelines regarding.

I am directed to invite your attention to Haryana Govt. letters noted in the margin on the subject noted above vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for the purpose of admission to educational institution (including technical/medical institution). The matter has been reconsidered in the light of judgment delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain vs. Union of India and others reported as AIR 1984-SC-1421, wherein it has been held that instead of the word 'Domicile' the word 'Resident' be used in the instructions issued by the State Government and it has been decided to revise the Government instructions. Henceforth, the following categories of persons would be eligible for the grant of Resident Certificate: -

- i) Candidates, who have passed their qualifying examination for selection in an institution from a school/college in Haryana.
- ii) Children / Wards (if parents are not living) / Dependents: -
 - (a) of the employees of Haryana State posted in or outside Haryana State or working on deputation;
 - (b) of the employees of the statutory bodies/corporations established by or under an act of the State of Haryana who are posted in Chandigarh or in Haryana or outside Haryana.
 - (c) of the employees of the Government of India posted in Chandigarh or in Haryana in connection with the affairs of the Haryana Government;
- iii) Children/wards (if parents not living)/dependents of persons who after retirement have permanently settled in Haryana and draw their pensions from the treasuries situated in the State of Haryana.
- iv) Children/wards (if parents are not living)/dependents of pensioners of Haryana Government irrespective of the fact that the original home of the retiree is in a state other than Haryana or he has settled after retirement in or outside Haryana;
- v) Children/Wards (if parents are not living)/dependents of persons, who have permanent home in Haryana and include persons who have been residing in Haryana for a period of not less than 15 years or who have permanent home in Haryana but on account of their occupation they are living outside Haryana;
- vi) The wives of such persons who are bonafide residents of Haryana irrespective of the fact that they had belonged to any other State before marriage;
- vii) Persons who were born in Haryana and produce a certificate to that effect; provided that the parents/guardians (if parents are not living) of persons belonging to any one of the above mentioned categories are:
 - a) Citizen of India;
 - b) Produce an affidavit to the effect that they or their children/wards (if parents are not living)/dependents have not obtained the benefit of Resident in any other State.
- viii) Children & Wards of the accredited journalists residing at Chandigarh and recognized by Govt. of Haryana.
2. All candidates claiming to be bonafide residents of Haryana should produce a Haryana Resident Certificate signed by the District Magistrate/General Assistant to Deputy Commissioner or Sub-Divisional Officer (Civil) of the District/Sub-Divisions to which the candidates belong. Resident Certificates in respect of elsewhere or in respect of the Children/Wards/Dependents of Haryana Govt. employees who are posted at Chandigarh, Delhi or elsewhere or in respect of Children /Wards/ Dependents of pensioners of Haryana Govt. or in respect of the Children/Wards/Dependents of the

employees of the Government of India posted at Chandigarh or in Haryana in connection with the affairs of Haryana Government, or in respect of Children/Wards/Dependents of the employees and retirees of the Statutory Bodies/Corporations of Haryana established by or under an Act of the State of Haryana or a Central Act and located at Chandigarh, Haryana or outside Haryana, should be by their respective Heads of Departments.

3. Candidates seeking admission in educational institutions (including medical and technical institutions) located in Haryana, may not be required to produce Resident Certificate, if they have passed the examinations from a school/college situated in Haryana. For this purpose, a certificate of the Principal/Headmaster from concerned institution, where the children/wards studied last should be considered sufficient. The Principal/Headmaster of the institution shall be competent to issue such certificate, which should be sufficient.
4. If a candidate is admitted on the basis of claim that he belongs to the State of Haryana but at any subsequent time is discovered that his claim was false, the student shall be removed from the institution, all fees and other dues paid up to the date of such removal shall be confiscated. The Principal/Headmaster may take such other action against the student and his/her parents/guardians as he may deem proper in the circumstances of any particular case.
