- 1) The Steering Committee noted the short listing and selection criteria followed by screening committee ('X' and 'Y' at NP-3) approved by Vice- Chancellor for short listing the innovative proposals received in response to the Advertisement by PDUIC dated 25.07.19 in Daily newspaper. The Steering Committee recommended and approved the above criteria for short listing and selection of innovative proposals. The details of which are given below (F/A) :-
 - i) Innovative Proposal should be in the thematic areas of Agricultural Sciences, Business Management, Engineering, AI, IOT & Robotics, Life Sciences, Pharmaceutical Sciences, Physical Sciences, Medical Sciences & Yoga Sciences as given in the advertisement.
 - ii) Output of the Innovative Proposal, skill development & training of stakeholders should be towards development of Product/device/software.
 - iii) It should not be a research proposal.
 - iv) Level of Innovation, learning, skill development and training.
 - v) Prospects of Commercialization/start-up.
 - vi) Societal Relevance of Innovative idea.
 - vii) Timeline and budgetary requirement of the submitted proposals within the available limits.
 - viii) Where private parties/companies are involved proper MoU with IPR sharing agreement to be executed.
 - ix) Start-up, if any must be registered as a Company.
 - x) For innovative proposals, Association of Mentor (Regular Faculty of GJUS&T) is mandatory.
 - xi) Budgetary requirement in the proposals for major equipment cannot be met except seed money for Start-ups and ICT Infrastructure.
 - xii) Applicants should have demonstrated experience of conducting the innovative work/training.
