NOTE:-

1. No individual Seat allotment letter will be sent to the candidates by the University.
2. The candidates, at the time of reporting to the allotted College, shall submit documents as mentioned in CHAPTER-4: COUNSELING/REPORTING of Prospectus 2024-25 for admission to B.Ed. - 2 year and B.A. B.Ed. - 4 year (Regular) programmes of Affiliated Colleges, in original as well as two sets of self-attested photocopies, to the Admission Committee of the College concerned for verification. They are also required to deposit fee as mentioned in the Prospectus(2024-25).
3. At the time of reporting by the Candidate in the College concerned, if documents are found correct on verification and the fee is paid (as mentioned in the Prospectus) by the candidate, then a Provisional Admission Letter will be issued to the candidate by the concerned college. The candidate shall check all the entries in this **Provisional Admission Letter** and should sign it and preserve it for further reference.
4. The allotment of seat is liable to be cancelled, if the personal data viz. Category, Sub-category, residential status (Bonafide Residents of Haryana or All India Category), percentage of marks in qualifying examination, gender etc. submitted by the candidates at the time of online registration is found to be wrong at time of verification of the original certificates by the Admission Committee of the allotted college. But in case, if the candidate is found to be eligible after the correction in personal data (i.e. reporting of discrepancy, if any, by the concerned college) the candidate may be considered for subsequent counselling, if any, against the vacant seats only.

5. If a candidate is admitted on the basis of the information submitted by her/him in the 'Online Application Form', which is found to be incorrect or false at any stage, then her/his admission shall be cancelled and all fees and other dues paid by her/him shall be forfeited. The University/College may take further action, as deemed fit, against the candidate in accordance with law.
6. If a candidate is selected as per her/his first choice in any counseling and if she/he does not deposit the fee, then she/he will be allowed to participate in the college level physical counseling only on the availability of vacant seat(s).
7. Seats in each category have been allotted in online counseling as per latest reservation policy of the State Government given at "CHAPTER-5: Distribution and Reservation of Seats" of Prospectus for admission to B.Ed. - 2 year and B.A. B.Ed. - 4 year (Regular) programmes of Affiliated Colleges for session 2024-25.
