2. Prequalification criteria: scan copy of following documents are required online:

Eligibility Criteria shall be as follows:

- i. Scan copy of enlistment letter for Contractor/Society /Shop with GSTIN/authorized Dealer/Distributor.
- ii. Scan copy of GST registration certificate.
- iii. Scan copy of latest Income Tax return will also be submitted.
- iv. Scan copy of PAN will also be submitted.
- v. In case of dealers/contractors/societies quoting for the tender, authorization certificate to be attached from the manufacturing company confirming that the dealer is authorized to bid for this project and the company will supply the tender items to the bidder within the specified time frame and will also support the bidder in giving after sale service including maintenance and availability of spare parts if needed for the purpose.
- vi. **If any agency/firm/contractor do not quote all items of DNIT, the tender of the same will be treated as cancelled**
- vii. **The agency has installed at least 1 RO Plant not less than 500 LPH capacity OR 2 RO Plant of 125 LPH capacity in last five years.**

3. Conditional tenders will not be entertained & are liable to be rejected.
