A meeting of the Committee constituted to promote quality research, International Research Collaborations was held on 16.06.2016 at 3:00 PM under the Chairmanship of Hon'ble Vice-Chancellor. The following members were present:

The following decisions were taken:

- 1 **Purchase of Equipment for Central Instrumentation Lab:** The Research promotion Board approved the purchase of following equipments for CIL out of RUSA Grant (Equipments) allocated to CIL as under:-
 - a) Atomic Absorption Spectrometer (AAS) with or without buy back policy
 - b) HPLC with or without buy back policy
 - c) DSC with or without buy back policy
 - d) FE- SEM (Scanning Electron Microscope)
 - e) CHNSO Analyzer
 - f) Rheometer
 - g) Raman Spectrometer
 - h) LCMS/HRMS
 - i) Liquid Nitrogen Plant
 - j) Water Purification system
 - k) XRD Single Crystal
 - l) Basic Equipments including Refrigerator (s), Deep freezer(s), Centrifuge, fire-fighting equipment(s), BOD, Analytical Balance etc.
- 2 All RPB members expressed concern regarding the pathetic condition of the Animal House in wake of recent news items. It was decided to make animal house a central facility and a whole time Director /Coordinator/In-charge be appointed with financial and administrative powers. It was also decided to make Animal House well equipped from RUSA funds.
- 3 It was resolved that university should apply for Institutional membership of different reputed Scientific Society/Association. The Faculty members and JRFs will also encouraged / allowed to become members of such societies / Associations from their contingent grant of project/fellowship.

- 4 It was resolved that Ph D students admitted against the Supernumerary seats in the past should be treated as over and above and should not be counted for the maximum allotted limit. In future no supernumerary seat in Ph.D will be allotted.
- 5 It was also resolved that Departments can allow students of different Govt. Institutes/ Universities for summer training /project work.
- 6 Admission to Ph.D will be done in the month of August / September.


