TERMS & CONDITIONS FOR AUCTION FOR FUEL WOOD IN THE PREMISES OF GURU JAMBHESHWAR UNIVERSITY OF SCIENCE & TECHNOLOGY, HISAR

- 1. The sale of the wood will be in two categories.
 - Fuel wood
 - (ii Log wood
- 2. The work will be got done through sealed quotation.
- 3. The bidder has to quote the rate of fuel wood and log wood separately.
- 4. The wood will be sale to the highest bidder.
- 5. The bidder will be required to deposit Rs. 10,000/- as security for participating with the quotation in the bid. The amount of security will be refunded to the unsuccessful bidders.
- 6. The security of successful bidder will be adjusted towards the bid amount.
- 7. The allottee shall be responsible for good conduct of the persons employed by him in removing the fuel wood.
- 8. All the area shall be cleared and cleaned by the allottee to the entire satisfaction of Engineer-in-Charge.
- 9. Time limit for this job will be 30 days.
- 10. If the allottee fails to complete the work, within the stipulated period his security and other deposited amount will be forfeited by the University.
- 11. Any dispute arising out of this, not covered under the above said terms and condition will be referred to the arbitration of Vice-Chancellor whose decision shall be final for which no suit will be filed in the civil court by any bidder.
- 12. To remove the fuel wood/log wood within a period of 30 days in consultation with the Consultant (Landscape) from the date of issuance of this letter, failing which the amount as security money already deposited by your agency will be forfeited by the
- 13. You are directed to deposit Rs. 25,000/- immediately before lifting the wood. You will be allowed to lift wood equivalent to Rs. 25,000/- or less at a time & further after depositing installment of Rs. 25,000/- again. The security money of Rs. 10,000/- will be adjusted in last installment.
- 14. Weighing of auctioned wood will be done by University officials and original receipt of weight will be handed over to J.E (Hort.) before 2nd round of lifting of wood.
- 15. The security amount deposited by you will be adjusted towards the total bid amount.
- 16. Your agency will be responsible for good conduct of the persons to be deployed by
- 17. All the area shall be cleaned and cleared by your agency to the entire satisfaction of the Executive Engineer (PH/Hort.). All type of wood will have to be accepted/ lifted except pipal wood.
