On consequence of extension of schedule of admission in UG/PG courses conveyed by Dy. Director General Higher Education, Haryana vide memo. No. Memo. No. 010019/6/2020-Coordination-DHE-Part (1) dated 21.10.2024, the schedule for online submission of Registration Return on University web portal of the students whose admission are made from 21.10.2024 to 23.10.2024 in UG/PG courses alongwith hardcopy for the session 2024-25 is further extended as under:
