**Sub: Institute Level Counseling for Admission to B. Pharmacy (Lateral Entry) Course 2024-25 against vacant /leftover seats.**

For admissions to B. Pharmacy (Lateral Entry) course for the session 2024-25 for the vacant/left over seats after two counseling by HSTES the following schedule was proposed by the admission committee in its meeting held on 30.09.2024 as per the guidelines sent by HSTES for Institute Level Counseling for B. Pharmacy (Lateral Entry) course for the session 2024-25 (copy enclosed as 'A').

If the candidate is satisfied with the allotted seat, then deposit the admission/tuition fee as per the key dates through credit card/debit card/UPI or net banking by using online payment gateway.

2. Admission shall be made at Institute level counseling after merging the sub categories (including female) of a particular reserved category into the main reserved category firstly on the basis of HSTES rank and thereafter on the basis of Inter-se-merit of percentage of aggregate marks of qualifying examination in B. Pharmacy (Lateral Entry) course. In the event of seats remaining vacant/ unfilled, if any, same shall be filled up before final cut off date of admissions (i.e. 30.11.2024 as per HSTES) without any reservation. However, the last date for full fee refund will be 25/11/2024 as per HSTES guidelines.

3. Eligibility and basis of admission will be similar as stated in Chapter '3' of the prospectus by HSTES (enclosed as 'B').

4. Guidelines of applying online for B. Pharmacy (Lateral Entry) admission 2024-25 (Enclosed as 'C').

5. The candidates, who belong to the State of Haryana, shall provide their Parivar Pehchan Patra (PPP) ID and Aadhaar No. (If applicant does not remember PPP ID) during sign up/registration. All related data of the applicant like name, gender, DOB, father name, mother name, income, category & sub category will be fetched from his/her PPP ID data base during registration on HSTES portal and these details fetched from PPP database will be non-editable. So that all the

candidates from Haryana State will have to get his/her details updated and verified on F.P.P portal first.

6. The status of the vacant seat category wise after 2<sup>nd</sup> online off-campus counseling by HSTES is as under:
