Sub: To extend the Schedule of submission of Migration Certificate for the students admitted in UTD's/HSB/Affiliated Colleges (except Education Colleges) for the session 2023-24.

Sir/Madam,

It is to inform you that the Vice-Chancellor considering the request of Chairpersons, UTDs and Principals, affiliated colleges is pleased to extend schedule for submission of Migration Certificate of the students admitted in UTD's/HSB/ Affiliated Colleges (except Education Colleges) on the basis of lower examination passed from other Universities/Boards (other than HBSE) for the session 2023-24 as under:

Schedule of submission of Migration Certificate after expiry of the date with fine of Rs.500/-

Upto 29th February, 2024 with a late fee of Rs.1000/-
Upto 30th April, 2024 with a late fee of Rs.2000/-
Upto 30th June, 2024 with a late fee of Rs.3000/-
Upto 31st July, 2024 with a late fee of Rs.4000/-
Upto 31st August, 2024 with a late fee of Rs.5000/-

The candidature for concerned examination of a student shall be suspended automatically if a student fails to submit the Migration Certificate upto 31st August, 2024.

Further, the student has to furnish an **affidavit** duly attested by the **Notary Public** to effect that he/she did not take/appear in regular examination of any other course from any University/Board during the admission in his/her course of study in this University simultaneously.

It is explicitly mentioned that no request of relaxation/waive off fine/late fee on account of late submission of Migration Certificate shall be entertained under any circumstances.

The Chairpersons/Directors/Principals of UTDs/HSB/affiliated Colleges concerned shall issue the orders of suspension of candidature of the examination concerned of the students under intimation to the Controller of Examinations after 31st August, 2024 who fail to submit the Migration Certificates within the stipulated schedule.

You are therefore, requested to take further necessary action to bring the extended schedule to the notice of the students admitted in your Department/College for the session 2023-24.
