ITEM No.11. DEPTT. OF BIOTECHNOLOGY**

To consider and decide for purchase of Ultrasonic Probe Sonicator at an estimated cost of Rs.10,00,000/- (Including GST).

NOTE:

The Chairperson, Deptt. of Biotechnology has requested for purchase of Ultrasonic Probe Sonicator at an estimated cost of Rs.10,00,000/- (Including GST). The expenditure will be met out from the budget head 'BT-45 Non-recurring/Equipments 2025-26' of Deptt. of Biotechnology where sufficient budget is available. The Vice-Chancellor has ordered to place the matter before SPC-I.

The resolution of the SPC-I held on 29.07.2025

The Committee considered the case for purchase of Ultrasonic Probe Sonicator and resolved that a Sub-Committee consisting of Chairperson, Deptt. of Biotechnology, Director, CIL, Dr. Lakhwinder Singh, Deptt. of ESE and Branch Officer (A/Cs) may be constituted to prepare the tender document and submit the same for consideration in the next meeting of SPC-I.

Recommendation of the sub-committee:

The tender document prepared by the Sub-Committee is submitted for consideration of SPC-I.

The resolution of the SPC-I held on 30.09.2025

The Committee considered the recommendations of the Sub-Committee and resolved that an indicative advertisement may be published in the newspapers, i.e., Danik Jagran (Haryana Edition), Dainik Bhaskar (Haryana Edition) and The Tribune (Haryana Edition). Being the PI of the project, name of the Dr. Sapna Grewal, Deptt. of Biotechnology may be included as member in sub-committee.

Further, a copy of the tender notice may also be uploaded on the University Website. e-Tender account of University Works Department may be used for e-Tender. The technical and financial bid may be invited separately and the same Sub-Committee will evaluate the technical bid and place its recommendations in the next meeting of the SPC-I.

Recommendation of the sub-committee:

The tender bids were received from by M/s Labine Scientific Corporation, Hisar, M/s Rajesh Trading Co., M/s Lokesh Enterprises and M/s Satguru Enterprises, Hisar in which only one firm M/s Labine Scientific Corporation, Hisar is technically responsive. So that, the case may be sent to put up in next meeting of SPC-I.

The resolution of the SPC-I held on 11.11.2025

The committee considered the recommendation of the sub-committee and resolved that the same may be re-tendered as only one tender responsive has been received through e-tender. As per purchase guidelines-2020 there should be minimum three quotations/e-tenders.

Keeping in view the cost involved in this purchase, committee is of the view the purchase guidelines should be followed strictly & it will be appropriate to re-tender the same. E-tender may be published in the newspapers already approved for previous e-tender. The same sub-committee may evaluate the technical bids and submit its recommendation in the next meeting of SPC-I.
